REGENT SUKOHARJO,

- Considering:** a. that for the smooth implementation of the Election of the Regent and Deputy Regent of Sukoharjo which will be held during the *2019 Corona Virus Disease pandemic*, it is mandatory to carry out countermeasures, one of which is a *Rapid Test* examination of the Election Officers for the Regent and Deputy Regent of Sukoharjo;
- b. that based on the provisions of Article 2 paragraph (1) of the Minister of Home Affairs Regulation Number 20 of 2020 concerning the Acceleration of Handling *Corona Virus Disease 2019* in the Regional Government Environment, the Regional Government needs to take steps to anticipate and handle the impact of the transmission of Covid-19;
- c. that based on General Election Commission Regulation Number 15 of 2019 concerning Stages, Programs and Schedules for the Election of Governors and Deputy Governors, Regents and Deputy Regents, and/or Mayors and Deputy Mayors in 2020 as amended several times, most recently by the Election Commission Regulations General Number 5 of 2020 concerning Third Amendment to General Election Commission Regulation Number 15 of 2019 concerning Stages,

The Program and Schedule for the 2020 Election of Governors and Deputy Governors, Regent and Deputy Regent, and/or Mayor and Deputy Mayor states that all stages, programs and schedules for further simultaneous elections must be carried out in accordance with the health protocol for handling the 2019 Corona Disease Virus . efforts to prevent *Covid-19* among election officials for the Regent and Deputy Regent of Sukoharjo through *Rapid Test examinations*;

- d. that based on the considerations as intended in letters a, b, and c, it is necessary to stipulate a Regent's Regulation concerning Assistance with Costs for the *2019 Corona Virus Disease Rapid Diagnostic Test* for 2020 Sukoharjo Regent and Deputy Regent Election Officers;

DECIDE :

To stipulate: **REGENT'S REGULATION CONCERNING ASSISTANCE WITH THE 2019 RAPID DIAGNOSTIC TEST CORONA VIRUS DISEASE EXAMINATION COSTS FOR ELECTION OFFICERS OF THE REGENT AND DEPUTY REGENT OF SUKOHARJO YEAR 2020.**

GENERAL REQUIREMENTS

article 1

In this Regent's Regulation what is meant by:

1. The region is Sukoharjo Regency.
2. Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.
3. *Corona Virus Disease 2019*, hereinafter referred to as *Covid-19*, is an infectious disease caused by *Severe Acute Respiratory Syndrome-Corona Virus-2*.
4. The Task Force for the Acceleration of Handling *Covid-19*, hereinafter referred to as the *Covid-19* Task Force, is a coordinating institution tasked with coordinating efforts to prevent and handle *Covid-19* in the Region.
5. The *Covid-19* Handling Task Force is tasked with implementing and controlling the implementation of strategic policies related to handling *Covid-19*.
6. The *Covid-19* pandemic is an event where the *Covid-19* disease spreads which occurs globally throughout the world.

7. **Adaptation to new habits, hereinafter abbreviated as AKB, is the new normal where everyone adapts and changes behavior to continue carrying out normal activities by paying attention to health protocols in the midst of the 2019 Corona Virus Disease *pandemic* .**
8. ***Rapid Diagnostic Test Covid-19* , hereinafter abbreviated as *RDT Covid-19* , is an initial screening method to detect antibodies, namely IgM and IgG, which are produced by the body to fight the Corona virus.**
9. **Community Health Center, hereinafter referred to as Puskesmas, is a health service facility that carries out public health efforts and first-level individual health efforts, by prioritizing promotive and preventive efforts, to achieve the highest level of public health in its working area.**
10. **Health Laboratory Regional Technical Implementation Unit, hereinafter referred to as UPTD Labkes, is a health facility that carries out measurements, determination and testing of materials originating from humans or materials that do not originate from humans to determine the type of disease, causes of disease, health conditions and contributing factors. can affect individual health.**
11. **The General Election Supervisory Body is an election organizing institution tasked with supervising the implementation of elections throughout the territory of the Unitary State of the Republic of Indonesia.**
12. **The General Election Commission, hereinafter abbreviated as KPU, is the state institution that organizes general elections in Indonesia.**
13. **Resort Police, hereinafter referred to as Polres, is the command structure of the Indonesian National Police in Regency/City areas.**

CHAPTER II

SCOPE

Section 2

The scope of this Regent's Regulation includes:

- a. Type of Health Service;
- b. Election Officer for Regent and Deputy Regent; c. Health Service Provider; d. Health Services Financing;
- e. Participants' Rights and Obligations; And
- f. Rights and Obligations of health service providers.

TYPES OF HEALTH SERVICES

Article 3

Types of health services in the form of *RDT COVID-19 examination*;

CHAPTER IV

OFFICER FOR THE ELECTION OF REGENT AND DEPUTY REGENT

Article 4

- (1) Regent and Deputy Regent Election Officers are provided with **COVID-19 RDT examination assistance as intended in Article 3**
- (2) **The Regent and Deputy Regent Election Officers consist of:**
 - a. **KPU ranks;**
 - b. **Bawaslu staff and Bawaslu committee;**
 - c. **Sukoharjo Police members appointed by the Head of Police.**
- (3) **The KPU ranks as referred to in paragraph (2) letter a include the Voting Organizer Group (KPPS) and Polling Place Security Officers (TPS).**
- (4) **The ranks of Bawaslu employees and Bawaslu committees as referred to in paragraph (2) letter b include Regency Bawaslu and Subdistrict General Election Supervisory Committees (Panwaslucam), Village/Kelurahan General Election Supervisory Committees (PPD/K) and Polling Place Supervisors (PTPS).**

CHAPTER V

HEALTH SERVICES PROVIDER

Article 5

- (1) **Health service providers provide health services to Regent and Deputy Regent Election Officers.**
- (2) **Provider of health services as intended in paragraph (1) namely Puskesmas and UPTD Labkes.**

CHAPTER VI

FINANCING HEALTH SERVICES

Article 6

- (1) **Funding for the COVID-19 RDT examination is a maximum of Rp. 150,000.00 (one hundred and fifty thousand rupiah).**
- (2) **Financing as referred to in paragraph (1) is charged to the State Revenue and Expenditure Budget and/or Regional Revenue and Expenditure Budget for Fiscal Year 2020.**

CHAPTER VII

PARTICIPANTS' RIGHTS AND OBLIGATIONS

Article 7

- (1) **Regent and Deputy Regent election officials as intended in Article 3 are entitled to receive RDT inspection services COVID-19;**

(2) The selection officer for the Regent and Deputy Regent as intended in paragraph (1) must: a. complete

the administrative requirements to be carried out
Covid-19 RDT examination ; And

b. comply with *the Covid-19 RDT* examination service procedures at the Puskesmas and UPTD Labkes.

CHAPTER VIII

RIGHTS AND OBLIGATIONS OF HEALTH SERVICE PROVIDERS

Article 8

- (1) Health service providers at Puskesmas and UPTD Labkes have the right to receive services and operational services in accordance with applicable regulations.
- (2) The service provider is obliged to provide *Covid-19 RDT* examination services and submit the results of *the Covid-19 RDT* examination in accordance with applicable regulations.

CHAPTER IX

CLOSING

Article 9

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.
