**EVALUATION OF PERFORMANCE ACCOUNTABILITY OF GOVERNMENT AGENCIES**

**BY THE GRACE OF GOD ALMIGHTY  
REGENT OF SUKOHARJO,**

- Considering :**
- a. That in order to realize good governance and a clean government structure through transparency in accountability and the improvement of government agency performance;
  - b. That the Evaluation of Government Agency Performance Accountability is a systematic series of various activities, tools, and procedures designed for the purpose of establishing and measuring, collecting data, classifying, summarizing, and reporting the performance of government agencies;
  - c. That Regent Regulation Number 39 of 2016 concerning the Guidelines for the Implementation of the Evaluation of the Implementation of the Government Agency Performance Accountability System in the Sukoharjo Regency Government is no longer in accordance with the developments in the existing laws and regulations, and therefore needs to be revoked and replaced;
  - d. That based on the considerations as referred to in letters a, b, and c, it is necessary to establish the Regent Regulation on the Evaluation of the Performance Accountability of Government Agencies;

**Remembering**

5. Regulation of the Minister of Home Affairs Number 7 of 2024 concerning the Amendment to the Regulation of the Minister of Home Affairs Number 19 of 2016 on Guidelines for the Management of Regional Property (Supplement to the State Gazette of the Republic of Indonesia of 2024 Number 350);

Regulation of the Sukoharjo Regent Number 48 of 2017 concerning the Procedures for Utilization of Former Bondo Desa Land (Regional Gazette of Sukoharjo Regency of 2017 Number 49) as amended several times, most recently by Regulation of the Sukoharjo Regent Number 77 of 2020 concerning the Third Amendment to Regulation of the Sukoharjo Regent Number 48 of 2017 concerning the Procedures for Utilization of Former Bondo Desa Land (Regional Gazette of Sukoharjo Regency of 2020 Number 77);

**DECIDES:**

**To Establish :** REGULATION OF THE SUKOHARJO REGENT CONCERNING THE FOURTH AMENDMENT TO REGULATION OF THE SUKOHARJO REGENT NUMBER 48 OF 2017 CONCERNING THE PROCEDURES FOR UTILIZATION OF FORMER BONDO DESA LAND.

**Article I**

Several provisions in Regulation of the Sukoharjo Regent Number 48 of 2017 concerning the Procedures for Utilization of Former Bondo Desa Land (Regional Gazette of Sukoharjo Regency of 2017 Number 49), which have been amended several times, most recently by the following regulations:

- a. Regulation of the Sukoharjo Regent Number 68 of 2017 concerning the Amendment to Regulation of the Sukoharjo Regent Number 48 of 2017 concerning the Procedures for Utilization of Former Bondo Desa Land (Regional Gazette of Sukoharjo Regency of 2017 Number 69);
- b. Regulation of the Sukoharjo Regent Number 64 of 2020 concerning the Second Amendment to Regulation of the Sukoharjo Regent Number 48 of 2017 concerning the Procedures for Utilization of Former Bondo Desa Land (Regional Gazette of Sukoharjo Regency of 2020 Number 64);
- c. Regulation of the Sukoharjo Regent Number 77 of 2020 concerning the Third Amendment to Regulation of the Sukoharjo Regent Number 48 of 2017 concerning the Procedures for Utilization of Former Bondo Desa Land (Regional Gazette of Sukoharjo Regency of 2020 Number 77);

are amended as follows:

1. The provisions of Article 9 are amended to read as follows:

**Article 9**

- (1) The auction committee shall announce to the public the implementation of the auction for Former Bondo Desa Land no later than six (6) working days before the auction is conducted.

- (2) The auction for the Former Bondo Desa Land shall be carried out by the committee at the local sub-district hall or another designated location.
- (3) The auction, as referred to in paragraph (2), shall be conducted openly to the public without any tendentiousness or priority, using a parcel-based auction system..
- (4) The bidding method for the auction of the Former Bondo Desa Land shall be done using an open system.
- (5) Bidders must be present and participate in the auction.
- (6) The base price for the land auction is the lowest value, calculated using a formula which is the product of:
  - a. rental rate; and
  - b. land area.
- (7) The auction winner is the participant who makes the highest bid and is appointed as the tenant.
- (8) The auction participants, as referred to in paragraph (5), may only win a maximum of two (2) parcels of the auctioned land.
- (9) The auction winner, as referred to in paragraph (7), must pay the Land and Building Tax (PBB).
- (10) The auction winner, as referred to in paragraph (7), shall be appointed by a decision from the sub-district head.

2. The provisions of Article 10 are amended to read as follows:

Article 10

- (1) The base price for the land auction, as referred to in Article 9 paragraph (6) letter a, is the product of:
  - a. rental rate; and
  - b. land area.
- (2) The rental rate for the land, as referred to in paragraph (1) letter a, shall be implemented in accordance with the provisions in the Regional Regulation concerning Regional Taxes and Regional Retributions.
- (3) The land area, as referred to in paragraph (1) letter b, shall be calculated based on the site plan/map or land certificate.
- (4) The land area, as referred to in paragraph (1) letter b, shall be calculated in square meters.
- (5) The base price for the land auction for economic value refers to Former Bondo Desa Land that has high economic value.
- (6) The base price for the land auction for non-economic value, with criteria for public interest services, social institutions within the sub-district, soil fertility, location, and recommendations from the local Agriculture Technical Implementation Unit, shall be determined with the following categories:
  - a. Category I: paddy fields, location, and level of fertility (technical irrigation system);
  - b. Category II: yard land, location, and level of fertility; and
  - c. Category III: marshland and location.

- (7) In the event that only a portion of the land is auctioned, the land area, as referred to in paragraph (1) letter b, shall be the area of the portion of the land being auctioned.
- (8) If, after being announced as referred to in Article 9 paragraph (1), there are no auction participants and/or no bids exceeding the minimum price for the land being auctioned, the auction shall be held again no later than six (6) days after the first auction is conducted.
- (9) If, after being re-auctioned as referred to in paragraph (8), there are still no prospective tenants or bidders exceeding the minimum price for the land being auctioned, the sub-district may manage the land itself or appoint another party to manage it.

## Article II

This Regulation of the Regent shall come into effect on the date of its promulgation.

In order for everyone to be aware of it, the promulgation of this Regulation of the Regent is ordered by placing it in the Regional Gazette of Sukoharjo Regency.
