REGENT SUKOHARJO,

Considering: a. that in the context of structuring and controlling business establishment permits for organizing karaoke activities, nightclubs, discos, bars/pubs or drinking houses, massage parlors/houses and spas in Sukoharjo Regency, Sukoharjo Regent Regulation Number 35 of 2016 concerning Moratorium on Permits for Establishing Businesses Organizing Entertainment Activities Nights, Massage Parlors, Karaoke, Bars or Drinking Houses and Spas in Sukoharjo Regency as amended by Sukoharjo Regent Regulation Number 48 of 2018 concerning Amendments to Sukoharjo Regent Regulation Number 35 of 2016 concerning Moratorium on Business Establishment Permits Organizing Night Entertainment Activities, Massage Parlors, Karaoke, Bar or Drinking House and Spa in Sukoharjo Regency which ends on December 31 2018 needs to be extended; b. that based on the considerations as referred to in letter a, Sukoharjo Regent Regulation Number 35 of 2016 concerning Moratorium on Business Establishment Permits Organizing Night

Entertainment Activities, Massage Parlors, Karaoke, Bars or Drinking Houses and Spas in Sukoharjo Regency as amended by Sukoharjo Regent Regulation Number 48 of 2018 concerning Amendments to Sukoharjo Regent Regulation Number 35 of 2016 concerning Moratorium on Business Establishment Permits Organizing Night Entertainment Activities, Massage Parlors, Karaoke, Bars or Drinking Houses and Spas in Sukoharjo Regency needs to be replaced;

c. that based on the considerations as intended in letters a and b, it is necessary to stipulate a Regent's Regulation concerning the Moratorium on Business Establishment Permits for Organizing Karaoke, Night Club, Discotheque, Bar/Pub or Drinking House, Massage Parlor/House and Spa Activities in Sukoharjo Regency;

DECIDE:

To stipulate: REGENT'S REGULATION CONCERNING THE MORATORIUM FOR ESTABLISHMENT PERMITS OF BUSINESSES ORGANIZING KARAOKE, NIGHT CLUB, DISCOTHIC, BAR/PUB OR DRINKING HOUSES, MASSAGE PARENTS/ HOUSES AND SPA ACTIVITIES IN SUKOHARJO DISTRICT.

GENERAL REQUIREMENTS

article 1

In this Regent's Regulation what is meant by:

1. The region is Sukoharjo Regency.
2. Regional Government is the Regional Head as the organizing element of Regional Government who leads the implementation of government affairs which fall under the authority of the autonomous region.
3. The Regent is the Regent of Sukoharjo.
4. A moratorium is a postponement or postponement of a business establishment permit for organizing karaoke activities, nightclubs, discos, bars/pubs or drinking houses, massage parlors/houses and spas.
5. Karaoke business is a business that provides places and facilities for singing with or without a song guide.
6. Night Club Business is a night entertainment business that provides a place and facilities for relaxing and/or dancing accompanied by live music and lights as well as providing dance guides.

7. Discotheque business is a night entertainment business that provides places and facilities to relax and/or play with the accompaniment of recorded songs and/or music and lights.
8. Bar/Pub or Drinking House Business is a business providing alcoholic and non-alcoholic drinks which is equipped with equipment and supplies for the manufacture, storage and/or serving process, in 1 (one) fixed place that does not move.
9. Massage Parlor/House is a business that provides massage places and facilities with trained masseuses, including traditional massage and/or reflexology with the aim of relaxation.
10. Spa business is a treatment business that provides services using a combination of water therapy, aroma therapy, massage, spices, healthy food/drink services, and physical activity with the aim of balancing the body and soul while still paying attention to the traditions and culture of the Indonesian people.
11. Building Construction Permit, hereinafter abbreviated to IMB, is a permit granted by the regional government to the applicant for new construction, rehabilitation/renovation, and/or restoration in order to preserve the building in accordance with applicable administrative and technical requirements.
12. Tourism Business Registration Certificate, hereinafter abbreviated as TDUP, is an official document that proves that the tourism business carried out by the entrepreneur has been included in the Tourism Business Register.

CHAPTER II

MORATORIUM ON LICENSE FOR ESTABLISHMENT OF PROPERTY BUSINESSES KARAOKE ACTIVITIES, NIGHT CLUB, DISCOTE, BAR/PUB OR DRINKING HOUSES, MASSAGE PARENTS/HOUSES AND SPA

Section 2

- (1) The Regent shall implement a Moratorium on Business Establishment Permits for Organizing Karaoke Activities, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and Spas in the Region.
- (2) The moratorium on permits for establishing businesses organizing Karaoke, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and Spas in Sukoharjo Regency as referred to in paragraph (1) is valid until with December 31, 2030.

Article 3

With the moratorium as intended in Article 2, the issuance of Environmental Documents, IMB and TDUP for Karaoke, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and Spas, is suspended.

Article 4

Excluded from the provisions as intended in Article 3, namely for the publication of:

- a. extension of TDUP for Karaoke, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and Spas; b. TDUP Bar/Pub or Drinking House whose business is integrated with a karaoke business which is managed by management/entrepreneurs whose business location is in the Solo Baru area including Langenharjo Village, Madegondo Village, Kwarasan Village, Gedangan Village and Grogol Village, Grogol District, Sukoharjo Regency; And
- c. TDUP Night Clubs, Discotheques, Massage Parlors/Houses and Spas whose business locations are in the Solo Baru area include Langenharjo Village, Madegondo Village, Kwarasan Village, Gedangan Village and Grogol Village, Grogol District, Sukoharjo Regency.

CHAPTER III

CLOSING

Article 5

When this Regent's Regulation came into force, Sukoharjo Regent's Regulation Number 35 of 2016 concerning the Moratorium on Business Establishment Permits Organizing Night Entertainment Activities, Massage Parlors, Karaoke, Bars or Drinking Houses and Spas (Regional Gazette of Sukoharjo Regency of 2016 Number 35), as stated in amended by Sukoharjo Regent Regulation Number 48 of 2018 concerning Amendments to Sukoharjo Regent Regulation Number 35 of 2016 concerning Moratorium on Business Establishment Permits Organizing Night Entertainment Activities, Massage Parlors, Karaoke, Bars or Drinking Houses and Spas (Sukoharjo Regency Regional Gazette 2018 Number 48) , is revoked and declared invalid.

Article 6

This Regent's Regulation comes into force on the date of promulgation.
So that people are aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional News of Sukoharjo Regency.
