KARAOKE, NIGHT CLUB, DISCOTHIC, BAR/PUB OR DRINKING HOUSE,
MASSAGE PARENTS/HOUSES AND SOLUS PER AQUA

BY THE GRACE OF GOD ALMIGHTY

REGENT SUKOHARJO,

Considering: a. that in the context of structuring and controlling permits for the establishment of businesses organizing karaoke activities, nightclubs, discos, bars/pubs or drinking houses, massage parlors/ houses and solus per aqua in Sukoharjo Regency, Sukoharjo Regent Regulation Number 78 of 2018 concerning Moratorium on Permits for Establishing Organizing Businesses Karaoke activities, nightclubs, discos, bars/pubs or drinking houses, massage parlors/ houses and spas in Sukoharjo Regency need to be replaced; b. that based on the considerations

as intended

in letter a it is necessary to stipulate a Regent's Regulation regarding the Moratorium on Business Establishment Permits for Organizing Karaoke Activities, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and Solus Per Aqua;

DECIDE:

To stipulate: REGENT'S REGULATION CONCERNING MORATORIUM FOR ESTABLISHMENT PERMITS OF BUSINESSES ORGANIZING KARAOKE ACTIVITIES,

NIGHTCLUBS, DISCOTHICS, BAR/PUB OR DRINKING HOUSES, MASSAGE PARENTS/HOUSES AND SOLUS PER AQUA.

PIG GENERAL REQUIREMENTS

article 1

In this Regent's Regulation what is meant by:

- 1. The region is Sukoharjo Regency.
- Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.
- 3. The Regent is the Regent of Sukoharjo.
- 4. A moratorium is a postponement or postponement of a business establishment permit for organizing karaoke activities, nightclubs, discos, bars/pubs or drinking houses, massage parlors/houses and spas.
- 5. Karaoke business is a business that provides places and facilities for singing with or without a song guide.
- 6. Night Club Business is a night entertainment business that provides places and facilities for relaxing and/or on the floor accompanied by live music and lights and providing dance guides.
- 7. Discotheque Business is a night entertainment business that provides places and facilities for relaxing and/or on the floor accompanied by recorded songs and/or music and light.
- 8. Bar/Pub or Drinking House Business is a business providing alcoholic and non-alcoholic drinks which is equipped with equipment and supplies for the manufacture, and/or storage of the serving process niot in (one) fixed place that does
- 9. Massage Parlor/House is a business that provides massage places and facilities with trained masseuses, including traditional massage and/or reflexology with the aim of relaxation.

- 10. Solus Per Aqua, hereinafter abbreviated as SPA, is a series of treatments consisting of full body massage therapy, body scrub, whitening mask, music therapy, aromatherapy, milk bath/ aromatherapy bath and snacks in the form of cakes and drinking warm ginger or hot tea.
- 11. A SPA business is a treatment business that provides services using a combination of water therapy, aroma therapy, massage, spices, healthy food/drink services, and physical activity with the aim of balancing the body and soul while still paying attention to the traditions and culture of the Indonesian nation.
- 12. Building Construction Permit, hereinafter abbreviated IMB is a permit granted by the government area to the applicant for new construction, rehabilitation/ renovation, and/or restoration in order to preserve the building in accordance with applicable administrative and technical requirements.
- 13. Certificate of Functionality of a Building, hereinafter referred to as SLF, is a certificate issued by the Regional Government except for Special Function Buildings by the Central Government, to state the suitability of the function of the Building as a condition for it to be utilized.
- 14. Tourism Business Registration Certificate, hereinafter abbreviated as TDUP, is an official document that proves that the tourism business carried out by the entrepreneur has been included in the Tourism Business Register.

CHAPTER II

MORATORIUM ON LICENSE FOR ESTABLISHMENT OF PROPERTY BUSINESSES KARAOKE ACTIVITIES, NIGHT CLUB, DISCOTE, BAR/PUB OR DRINKING HOUSES, MASSAGE PARENTS/HOUSES AND SPA

Section 2

- (1) The Regent shall implement a Moratorium on Business Establishment Permits for Organizing Karaoke Activities, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and SPA in the Regions.
- (2) The moratorium on permits for establishing businesses organizing Karaoke, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and SPA in Sukoharjo Regency as referred to in paragraph (1) is valid until 31 December 2030.

Article 3

With the moratorium as referred to in Article 2 means the issuance of a Certificate of Spatial Planning, Assessment and Examination of Environmental Documents, Approval and Recommendations for TDUP, IMB, IMB, SLF and TDUP Technical Recommendations for Karaoke, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and SPA, are suspended.

Article 4

Excluded from the provisions as intended in Article 3, namely for the publication of: a. Extension of

- TDUP for Karaoke, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and SPA whose business location is in the Solo Baru area including Langenharjo Village, Madegondo Village, Kwarasan Village, Gedangan Village and Grogol Village, Grogol District, Sukoharjo Regency; b. New TDUP for Bars/Pubs or Drinking Houses
- whose business is integrated with a karaoke business whose management is carried out by one management/entrepreneur whose business location is in the Solo Baru area including Langenharjo Village, Madegondo Village, Kwarasan Village, Gedangan Village and Grogol Village, Grogol District, Sukoharjo Regency; c. New TDUP resulting from relocation that already has permits for Karaoke, Night Clubs, Discothegues, Bars/Pubs or

Drinking Houses, Massage Parlors/Houses and SPA located outside the Solo Baru area; And

d. New TDUP for Night Clubs, Discotheques, Massage Parlors/Houses and SPA whose business locations are in the Solo Baru area including Langenharjo Village, Madegondo Village, Kwarasan Village, Gedangan Village and Grogol Village, Grogol District, Sukoharjo Regency.

CHAPTER III

TRANSITIONAL PROVISIONS

Article 5

(1) Organizing Karaoke Activities, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and SPA whose permits are still valid and are located outside the Solo Baru area, including Langenharjo Village, Madegondo Village, Kwarasan Village, Gedangan Village and Grogol Village, Grogol District, can carry out their business until the permit is valid and/or for a maximum period of 5 (five) years.

(2) Within a period of no later than 5 (five) years after this Regent's Regulation is stipulated, those carrying out activities as intended in paragraph (1) if they wish to continue their business must move the location of their activities to the Solo Baru area, including Langenharjo Village, Madegondo Village, Kwarasan Village, Gedangan Village and Grogol Village, Grogol District.

CHAPTER IV

CLOSING

Article

6 When this Regent's Regulation comes into force, Sukoharjo Regent's Regulation Number 78 of 2018 concerning Moratorium on Business Establishment Permits Organizing Karaoke Activities, Night Clubs, Discotheques, Bars/Pubs or Drinking Houses, Massage Parlors/Houses and Spas in Sukoharjo Regency (Regional News Sukoharjo Regency Year 2018 Number 79) is revoked and declared invalid.

Article 7

This Regent's Regulation comes into force on the date of promulgation.
