**REGENT SUKOHARJO,**

**Considering: that to implement the provisions of Article 3 paragraph (2)  
Minister of Home Affairs Regulation Number 11 of 2019  
concerning Regional Apparatus that carries out Affairs  
The government in the field of National Unity and Politics  
needs to establish Regional Regulations regarding Formation  
National and Political Unity Agency;**

GENERAL REQUIREMENTS

article 1

In this Regional Regulation what is meant by:

1. The region is Sukoharjo Regency.
2. Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.
3. The Regent is the Regent of Sukoharjo.
4. Regional Apparatus is the supporting element of the Regent and the Regional People's Representative Council in administering Government affairs which fall under the authority of the Region.
5. The National Unity and Political Agency is a Regional Apparatus that carries out government affairs in the field of national unity and politics.

CHAPTER II

**FORMATION**

**Section 2**

**With this Regional Regulation, the National and Political Unity Agency was formed.**

**Article 3**

**The National and Political Unity Agency as referred to in Article 2 is a medium intensity criterion.**

**Article 4**

**Provisions regarding the position, organizational structure, duties and functions, and work procedures of the National Unity and Political Agency are regulated in the Regent's Regulations.**

CHAPTER III

**EMPLOYMENT**

**Article 5**

**State Civil Apparatus officials at the National Unity and Political Agency are appointed and dismissed by the Regent in accordance with the provisions of statutory regulations.**

CHAPTER IV

**TRANSITIONAL PROVISIONS**

**Article 6**

**When this Regional Regulation comes into force:**

- a. The National and Political Unity Office that has been established will continue to carry out its duties until the Regent's Regulation regarding the Position, Organizational Structure, Duties and Functions, and Working Procedures of the National and Political Unity Agency is issued; And**
- b. Officials at the Office of National Unity and Politics as referred to in letter a remain in their positions and carry out their duties until arrangements are made based on this Regional Regulation.**

**CLOSING****Article 7**

When this Regional Regulation comes into force, Sukoharjo Regency Regional Regulation Number 4 of 2008 concerning the Organization and Work Procedures of Regional Technical Institutions, Civil Service Police Units, and the Sukoharjo Regency Integrated Licensing Service Office (Sukoharjo Regency Regional Gazette of 2008 Number 4, Additional Gazette Sukoharjo Regency Region Number 158) as amended several times, most recently by Sukoharjo Regency Regional Regulation Number 6 of 2015 concerning the Fourth Amendment to Sukoharjo Regency Regional Regulation Number 4 of 2008 concerning Organization and Work Procedures of Regional Technical Institutions, Civil Service Police Units, and Service Offices Sukoharjo Regency Integrated Licensing (2015 Sukoharjo Regency Regional Gazette Number 6, Supplement to Sukoharjo Regency Regional Gazette Number 220) is revoked and declared invalid.

**Article 8**

This local regulation are applied at the date stated.

So that everyone is aware, this Regional Regulation is ordered to be promulgated by placing it in the Sukoharjo Regency Regional Gazette.

**I. GENERAL.**

**Based on Law Number 23 of 2014 concerning Regional Government and its amendments, general government affairs in the field of national unity and politics fall under the authority of the central government. Until now, government regulations regarding general governance have not been established, resulting in a legal vacuum in their implementation.**

**Based on the provisions of Article 122 paragraph (1) of Government Regulation Number 18 of 2016 concerning Regional Apparatus as amended by Government Regulation Number 72 of 2019 concerning Amendments to Government Regulation Number 18 of 2016 concerning Regional Apparatus, all Regional Apparatus that carry out government affairs in the unitary sector nation and politics will continue to carry out their duties until laws and regulations regarding the implementation of general government affairs are promulgated. That in order to provide legal certainty in the implementation of the duties and functions of regional apparatus which currently carries out affairs in the field of national and political unity, it is necessary to regulate the position, duties, functions, structure and work procedures of regional apparatus which carry out government affairs in the field of national and political unity.**

**Based on Minister of Home Affairs Regulation Number 11 of 2019 concerning Regional Apparatus carrying out Government Affairs in the Field of National Unity and Politics, adjustments and changes need to be made to regional apparatus carrying out government affairs in the field of national unity and politics.**

**To support the implementation of the duties and functions referred to, it is necessary to change the institution of the relevant regional apparatus, namely the Office of National Unity and Politics, and thus this needs to be stipulated in a Regional Regulation.**

**Based on these considerations, the Regency Regional Regulations Sukoharjo Number 4 of 2008 concerning Organization and Institutional Work Procedures Regional Technical, Civil Service Police Unit, and Licensing Services Office Integrated Sukoharjo Regency as amended several times, most recently by Sukoharjo Regency Regional Regulation Number 6 of 2015 concerning the Fourth Amendment to Regency Regional Regulations Sukoharjo Number 4 of 2008 concerning Organization and Institutional Work Procedures Regional Technical, Civil Service Police Unit, and Licensing Services Office Integrated Sukoharjo Regency needs to be adjusted and formed**
