SUKOHARJO REGENCY REGULATIONS NUMBER 74 OF 2021

ABOUT ESTABLISHMENT OF A REGIONAL FOOD SAFETY COMPETENT AUTHORITY

BY THE GRACE OF ALMIGHTY GOD REGENT SUKOHARJO.

Considering: a. that food is the most important basic human need and is part of human rights and to realize community welfare and quality human resources:

- b. that in order to monitor the safety and quality of Fresh Food of Plant Origin (PSAT) products in Sukoharjo Regency, it is necessary to establish an Authority Regional Food Safety Competent (OKKPD);
- c. that based on Article 68 of Law Number 18 of 2012 concerning Food,
 Regional Governments have the duty and responsibility to ensure food safety;
- d. that based on considerations as follows
 referred to in letter a, letter b and letter c, necessary
 establish a Regent's Regulation on the Establishment of a
 Regional Food Safety Competent Authority;
- Bearing in mind: 1. DECIDE:

To stipulate: REGULATION OF THE REGENCY ON FORMATION OF THE REGIONAL FOOD SAFETY AUTHORITY.

CHAPTER I

GENERAL REQUIREMENTS

article 1

In this Regent's Regulation what is meant by:

- 1. The region is Sukoharjo Regency.
- Regional Government is the Regent as the organizing element of the Regional Government which leads the implementation of government affairs which are the authority of the autonomous Region.
- 3. The Regent is the Regent of Sukoharjo.
- 4. The Food Service, hereinafter referred to as the Service, is the Sukoharjo Regency Food Service.
- 5. Food is everything that comes from biological sources, agricultural products, plantations, forestry, fisheries, animal husbandry, waters, and water, both processed or unprocessed intended as food or drink for human consumption, including food additives, food raw materials, and other materials used in the process preparation, processing and/or manufacturing of food or drinks.
- 6. Fresh Food of Plant Origin, hereinafter abbreviated as PSAT, is food of plant origin which can be consumed directly and/or which can be raw material for processed food which undergoes minimal processing including washing, peeling, cooling, freezing, cutting, drying, salting, mixing, grinding., dyeing (blancing), and/or other processes without the addition of food additives except coating with other permitted auxiliary materials to extend the shelf life.
- 7. Small Business Domestic Product PSAT, hereinafter abbreviated as PD-UK PSAT, is PSAT produced by micro and small business actors within the Territory of the Republic of Indonesia, whether originating from raw materials that are domestic or foreign products.

- 8. Small businesses are productive economic businesses that stand alone, which are carried out by individuals or business entities that are not subsidiaries or branches of companies that are owned, controlled, or are part, either directly or indirectly, of medium-sized businesses or large businesses that meet Small Business criteria as intended in government regulations.
- 9. Food safety is the conditions and efforts necessary to prevent food from being damaged biological, chemical and other possible contamination disturbing, detrimental and endangering health human beings and does not conflict with the religion, belief, and culture of the community so that it is peaceful to consume.
- 10. PSAT quality is a value determined on the basis of food safety and nutritional content criteria.
- 11. PSAT safety is the conditions and efforts needed to prevent PSAT from possible biological, chemical and other contamination that can disturb, harm and endanger human health and does not conflict with the religion, beliefs and culture of the community so that it is safe for consumption.
- 12. Certificate is a written guarantee given by institutions/laboratories that have been accredited/appointed to state that goods, services, processes, or personnel have met the required standards.
- 13. Regional Food Safety Competent Authority, hereinafter abbreviated to OKKPD, is a provincial/district/city level Government and Regional Government work unit which, in accordance with its duties and functions, is given the authority to supervise PSAT Safety and Quality.
- 14. The head of OKKPD is the officer appointed to implement OKKPD.
- 15. Supervision Coordinator is the personnel assigned to coordinate the implementation of data collection, *post-market supervision*, and fulfillment of PD-UK PSAT commitments.
- 16. Sub Technical Coordinator is the personnel assigned to carry out *post-market* supervision and supervision of the fulfillment of PD-UK PSAT registration commitments.
- 17. Administrative Sub-Coordinator is personnel assigned to carry out secretarial functions, including processing the issuance of signing certificates, certificates of compliance with good handling and conveying them to business actors.

- Supervisors are personnel appointed to carry out post-market supervision and supervision of the fulfillment of PD-UK PSAT registration commitments.
- 19. *Post-market* supervision is supervision/inspection of the safety and quality of PSAT circulating on the market.
- 20. Sampling Officer, hereinafter abbreviated as PPC, is an officer appointed to carry out sampling duties based on competency in the field of sampling.
- 21. Administrative Staff are personnel officially assigned by the OKKPD chairman to administer business units or institutions in PSAT registration.

BAB II

FORMATION

Section 2

With this Regent's Regulation the OKKPD was formed.

CHAPTER III

POSITION, DUTIES AND FUNCTIONS

Part One

Position

Article 3

- (1) OKKPD as intended in Article 2 is a non-structural institution.
- (2) OKKPD is located below and is responsible to the Regent.

The second part

Task

Article 4

OKKPD has the task of assisting Regional Governments in monitoring and quality of PSAT Food Safety, including:

- a. carry out PD-UK PSAT registration;
- b. carry out safety and quality supervision of PSAT in circulation;
- c. perform data collection for PSAT PD-UK performers; and
- d. implement supervision and compliance construction PD-UK PSAT registration commitment.

Part Three

Function

Article 5

To carry out the duties as in Article 4, OKKPD works:

- a. implementation of data collection on PSAT business actors;
- b. implementation of PD-UK PSAT registration services;
- c. implementation of the construction and supervision of PSAT business actors; and
- d. the implementation of PSAT supervision in circulation.

CHAPTER IV

ORGANIZATIONAL STRUCTURE

Article 6

- (1) The OKKPD Organizational Structure as intended in Article 2 consists of
 - to. Ketua:
 - b. Supervision Coordinator;
 - c. Sub Technical Coordinator;
 - d. Sub Administrative Coordinator;
 - e. Supervisor/PPC; and
 - f. Administrative staff.
- (2) The OKKPD Organizational Structure as referred to in paragraph (1) is listed in the Attachment which is an inseparable part of this Regent's Regulation.

Article 7

The Chair of the OKKPD as referred to in Article 6 paragraph (1) letter a is the Head of the Service.

Article 8

The head of the OKKPD as referred to in Article 6 paragraph (1) letter a has the duty to:

- a. assign personnel within the institutional structure
 OKKPD and PSAT supervisory officers;
- b. determine priorities for PSAT supervision and monitoring fulfillment of PDUK registration commitments;
- c. sign the PSAT PD-UK registration certificate or recommendation for the issuance of PSAT PD-UK;
- d. sign the business actor data collection certificate PSAT;
- e. sign a certificate of fulfillment of the commitment to implement good PSAT handling of at least level 3;

- f. report PSAT monitoring activities to OKKPD Province:
- g. responsible for allocating Human Resources (HR) and budget for implementing activities; And
- h. carry out monitoring and evaluation of activities PSAT supervision.

Article 9

Supervision Coordinator as referred to in Article 6 paragraph (1) letter b, has the duty:

- a. assign a team to carry out data collection, *post-market* supervision , and fulfill PD-UK PSAT commitments;
- b. formulate a development program for PSAT business actors PD-UK:
- c. coordinating the reporting of the results of implementing PSAT monitoring and development activities; And
- d. schedule and prepare the implementation of the evaluation periodic supervision.

Article 10

Sub Technical Coordinator as referred to in Article 6 paragraph (1) letter c, has duties:

- a. propose officers to the coordinator to carry out data collection, post-market supervision and supervision of the fulfillment of PD-UK PSAT registration commitments;
- b. carry out data collection activities, *post-market* supervision and fulfill PD-UK PSAT registration commitments;
- c. carry out guidance on compliance with PD-UK PSAT registration standards for business actors;
- d. identify and implement training to increase personnel competency capacity; And
- e. reporting data collection results, post-market supervision and monitoring the fulfillment of PD-UK PSAT registration commitments to the supervision coordinator.

Article 11

Sub Administrative Coordinator as intended in Article 6 paragraph (1) letter d, has the duty:

- a. carry out secretarial functions, including processing the issuance of signing certificates, certificates of compliance with good handling and conveying them to business actors;
- b. receive PD-UK PSAT registration applications;
- c. ensure completeness of administrative requirements and prepare PD-UK PSAT registration recommendations;

- d. prepare media/means of service information OKKPD; And
- e. managing PSAT monitoring documents PD-UK.

Article 12

Supervisors/PPC as referred to in Article 6 paragraph (1) letter e, have duties:

- a. carry out data collection, post-market supervision and assessment of fulfillment of PD-UK PSAT registration commitments;
- b. perform sampling when required;
- c. provide guidance on compliance with registration standards PSAT PD-UK;
- d. make a report on the results of construction and supervision;
- e. document each stage of activities carried out;
- f. identify and collect data on cases of food insecurity;
- g. carry out food safety outreach to relevant *stakeholders* and the community; And
- h. develop PSAT monitoring priorities and monitoring plans for fulfilling PD-UK registration commitments;

Article 13

Administrative Staff as referred to in Article 6 paragraph (1) letter f, have the task of assisting the implementation of OKKPD administration.

BAB V

WORKING PROCEDURE

Article 14

- (1) The Chairman of OKKPD carries out his duties based on applicable laws and regulations and policies established by the Regent.
- (2) In carrying out their duties, the Chair of the OKKPD, Supervision Coordinator, Technical Sub-Coordinator, Administrative Sub-Coordinator, Supervisor/PPC and Administrative Staff are required to apply the principles of fairness and impartiality.

BAB VI

FINANCING

Article 15

Funding for the implementation of OKKPD comes from:

- a. state budget;
- b. regional income and expenditure budget; And
- c. other legitimate sources of income.

Article 16

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.


