CHANGES TO THE REGULATIONS OF THE REGENCY OF SUKOHARJO  
NUMBER 44 OF 2021 CONCERNING DESCRIPTION OF CHANGES  
REGIONAL REVENUE AND EXPENDITURE BUDGET  
2021 BUDGET YEAR

BY THE GRACE OF GOD ALMIGHTY

REGENT SUKOHARJO,

- Considering: a. that based on the Decree of the Minister of Education, Culture, Research and Technology Number 224/P/2021 concerning Schools Recipient of Regular School Operational Assistance Funds for the 2021/2022 Academic Year, it is necessary to make budget adjustments;
- b. that based on the provisions of letter E, other special matters point 10 of the Minister of Home Affairs Regulation Number 64 of 2020 concerning Guidelines for Preparing Regional Revenue and Expenditure Budgets for Fiscal Year 2021, regulates Regional Governments budgeting income which originates from transfer funds to regions whose use has been determined by technical instructions in accordance with statutory regulations. In the event that the budget for transfer funds to the regions in question is not used in accordance with the technical instructions for the year in question, the Regional Government shall make adjustments to the use of the transfer funds in question by making changes to the Head of Regent's Regulations concerning the Explanation of the APBD for Fiscal Year 2021 and notify the leadership of the DPRD, to be subsequently budgeted in the Regional Regulations regarding changes to the APBD for Fiscal Year 2021 or accommodated in the LRA for Regional Governments that do not make changes to the APBD for Fiscal Year 2021;

- c. that based on the considerations as intended in letters a, b and c, it is necessary to determine  
Regent's Regulation concerning Amendments to Sukoharjo  
Regent's Regulation Number 44 of 2021 concerning Elaboration  
Changes to the Regional Revenue and Expenditure Budget for  
Fiscal Year 2021;

DECIDE :

To stipulate: REGENT'S REGULATION CONCERNING CHANGES TO REGULATIONS REGENCY OF SUKOHARJO NUMBER 44 OF 2021 CONCERNING EXPLANATION OF CHANGES IN INCOME BUDGET AND REGIONAL EXPENDITURE FOR BUDGET YEAR 2021.

#### Article I

Several provisions in Sukoharjo Regent Regulation Number 44 of 2021 concerning the Explanation of Budget Changes Regional Revenue and Expenditures for Fiscal Year 2021 (News Sukoharjo Regency Region Year 2021 Number 45) is amended as follows:
