AMENDMENT TO REGIONAL REGULATION NUMBER 12 OF 2016
CONCERNING THE FORMATION AND COMPOSITION OF REGIONAL APPARATUS

BY THE GRACE OF GOD ALMIGHTY

REGENT SUKOHARJO,

- Considering: a. that the formation and composition of Regional Apparatus is carried out in the context of administering Regional Government affairs to protect, serve, empower and improve the welfare of the community;
- b. that in order to follow up on the results of institutional evaluations which are based on the principles of appropriate function and appropriate size in accordance with conditions and needs in the Region, it is necessary to reorganize Regional Apparatus by merging certain Regional Apparatus in accordance with the family of government affairs under the authority of the Region;
- c. that in order to implement the provisions of Article 3 paragraph (1) of Government Regulation Number 18 of 2016 concerning Regional Apparatus as amended by Government Regulation Number 72 of 2019 concerning Amendments to Government Regulation Number 18 of 2016 concerning Regional Apparatus, then Regional Regulation Number 12 of 2016 concerning the Formation and Structure of Regional Apparatus
needs to be changed;
- d. that based on the considerations as intended in letters a, b, and c, it is necessary to stipulate a Regional Regulation concerning Amendments to Regional Regulation Number 12
2016 concerning the Formation and Structure of Regional Apparatus;

- Bearing in mind: 1. Article 18 paragraph (6) of the 1945 Constitution of the Republic of Indonesia;
2. Law Number 13 of 1950 concerning the Establishment of Regency Regions within the Province of Central Java as amended by Law Number 9 of 1965 concerning the Establishment of the Batang Level II Region by amending Law No. 13 of 1950 concerning the Establishment of Regency Regions within the Province of Central Java (State Gazette of 1965 Number 52, Supplement to State Gazette Number 2757);
 3. Law Number 23 of 2014 concerning Regional Government (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to State Gazette of the Republic of Indonesia Number 5587) as amended several times, most recently by Law Number 11 of 2020 concerning Job Creation (State Gazette Republic of Indonesia Year 2020 Number 245, Supplement to the State Gazette of the Republic of Indonesia Number 6573);
 4. Government Regulation Number 18 of 2016 concerning Regional Apparatus (State Gazette of the Republic of Indonesia of 2016 Number 114, Supplement to the State Gazette of the Republic of Indonesia Number 5887) As amended by Government Regulation Number 72 of 2019 concerning Amendments to Government Regulation Number 18 of 2016 concerning Apparatus Regional (State Gazette of the Republic of Indonesia 2019 Number 187, Supplement to the State Gazette of the Republic of Indonesia Number 6402);
 5. Sukoharjo Regency Regional Regulation Number 12 of 2016 concerning the Formation and Structure of Regional Apparatus (Sukoharjo Regency Regional Gazette of 2016 Number 12, Supplement to Sukoharjo Regency Regional Gazette Number 236);

DECIDE:

To stipulate: REGIONAL REGULATIONS CONCERNING AMENDMENTS TO REGIONAL REGULATION NUMBER 12 OF 2016 CONCERNING THE FORMATION AND COMPOSITION OF REGIONAL APPARATUS.

Article I

Several provisions in Regional Regulations Sukoharjo Regency Number 12 of 2016 concerning Formation and Structure of Regional Apparatus (Sukoharjo Regency Regional Gazette 2016 Number 12, Supplement to Regency Regional Gazette Sukoharjo Number 236), amended as follows:

1. Provisions number 12, number 15 are changed and number 13 is deleted, so that Article 1 reads as follows:

article 1

In this Regional Regulation what is meant by:

1. The region is Sukoharjo Regency.
2. Regional Government is the Regent as an element of regional government administrators who leads the implementation of government affairs which fall under the authority of the autonomous region.
3. The Regent is the Regent of Sukoharjo.
4. The Regional People's Representative Council, hereinafter abbreviated as DPRD, is the Regional People's Representative Council of Sukoharjo Regency.
5. Regional Apparatus is the supporting element of the Regent and DPRD in administering government which affairs is under the authority of the Region.
6. Regional Secretariat is the Regional Secretariat of Sukoharjo Regency.
7. The Secretariat of the Regional People's Representative Council, hereinafter referred to as the DPRD Secretariat, is the Secretariat of the Regional People's Representative Council of Sukoharjo Regency.
8. Regional Inspectorate is the Regional Inspectorate of Sukoharjo Regency.
9. Regional Service is the Sukoharjo Regency Regional Service.

10. Regional Agency is a Regional Agency Sukoharjo Regency.
 11. The Civil Service Police Unit is part of the Regional Apparatus in enforcing Regional Regulations and maintaining public order and public peace.
 12. Regional Technical Implementation Unit is an organization that carries out operational technical activities and/or certain supporting technical activities at a Regional Service or Agency.
 13. Deleted.
 14. Type A is the typology criteria for Regional Apparatus based on the results of mapping Regional government affairs for Regional Secretariats, DPRD Secretariats, Regional Inspectorates, Services and Agencies with a large workload category that has a variable value greater than 800 (eight hundred), and for Districts with variable value is greater than 600 (six hundred).
 15. Type B is the typology criteria for Regional Apparatus based on the results of mapping Regional government affairs for Regional Secretariats, DPRD Secretariats, Regional Inspectorates, Services and Agencies with a medium workload category that has a variable value of more than 600 (six hundred) to 800 (eight hundred), and for sub-districts with a small workload and having a variable value of less/equal to 600 (six hundred).
 16. Type C is a typology criterion for Regional Apparatus based on the results of mapping Regional government affairs for Regional Secretariats, DPRD Secretariats, Regional Inspectorates, Services and Agencies with a small workload category that has a variable value of less/equal to 600 (six hundred).
2. Provisions on letter c, letter d number 1, number 5, number 12, number 14, number 15, number 16, number 17, number 18, letter e changed, and letter e Article 2 added 2 (two) numbers, namely numbers 4 and number 5, so that Article 2 reads as follows:

Section 2

In this Regional Regulation a Device is formed Regions with the following arrangement:

- a. The Regional Secretariat is a Type B Regional Secretariat;

- b. The DPRD Secretariat is the Type B DPRD Secretariat;
- c. The Regional Inspectorate is a Type B Regional Inspectorate;
- d. Regional Services, consisting of:
 - 1. Type A Education and Culture Service carries out Government Affairs in the field of education and culture;
 - 2. Type A Health Service carries out Government Affairs in the health sector;
 - 3. The Public Works and Spatial Planning Service Type A organizes affairs government in the field of public works and spatial planning and the land sector;
 - 4. Type B Housing and Settlement Area Service carries out Government Affairs in the field of housing and residential areas;
 - 5. Type A Civil Service Police Unit carries out Government Affairs in the field of peace and public order as well as community protection, sub-affairs of peace and public order and sub-affairs of fire;
 - 6. Type A Social Service carries out government affairs in the social sector;
 - 7. Department of Population Control, Family Planning and Women's Empowerment and Child Protection Type A carries out Government Affairs in the field of population control and family planning and the field of empowerment and child protection;

- 8. Type B Food Service carries out Government Affairs in the food sector;
- 9. Type A Environmental Service carries out Government Affairs in the environmental sector;
- 10. Type A Population and Civil Registration Service carries out affairs Government in the field of population administration and civil registration;
- 11. Type B Community and Village Empowerment Service organizes affairs Government in the field of community and village empowerment;

12. The Type Transportation Service carries out Government Affairs in the field of transportation; B
13. Type B Communication and Information Service carrying out Government Affairs in the fields of communications and informatics, the field of coding, and the field of statistics;
14. Department of Investment and Services One Stop Integrated provides Government Affairs in the field of investment and one stop integrated services;
15. Type B Youth, Sports and Tourism Service carries out Government Affairs in the youth sector
and sports and tourism sectors;
16. Type C Library and Archives Service carrying out Government Affairs in the library and archives sector;
17. Type A Agriculture and Fisheries Service carries out Government Affairs in the agricultural and marine and fisheries sectors;
18. Service of Cooperatives, Small and Medium Enterprises and Type A Trade carries out Government Affairs in the field of cooperatives, small and medium enterprises, and the field of trade; And
19. Type A Industry and Manpower Service carries out Government Affairs in the industrial sector, labor sector and transmigration sector.

e. The Regional Agency consists of:

1. Type A Regional Development Planning, Research and Innovation Agency carries out planning support functions and research and development support functions;
2. Type B Regional Financial, Revenue and Asset Management Agency carries out financial support functions;
3. Type B Personnel and Human Resources Development Agency carries out personnel support functions as well as education and training;
4. The National and Political Unity Agency is currently carrying out government affairs in the field of national and political unity; And

5. Regional Disaster Management Agency
Classification B carries out government affairs in the field of peace and public order as well as community protection, sub-disaster affairs.

3. The provisions of Article 5 are amended so that Article 5 reads as follows:

Article 5

- (1) In Regional Services and Regional Bodies as intended in Article 2 letters d and e, Regional Technical Implementation Units can be formed.
- (2) The Regional Technical Implementation Unit as intended in paragraph (1), is formed to carry out operational technical activities and/or certain supporting technical activities of its parent Regional Apparatus.

4. The provisions of paragraph (1) of Article 6 are amended, so that Article 6 reads as follows:

Article 6

- (1) Apart from the Regional Technical Implementation Unit as intended in Article 5, there is a Regional Technical Implementation Unit in the field of education in the form of a Regional education unit.
- (2) Regional education units as referred to in paragraph (1) are in the form of formal and non-formal education units.

5. The provisions of paragraph (1) of Article 7 are amended, so that Article 7 reads as follows:

Article 7

- (1) Apart from the Regional Technical Implementation Unit as intended in Article 5, in Government affairs in the health sector there are Regional Hospitals as special organizational units and Community Health Centers as functional organizational units, which provide professional services.

- (2) Regional Hospitals as referred to in paragraph (1) are autonomous in carrying out hospital governance and clinical governance as well as implementing financial management patterns for Regional public service agencies.
- (3) The Regional Hospital as intended in paragraph (1) is led by the Regional Hospital Director.
- (4) The Regional Hospital Director as referred to in paragraph (3) in the management of regional finances and property as well as the personnel sector is responsible to the head of the service that carries out Government Affairs in the health sector.
- (5) Accountability as intended in paragraph (4) is carried out through the submission of reports on the implementation of regional financial and property management as well as regional hospital staffing.

6. The provisions of Article 11 and Article 12 are deleted.

Article II

1. When this Regional Regulation comes into force,
 - a. Sukoharjo Regency Regional Regulation Number 4 of 2011 concerning the Organization and Work Procedures of the Sukoharjo Regency Regional Disaster Management Agency (Sukoharjo Regency Regional Gazette of 2011 Number 4, Supplement to Sukoharjo Regency Regional Gazette Number 184);
 - b. Sukoharjo Regency Regional Regulation Number 8 of 2020 concerning the Establishment of the National and Political Unity Agency (Sukoharjo Regency Regional Gazette of 2020 Number 8, Supplement to Sukoharjo Regency Regional Gazette Number 293);

revoked and declared invalid.

2. This Regional Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regional Regulation is ordered to be promulgated by placing it in the Sukoharjo Regency Regional Gazette.

I. GENERAL

In order to carry out the duties and functions of regional apparatus more efficiently, effectively, have clear work procedures and be more flexible and in accordance with statutory regulations, adjustments are needed to regional apparatus including composition, organizational structure, work procedures, duties and functions as well as nomenclature. regional apparatus which is guided by statutory regulations relating to regional apparatus which is carried out through the stipulation of Regional Regulations concerning the Formation and Structure of Regional Apparatus.

That the evaluation of the Institutional Arrangement of Regional Apparatus in Sukoharjo Regency is carried out based on Government Regulation Number 18 of 2016 concerning Regional Apparatus as amended by Government Regulation Number 72 of 2019 concerning Amendments to Government Regulation Number 18 of 2016 concerning Regional Apparatus and Minister of Home Affairs Regulation Number 99 of 2018 concerning Development and Control of Regional Apparatus Arrangement. The evaluation material is guided by the results of the Institutional Evaluation of Regional Apparatus which was carried out in 2021. And with changes in regulations at the central level, adjustments are needed to regional apparatus including composition, organizational structure, work procedures, duties and functions as well as nomenclature of regional apparatus.

So it is necessary to change the composition and nomenclature of regional apparatus by establishing Regional Regulations concerning Amendments to Regional Regulation Number 12 of 2016 concerning Formation and Structure of Regional Apparatus.
