STUNTING PREVENTION IN SUKOHARJO DISTRICT

BY THE GRACE OF ALMIGHTY GOD

REGENT SUKOHARJO,

Considering: a. that *Stunting* is a chronic malnutrition problem caused by a lack of nutritional intake over a long period of time, which can result in impaired physical growth in children with a height lower or shorter than their age standard, affecting the development of brain tissue and intelligence so that it has an impact on the quality of human resources;

b. that the high prevalence of *stunting* can hinder efforts to improve public health and hinder the realization of healthy, intelligent and productive human resources;

c. that in accordance with the provisions of Article 8 of Central Java Governor's Regulation Number 34 of 2019 concerning the Acceleration of *Stunting* Prevention in Central Java Province, the Regional Government is implementing convergence actions for *Stunting* prevention in the Regency;

d. that based on the considerations as intended in letters a, b, and c, it is necessary establish a Regent's Regulation on *Stunting* Prevention in Sukoharjo Regency;

DECIDE :

To stipulate: **REGENT'S REGULATION CONCERNING *STUNTING* PREVENTION IN SUKOHARJO DISTRICT.**

CHAPTER I

GENERAL REQUIREMENTS

article 1

In this Regent's Regulation what is meant by:

1. The region is Sukoharjo Regency.
2. Regional Government is the Regent as the organizing element of the Regional Government which leads the implementation of government affairs which fall under the authority of the autonomous region.
3. The Regent is the Regent of Sukoharjo.
4. Health Service is the District Health Service Sukoharjo
5. *Stunting* is a condition of failure to thrive in children under five years (toddlers) due to chronic malnutrition, recurrent infections, and inadequate psychosocial stimulation, especially in the first 1000 (one thousand) days of life. (1000 HPK), namely from fetus to two year old child.
6. Specific Nutritional Interventions are interventions that target the direct causes of *Stunting* which include adequate food and nutritional intake, provision of food, care and parenting patterns, and treatment of infections/diseases.
7. Sensitive Nutrition Interventions are interventions that target indirect causes of *Stunting* which include increasing access to nutritious food, increasing awareness, commitment and nutritional care practices for mothers and children, increasing access and quality of nutrition and health services, as well as providing clean water and sanitation.
8. Nutrition Surveillance is regular and continuous observation carried out by nutrition workers regarding all aspects of nutritional problems, both their condition and distribution in a particular community for the purposes of prevention and control.
9. *Stunting* prevention convergence action is an instrument or intervention approach carried out in a coordinated, integrated and joint manner in efforts to reduce *stunting*.
10. The data management system is part of information resource management which includes all activities from identifying data needs, data collection to data utilization, to ensure accurate and up-to-date information.

11. A village is a legal community unit that owns territorial boundaries that have the authority to regulate and manage government affairs, the interests of local communities based on community initiatives, rights of origin, and/or traditional rights that are recognized and respected in the government system of the Unitary State of the Republic of Indonesia.
12. Village Funds are funds sourced from the State Revenue and Expenditure Budget intended for Villages which are transferred through the Regional Revenue and Expenditure Budget and used to fund the implementation of development, community development and community empowerment government,
13. The Village Government is the Village Head assisted by village officials as the organizing element of the Village Government.
14. Village Government is the administration of government affairs and the interests of local communities in the government system of the Unitary State of the Republic of Indonesia.
15. Prevalence is the entire population suffering from the disease (new and old cases) from the population at risk of suffering from the disease within a certain time period.
16. Other related elements are other stakeholders, namely individuals or institutions outside the Regional Apparatus Organization (OPD) who can be involved as needed to support or strengthen prevention activities
Stunting is like experts or practitioners in the field of nutrition or service providers in other fields.

BAB II

PURPOSE AND OBJECTIVES

Section 2

- (1) This Regent's Regulation is intended as a guideline for preventing *stunting* in the regions through convergence actions.
- (2) This Regent's Regulation aims to prevent *stunting* in children under two years of age (baduta) and dealing with *stunting* in children under five years of age (toddlers) in the regions through the implementation of 8 (eight) convergence actions to prevent *Stunting*.

CHAPTER III

SCOPE

Article 3

The scope of *Stunting* prevention in this Regent's Regulation includes:

- a. implementation of 8 (eight) preventive convergence actions
Stunting;
- b. organizing;
- c. coordination;

- d. performance assessment;
- e. cooperation;
- f. monitoring, evaluation and reporting; And
- g. financing.

CHAPTER IV

IMPLEMENTATION OF 8 (EIGHT) CONVERGENCE ACTIONS
STUNTING PREVENTION

Part One

General

Article 4

- (1) The regional government carries out 8 (eight) actions *Stunting prevention convergence* includes:
- a. analysis of the situation of the stunting reduction program ;
 - b. preparation of activity plans;
 - c. *Stunting discussion* ;
 - d. preparation of Village Regulations;
 - e. development of Human Development Cadres;
 - f. *Stunting data management system* ;
 - g. *Stunting measurement and publication* ; And
 - h. annual performance review.
- (2) Prevention of *Stunting* in the Regions as referred to in paragraph (1) is carried out with multi-sectoral involvement through cross-program synchronization at the Central Government, Provincial Government and Regional Government levels.
Local government.
- (3) In order to support the integrated implementation of *Stunting prevention*, 8 (eight) convergence actions will be implemented which will strengthen the effectiveness of interventions starting from planning, implementation, monitoring and evaluation.

The second part

Situation Analysis of the *Stunting* Reduction Program

Article 5

- (1) Analysis of the situation of the *Stunting reduction program* as intended in Article 4 paragraph (1) letter a is carried out as a diagnostic effort to support planning for *Stunting prevention*.
- (2) Analysis of the situation as intended in paragraph (1) through the approach:
- a. Specific nutritional interventions targeting:
 - 1. pregnant women, breastfeeding mothers and children aged 0-23 months in the First 1000 Days of Life (HPK); And

2. teenage girls and women of childbearing age as well as children aged 24-59 months.

b. sensitive nutrition interventions targeting families and communities.

Part Three

Preparation of Activity Plans

Article 6

- (1) The preparation of activity plans as intended in Article 4 paragraph (1) letter b is prepared based on recommendations from the results of the situation analysis.
- (2) Activity plans as intended in paragraph (1) includes:
 - a. related Regional Apparatus programs and activities in increasing coverage of Stunting prevention intervention services , and;
 - b. activities to increase the integration of interventions by the Regional Government in the current and/or first year next year.
- (3) Regional Government integrates Activity Plans as intended in paragraph (2) into the Plan Local Government Work.

Part Four

Stunting Consultation

Article 7

- (1) The *Stunting* Consultation as referred to in Article 4 paragraph (1) letter c is carried out by the Regional Government in the context of controlling and ensuring integration in the implementation of joint *Stunting* prevention interventions.
- (2) The *Stunting* Consultation is carried out jointly as intended in paragraph (1) by the Regional Apparatus in charge of services, non-government sectors/institutions and the community.
- (3) The main issues in *Stunting* consultation activities as follows referred to in paragraph (1) includes:
 - a. *Stunting* prevention programs and activities that will be carried out in the current year; And
 - b. Regional Government commitment to programs and activities to reduce *stunting* which will be included in the Regional Government Work Plan for the following year.

Part Five
Preparation of Village Regulations
Article 8

In implementing the convergence action to prevent *stunting* , the Village Government has prepared Village Regulations related to preventing *stunting* as intended in Article 4 paragraph (1) letter d.

Part Six
Development of Human Development Cadres
Article 9

- (1) Human Development Cadres as intended in article 4 paragraph (1) letter e are determined by Decree Village Head/Lurah based on the results of level deliberations Village/Subdistrict;**
- (2) Human Development Cadres as referred to in paragraph (1) functions to assist Villages/Subdistricts in implementing integrated *Stunting prevention interventions*;**
- (3) Human Development Cadres as referred to in paragraph (1) comes from:**
 - a. Early Childhood Education Teacher;**
 - b. Village/Subdistrict Community Empowerment Cadres (KPMD/K);**
 - c. Integrated Service Post Cadre; And**
 - d. Cadres/other community elements in the village/sub-district.**

Part Seven
***Stunting* Data Management System**
Article 10

- (1) The *Stunting* data management system as referred to in article 4 paragraph (1) letter f is carried out as an effort to manage data at the Village/Subdistrict level in stages up to the Regional level to support the implementation of convergence actions.**
- (2) The data management system as intended in paragraph (1) includes indicator data starting from *Stunting* data up to coverage of specific and sensitive nutritional interventions.**
- (3) The implementation of the data management system as referred to in paragraph (1) aims to help provide and facilitate data access for the management of integrated *stunting* prevention programs .**
- (4) Indicator data as intended in paragraph (2) is used to meet the needs for implementing the action convergence.**

Part Eight

Measurement and Publication of *Stunting* Data

Article 11

- (1) **The Regional Government measures and publishes *Stunting* Data as intended in Article 4 paragraph (1) letter g as an effort to obtain *Stunting* prevalence data the latest on the Village/Subdistrict and Subdistrict service scale.**
- (2) **Measurement and publication of *Stunting* as intended in paragraph (1) aims to:**
 - a. knowing the nutritional status of children according to age;
 - b. knowing the prevalence of *stunting* in villages/ sub-districts, sub-districts and regions; **And** level
 - c. strengthen the commitment of Village/Subdistrict Governments, Subdistrict and Regional Governments as well as the community in preventing *Stunting*.

Part Nine

Annual Performance Review

Article 12

- (1) **The annual performance review as intended in Article 4 paragraph (1) letter h is carried out by the Regional Government in the context of evaluating the performance of implementing programs and activities related to *Stunting* prevention during the last year.**
- (2) **The annual performance review as intended in paragraph (1) includes: a.**
 - implementation of 8 (eight) regional Convergence Actions;
 - b. realization of annual *stunting* reduction activity plans area;
 - c. implementation of program budgets and intervention activities *Stunting*.
- (3) **The annual performance review as intended in paragraph (1) is carried out by:**
 - a. compare plans and actual *output* achievements (performance targets), *outcome* achievements, budget absorption, and completion time frames;
 - b. identify factors that hinder the achievement of *output* and *outcome* performance targets; **And**
 - c. formulate follow-up improvements so that performance targets can be achieved in the following year.

BAB V
ORGANIZING
Article 13

(1) In implementing *Stunting* prevention in the Region formed:

a. *Stunting* Prevention Coordination Team ; and b.

Stunting Prevention Working Group .

(2) Composition and elements of membership of the Coordination Team and The group as referred to in paragraph (1) as following:

a. The *Stunting* Prevention Coordination Team consists of:

 - d) Regional General Hospital; And
 - e) Other related elements.
 3. Food Security working group;
 - a) Agriculture and Fisheries Service;
 - b) Food Service; And
 - c) Other related elements.
 4. Working group on Housing and Clean Water
 - a) Public Works and Spatial Planning Department;
 - b) Regional Drinking Water Company; And
 - c) Other related elements.
 5. Communication, Information and working group
Education.
 - a) Communication and Informatics Service;
 - b) Department of Education and Culture;
 - c) Social Services;
 - d) Population and Civil Registration Service; And
 - e) Other related elements.
- (3) The *Stunting* Prevention Coordination Team and *Stunting* Prevention Working Group as intended in paragraph (1) are determined by Regent's Decree.**

BAB VI

COORDINATION

Part One

General

Article 14

In implementing *Stunting* prevention , coordination includes:

- a. Regional Level Coordination;
 - b. District Level Coordination; and c.
- Village/Subdistrict Level Coordination.

The second part

Regional Level *Stunting* Prevention Coordination

Article 15

- (1) **Regional Level Coordination** as referred to in Article 14 letter a is carried out by the Coordination Team and *Stunting Prevention Working Group*.
- (2) **Coordination** as referred to in paragraph (1) includes socialization, facilitation, guidance, monitoring and evaluation of *stunting* prevention actions carried out at the regional, sub-district and village/sub-district levels.
- (3) **Coordination results** as intended in paragraph (2) as a perfecting input material in taking next strategic steps.

Part Three

Coordination of *Stunting* Prevention at District Level

Article 16

Sub-district level coordination as referred to in Article 14 letter a is carried out by the sub-district head who acts as the coordinator of *stunting* prevention interventions at the sub-district level.

Part Four

Coordination of *Stunting* Prevention at Village/Subdistrict Level

Article 17

Subdistrict level coordination as referred to in Article 14 letter a is carried out by the Village Head/Lurah who acts as the *Stunting* prevention intervention coordinator at the village/subdistrict level.

BAB VII

PERFORMANCE ASSESSMENT

Article 18

- (1) **The Regent carries out an assessment of the performance of sub-districts and villages/sub-districts in implementing convergence actions to prevent *Stunting*.**
- (2) **The purpose of the performance assessment as referred to in paragraph (1) for:**
 - a. **Ensure and implement convergence village/subdistrict Actions;**
 - b. **provide written responses to the results of performance assessments to sub-districts and villages/sub-districts implementation of Convergence Action;**
 - c. **identify the implementation of good practices in implementing the Convergence Action for *Stunting* prevention between sub-districts and between villages/sub-districts; And**

d. provide awards in the form of certificates and prizes for the implementation of the Stunting Prevention Convergence Action .

- (3) In carrying out the assessment as referred to in paragraph (1), the Regent delegates to the *Stunting* Prevention Coordination Team and the *Stunting Prevention Working Group*.

BAB VIII

COOPERATION

Article 19

- (1) In supporting the implementation and sustainability of convergence actions to prevent *Stunting*, the Regional Government collaborates with other parties.
- (2) Cooperation as referred to in paragraph (1) is carried out based on benefits for efforts to prevent *stunting* and community welfare based on statutory regulations.

Chapter IX

MONITORING, EVALUATION AND REPORTING

Article 20

- (1) The Regent carries out monitoring and evaluation of implementation of Stunting prevention .
- (2) The implementation of monitoring and evaluation as intended in paragraph (1) is carried out by the *Stunting Prevention Working Group* .
- (3) Results of monitoring and evaluation of *Stunting* prevention as referred to in paragraph (2) is reported to the Regent periodically every 6 (six) months or when needed.
- (4) Report on the results of monitoring and evaluation of *Stunting* prevention as intended in paragraph (3) is reported to the Governor periodically every 6 (six) months or if necessary at any time.

CHAPTER X

FINANCING

Article 21

- (1) Costs incurred in implementing *Stunting* prevention charged to the Regional Revenue and Expenditure Budget.
- (2) Apart from being sourced from the Revenue and Expenditure Budget and Regional Expenditures, costs as intended in paragraph (1) can be sourced from:
- a. State budget;

- b. Regional Revenue and Expenditure Budget; And
- c. Other legal and non-binding sources of funds.

Article 22

The implementation of convergence actions to prevent *Stunting* is listed in the Appendix which is an inseparable part of this Regent's Regulation.

Chapter IX

CLOSING

Article 23

This Regent's Regulation comes into force on the date of promulgation. So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.
