# DELEGATION OF AUTHORITY TO ISSUE REGISTRATION SIGNS LEGAL ENTITY SOCIAL WELFARE INSTITUTION TO THE HEAD OF SOCIAL SERVICES

# BY THE GRACE OF GOD ALMIGHTY REGENT SUKOHARJO,

Considering: a. that in order to realize effective and efficient services so as to provide legal certainty in the issuance of registration certificates for Social Welfare Institutions, the Regent needs to delegate the authority to issue registration certificates for legal entity Social Welfare Institutions to the Head of the Social Service;

- b. that based on the provisions of Article 14 paragraph (2) of the Minister of Social Affairs Regulation Number 184 of 2011 concerning Social Welfare Institutions, the Regent is in accordance with his authority issue a registration certificate no later than 14 (fourteen) working days after the registration requirements are declared complete;
- c. that based on the considerations as intended in letters a and b, it is necessary to stipulate a Regent's Regulation concerning the Delegation of Authority to Issue Registration Certificates for Legally Incorporated Social Welfare Institutions to the Head of the Social Service;

#### DECIDE:

To stipulate: REGULATION OF THE REGENT CONCERNING DELEGATION OF AUTHORITY TO ISSUATE REGISTRATION SIGNS OF LEGAL ENTITIES OF SOCIAL WELFARE INSTITUTIONS TO THE HEAD OF SOCIAL SERVICES.

#### PIG

#### **GENERAL REQUIREMENTS**

#### article 1

In this Regent's Regulation what is meant by:

- 1. The region is Sukoharjo Regency.
- 2. Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.
- 3. The Regent is the Regent of Sukoharjo.
- 4. Social Service is the Sukoharjo Regency Social Service.
- 5. Social Welfare Institutions, hereinafter abbreviated as LKS, are social organizations or social associations that carry out social welfare activities formed by the community, both legal entities and non-legal entities.
- 6. A legal entity LKS is a social organization or social association which operates in the field of providing social welfare in the form of a foundation or other form which is declared as a legal entity.
- 7. Delegation of Authority is the transfer of duties, rights, obligations and responsibilities for issuing LKS registration certificates.

#### CHAPTER II

### **DELEGATION OF AUTHORITY**

#### Section 2

- (1) The Regent, in accordance with his authority, issues registration certificates LKS is a legal entity.
- (2) The Regent in issuing the legal entity LKS registration certificate as intended in paragraph (1) delegates it to the Head of the Social Service.
- (3) The Head of the Social Service issues an LKS registration certificate no later than 14 (fourteen) working days after the registration requirements are declared complete.

#### CHAPTER III

## COACHING, SUPERVISION AND REPORTING

#### Article 3

(1) The Social Service provides guidance and supervision regarding the issuance of LKS registration certificates in accordance with its authority based on the provisions of statutory regulations.

- (2) In carrying out the delegation of authority as intended in Article 2, the Head of the Social Service reports to the Regent.
- (3) Implementation reporting as intended in paragraph (2) carried out every year.

CHAPTER IV

#### **CLOSING**

#### Article 4

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.
