SUKOHARJO REGENCY REGULATIONS NUMBER 87 OF 2022

ABOUT

USE OF DATA AND INFORMATION

BY THE GRACE OF GOD ALMIGHTY REGENT SUKOHARJO,

Considering: that to implement the provisions of Article 12 paragraph (5)

Sukoharjo Regency Regional Regulation Number 2 of 2022 concerning Electronic-Based Government Systems, it is necessary to stipulate a Regent's Regulation concerning the Use of Data and Information;

DECIDE:

Establish: REGENT REGULATIONS CONCERNING DATA USE AND INFORMATION.

PIG GENERAL REQUIREMENTS

article 1

In this Regent's Regulation what is meant by:

- 1. The region is Sukoharjo Regency.
- 2. Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.
- 3. The Regent is the Regent of Sukoharjo.
- 4. Regional Apparatus is the supporting element of the Regent and the Regional People's Representative Council in administering government affairs which fall under the authority of the Region.
- The Communication and Informatics Service, hereinafter referred to as the Communication and Information Service, is the Sukoharjo Regency Communication and Informatics Service.
- 6. Data is a record of a collection of facts or descriptions in the form of numbers, characters, symbols, images, maps, signs, signals, writing, voices and/or sounds, which represent the actual situation showing an idea, object, condition or situation.
 Or
- Data Producers are units in Central Agencies and Regional Agencies that produce Data based on authority in accordance with statutory provisions.
- 8. Data Users are Central Agencies, Regional Agencies, individuals, groups of people, or legal entities that use Data.
- 9. Data Guardian is a unit in Central Agencies and Regional Agencies that carries out activities for collecting, examining and managing Data submitted by Data Producers, as well as disseminating Data.

- 10. National Data Center is a collection of data centers that are used on a shared basis by Central Agencies and Regional Governments, connected to each other, and used for the placement of electronic systems and other related components for the purposes of data placement, storage, processing and recovery.
- 11. Data interoperability is the ability of data to be shared between electronic systems that interact with each other.
- 12. Application Programming Interface (API) is a technology to facilitate the exchange of information or data between two or more software applications.
- 13. Government Service Liaison System is a service liaison system organized by the Regional Government to exchange SPBE Services within the Regional Government.
- 14. Information is information, statements, ideas and signs that contain values, meanings and messages, both data, facts and explanations that can be seen, heard and read which are presented in various packages and formats in accordance with developments in information technology and electronic or non-electronic communication.

CHAPTER II

PURPOSE AND OBJECTIVES

Section 2

This Regent's Regulation is intended as a guideline in implementing the Use of Data and Information.

Article 3

This Regent's Regulation aims to:

- a. guarantee the realization of accurate, up-to-date, integrated and accessible data as a basis for planning, implementing, evaluating and controlling regional development; And
- b. guarantee the quality of information that is accurate, effective, efficient and timely.

CHAPTER III

SCOPE

Article 4

The scope of this Regent's Regulation includes:

- a. share data use; And
- b. Use of Information.

CHAPTER IV SHARE DATA USE

Article 5

- (1) Data sharing prioritizes data stored in National Data Center.
- (2) Regional Data Producers provide APIs at the National Data Center.
- (3) Data Interoperability Standards based on provisions legislation.
- (4) The Communications and Information Service provides a service liaison system for data use purposes.
- (5) The Communications and Information Service and Data Users guarantee Data security from access that is not in accordance with Data governance provisions or laws and regulations related to Data management.
- (6) Further provisions regarding access rights for data use are regulated in the Standard Operating Procedures stipulated by the Communications and Information Service.

CHAPTER V USE OF INFORMATION

Article 6

- (1) The information used is sourced from data has been processed by the Data Producer.
- (2) Data Producers and Data Guardians are responsible to Information.
- (3) Information is used to describe the results of the implementation of the duties and functions of the Data Producer.
- (4) Information is published in accordance with statutory provisions.

CHAPTER VI

CLOSING

Article 7

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regulation is ordered to be promulgated by placing it in the Regional Gazette of Su**Regari**b Regency.
