# CHANGES TO REGENT REGULATION NUMBER 32 OF 2022 CONCERNING REGIONAL GOVERNMENT WORK PLANS SUKOHARJO DISTRICT IN 2023

## BY THE GRACE OF GOD ALMIGHTY

#### REGENT SUKOHARJO,

Considering: a. that to implement the provisions of Article 26 paragraph (2)

Law Number 25 of 2004 concerning the National Development Planning System and Article 264 paragraph (2) of Law Number 23 of 2014 concerning Regional Government as amended several times, most recently by Law Number 6 of 2023 concerning the Determination of Government Regulations in Lieu of Laws. Law Number 2 of 2022 concerning Job Creation has become a Law, Sukoharjo Regent Regulation Number 32 of 2022 concerning the Sukoharjo Regency Regional Government Work Plan for 2023 has been stipulated;

- b. that based on an evaluation of the implementation of the 2023 Sukoharjo Regency Regional Government Work Plan up to the second quarter there are additional activities and sub-activities in the Regional Apparatus so that adjustments need to be made to the activities and sub-activities of the 2023 Sukoharjo Regency Regional Government Work Plan:
- c. that based on the considerations as intended in letters a and b, Regent Regulation Number 32 of 2022 concerning Regional Government Work Plans
  - Sukoharjo Regency in 2023, needs to be changed;
- d. that based on the considerations as intended in letters a, b, and c, it is necessary to stipulate a Regent's Regulation concerning Amendments to Regent's Regulation Number 32 of 2022 concerning the Sukoharjo Regency Regional Government Work Plan for 2023;

#### DECIDE:

To stipulate: REGENT'S REGULATION CONCERNING AMENDMENTS TO REGENT'S REGULATION NUMBER 32 OF 2022 CONCERNING THE WORK PLAN OF THE REGIONAL GOVERNMENT OF SUKOHARJO DISTRICT FOR 2023.

## Article I

Provisions of Article 4 in Regent Regulation Number 32 of 2022 concerning Regency Regional Government Work Plans
Sukoharjo 2023 (Regional Gazette of Sukoharjo Regency
2022 Number 32) is amended to read as follows:

#### Article 4

(1) Changes to the 2023 RKPD are prepared systematically as follows:

a. Pig : Introduction;

b. chapter II : Evaluation of the Results of the Second Quarter (Two) Years

Regarding;

c. chapter III : Economic and Financial Framework

Area;

d. Chapter IV : Development Goals and Priorities

Area;

e. Chapter V : Regional Work Plan and Funding;

And

f. Chapter VI : Closing.

(2) A description of the changes to the 2023 RKPD as intended in paragraph (1) is contained in the Attachment which is an inseparable part of this Regent's Regulation.

### Article II

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.
