4 OF 2006 CONCERNING GUIDELINES FOR ORGANIZATIONAL DESIGNATION  
AND VILLAGE GOVERNMENT WORK PROCEDURES**

**REGENT SUKOHARJO,**

- Considering:**
- a. that with the enactment of Law Number 6 of 2014 concerning Villages, Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages as amended by Government Regulation Number 47 of 2015 concerning Amendments to Government Regulation Number 43 of 2014 regarding the Implementing Regulations of Law Number 6 of 2014 concerning Villages and Minister of Home Affairs Regulation Number 84 of 2015 concerning Organizational Structure and Work Procedures of Village Government, then Sukoharjo Regency Regional Regulation Number 4 of 2006 concerning Guidelines for the Organization and Work Procedures of Village Government is not in accordance with regulatory provisions regarding the Organizational Structure and Work Procedures of Village Government;**
  - b. that based on the provisions of Article 15 of the Minister of Home Affairs Regulation Number 84 of 2015 concerning the Organizational Structure and Work Procedures of Village Governments, it is mandated that regulations regarding the organizational structure and work procedures of village governments and village officials be regulated by Regent's Regulations;**
  - c. that based on the considerations as intended in letters a and b, Sukoharjo Regency Regional Regulation Number 4 of 2006 concerning Guidelines for Organizational Arrangement and Village Government Work Procedures needs to be revoked;**
  - d. that based on the considerations as intended in letters a, b, and c, it is necessary to stipulate a Regional Regulation concerning the Revocation of Sukoharjo Regency Regional Regulation Number 4 of 2006 concerning Guidelines for the Organization and Work Procedures of Village Government;**

**REVOCATION OF SUKOHARJO DISTRICT REGIONAL REGULATION NUMBER  
4 OF 2006 CONCERNING GUIDELINES FOR ORGANIZATIONAL DESIGNATION  
AND VILLAGE GOVERNMENT WORK PROCEDURES**

**I. GENERAL.**

Sukoharjo Regency Regional Regulation Number 4 of 2006 concerning Guidelines for Preparing Village Government Organizations and Work Procedures, is no longer appropriate and is in conflict with statutory regulations, namely: 1. Law Number 6 of 2014 concerning Villages, especially Article 48; 2. Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages as amended by Government Regulation Number 47 of 2015 concerning Amendments to Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages, especially in Article 61; and 3. Minister of Home Affairs Regulation Number 84 of 2015 concerning Organizational Structure and Work Procedures of Village Governments, especially in Article 15.

Non-compliance with the statutory regulations in question includes, among other things, several regulations regarding:

1. organizational structure, duties and functions;
2. type of village; and
3. work procedures;

Apart from that, the regulations regarding Guidelines for Organizational Arrangement and Village Government Work Procedures which have so far been regulated in Regional Regulations are mandated based on the provisions of statutory regulations to be regulated in Regent Regulations.

Based on the considerations above, so that the Regional Government can follow up on the provisions governing the Organizational Structure and Work Procedures of Village Government in accordance with statutory regulations, Sukoharjo Regency Regional Regulation Number 4 of 2006 concerning Guidelines for the Organizational Structure and Work Procedures of Village Government, is revoked and declared not applicable.
