Minister of Home Affairs Regulation Number 112 of 2014
concerning the Election of Village Heads and Regulations of the Minister of Internal Affairs
State Number 82 of 2015 concerning Appointment and
Dismissal of the Village Head as amended by Minister of Home
Affairs Regulation Number 66 of 2017 concerning Amendments to
Minister of Home Affairs Regulations
Number 82 of 2015 concerning Appointment and
Dismissal of the Village Head requires establishing regulations
Regions regarding the Second Amendment to Regional Regulations
Sukoharjo Regency Number 10 of 2015 concerning Heads
Village;

DECIDE:

To stipulate: REGIONAL REGULATIONS CONCERNING THE SECOND AMENDMENT TO SUKOHARJO DISTRICT REGIONAL REGULATIONS NUMBER 10 OF 2015 CONCERNING VILLAGE HEADS.

Article I

Several provisions in the Regency Regional Regulations
Sukoharjo Number 10 of 2015 concerning Village Heads
(Sukoharjo Regency Regional Gazette 2015 Number
10, Supplement to Sukoharjo Regency Regional Gazette Number
224) as amended by Regional Regulations
Sukoharjo Regency Number 8 of 2016 concerning
Changes to Sukoharjo Regency Regional Regulations
Number 10 of 2015 concerning Village Heads (Gazette
Sukoharjo Regency Region 2016 Number 8,
Additional Sukoharjo Regency Regional Gazette Number 233),
amended as follows:

1. The provisions of Article 1 are added with 4 (four) numbers, namely number 28, number 29, number 30 and number 31 so that Article 1 reads as follows:

article 1

In this Regional Regulation what is meant by:

- 1. The region is Sukoharjo Regency.
- 2. Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.
- 3. The Regent is the Regent of Sukoharjo.
- 4. A village is a legal community unit that has territorial boundaries that has the authority to regulate and manage government affairs, the interests of local communities based on community initiatives, original rights, and/or traditional rights that are recognized and respected in the government system of the Unitary State of the Republic of Indonesia.
- 5. Village Authority is the authority possessed by the Village including authority in the field of administering Village Government, implementing Village Development, Development of Village Community, and Empowerment of Village Community based on community initiative, original rights and Village customs.

- 6. Village Government is the administration of government affairs and the interests of local communities in the government system of the Unitary State of the Republic of Indonesia.
- 7. Village Government is the Village Head assisted by Village officials as an element of Village Government administration.
- 8. Village Consultative Body, hereinafter abbreviated to BPD, is an institution that carries out government functions whose members are representatives of the Village population based on regional representation and are determined democratically.
- Village Community Institutions are institutions formed by the community in accordance with needs and are partners of the village government in empowering the community.
- 10. Village Deliberation is a deliberation between the BPD, the Village Government and elements of society held by the BPD to agree on matters strategic in nature.
- 11. The Village Head is a Village Government official who has the authority, duties and obligations to organize the Village household and carry out the duties of the Government and Regional Government.
- 12. The election of the Village Head is an exercise of sovereignty people in the village in order to elect a Village Head who is direct, general, free, confidential, honest, and fair.
- 13. The Village Head Election Committee, hereinafter referred to as the Election Committee, is the Committee formed by the BPD to carry out the Village Head Election process.
- 14. The Regency level Village Head election committee, hereinafter referred to as the Regency Election Committee, is a committee formed by the Regent at the Regency level to support the implementation of the Village Head election.
- 15. Village Head Candidate is a prospective Village Head who has been determined by the Election Committee as a candidate who has the right to be elected as Village Head.
- 16. Elected Village Head Candidate is a candidate for Village Head who received the most votes in the Village Head election.
- 17. Acting Village Head is an official appointed by the authorized official to carry out the duties, rights and authority and obligations of the Village Head within a certain period of time.

- 18. Voters are residents of the village concerned and have fulfilled the requirements to exercise the right to vote in the election of the Village Head.
- 19. Temporary Voter List, hereinafter abbreviated DPS is a voter list compiled based on data from the Permanent Voter List for the last General Election which has been updated and checked again for correctness and added with new voters.
- 20. Additional Voter List is a voter list compiled based on proposals from voters

 The person concerned is not yet registered in the Temporary Voter List.
- 21. Permanent Voter List, hereinafter abbreviated as DPT is a list of voters that has been determined by the Election Committee as the basis for determining identity voters and number of voters in the Village Head election.
- 22. Deleted.
- 23. A campaign is an activity carried out by a Village Head Candidate to convince voters in order to gain support.
- 24. Polling Place, hereinafter abbreviated as TPS, is the place where voting takes place voice.
- 25. Witnesses are local village residents who are authorized by the Village Head Candidate to represent the candidate concerned in participating in the voting process.
- 26. Supervisory Team is a Team formed to supervise the process of selecting Village Heads at the village and subdistrict levels.
- 27. Day is a working day.
- 28. A court decision is a judge's statement made in an open court session, which can be in the form of punishment or acquittal or release from all legal charges.
- 29. A suspect is a person who, because of his actions or circumstances, based on preliminary evidence, is reasonably suspected of being the perpetrator of a criminal offense since the issuance of the Suspect Determination Letter or Lette Order to Commence Investigation.
- 30. A defendant is a suspect who has been charged, examined and tried in court since the file is declared complete by the Public Prosecutor and recorded in the case register at court.

- 31. A convict is a person who is convicted based on a court decision which has obtained permanent legal force, with a decision letter/information from the Court.
- 2. The provisions of Article 8 are added with 1 (one) paragraph, namely paragraph (5) so that Article 8 reads as follows:

- (1) Before the Village Head can be elected simultaneously once as intended in Article 7 paragraph (1), the Village Head can be elected done in waves.
- (2) The staggered election of Village Heads as intended in paragraph (1) can be carried out by considering:
 - a. grouping of time of end of term of office Village Head in the Regency area;
 - b. regional financial capacity; and/or
 - c. availability of civil servants in the Regency who meet the requirements as Acting Village Head.
- (3) The staggered election of Village Heads as intended in paragraph (1) shall be carried out a maximum of 3 (three) times within a period of 6 (six) years.
- (4) The selection of Village Heads as referred to in paragraph (3) is carried out at a maximum time interval of 2 (two) years.
- (5) Further provisions regarding the time interval for the staggered election of Village heads as referred to in paragraph (4) are regulated by a Regent's Regulation.
- 3. The provisions of paragraph (2) and paragraph (3) of Article 9 are amended to read as follows:

Article 9

- (1) The Regent forms an Election Committee in the Regency.
- (2) The election committee in the Regency as intended in paragraph (1) has duties and authority including:
 - a. plan, coordinate and organize all stages of implementing district level elections;
 - b. provide technical guidance on the implementation of the Village Head election to the Village Head election committee at the village level;

- c. facilitate the provision of equipment, supplies and polling places;
- d. facilitate the resolution of problems in the election of Village Heads at the Regency level related to the vote counting results;
- e. carry out supervisione point is large head elections and make recommendations to the Regent; f. evaluate and report on election implementation; And
- g. carry out other duties and authorities stipulated by the Regent's Decree.
- (3) The duties of the committee as intended in paragraph (2) letter e are delegated to the Election Supervisory Team Village Head in the District.
- (4) The elements of the Election Committee in the Regency as intended in paragraph (1) are regulated in the Regent's Regulation.
- (5) Membership of the Regency Election Committee as intended in paragraph (1) is determined by a Regent's Decree.
- 4. Between Article 12 and Article 13, 1 (one) Article, namely Article 12A, is inserted so that it reads as follows:

Article 12A

The BPD cannot dissolve the election committee until an elected village head candidate is determined.

5. The provisions of Article 15 are amended to read as follows following:

Article 15

The Village Head Election Committee as intended in Article 12 letter b has the following duties:

- a. plan, coordinate, organize, supervise and control all stages of election implementation;
- b. planning and submitting election costs to the Regent through the Camat;
- c. carry out voter registration and determination;
- d. conducting screening and screening of prospective candidates;
- e. carry out additional selection of more than 5 (five) prospective village head candidates;
- f. determine candidates who have met the requirements;
- g. determine the procedures for conducting elections;
- h. determine the procedures for implementing the campaign;

- i. determine the number of ballot papers and ballot boxes;
- j. printing ballot papers and making ballot boxes and other election equipment;
- k. deliver ballot papers, ballot boxes and other election equipment;
- I. carry out voting;
- m. determine the results of the vote count recapitulation and announce election results;
- n. determine the elected Village Head candidate; And
- o. evaluate and report on the implementation of the election.
- 6. Between Article 15 and Article 16, 3 (three) articles are inserted, namely Article 15A, Article 15B and Article 15C, so that they read as follows:

Article 15A

- (1) The Election Committee may not resign without justifiable reasons before completing its duties.
- (2) In the event that the Election Committee resigns with justified reasons as intended in paragraph (1), it will be replaced by a replacement committee from the same elements of the Election Committee as intended in Article 14 paragraph (2).
- (3) In the event that a Substitute Committee from the same Election Committee element does not exist, it is replaced by another Election Committee element.
- (4) The Substitute Committee as intended in paragraph (2) and paragraph (3) is determined by a BPD Decree.
- (5) In the event that the BPD does not issue a BPD Decision as intended in paragraph (4), then it is taken over by the Regency Election Committee.

Article 15B

- (1) In the event that the entire Election Committee resigns with justified reasons, the BPD forms an Election Committee.
- (2) In the event that the BPD does not form an Election Committee as intended in paragraph (1), it is taken over by the Regency Election Committee.

Article 15C

(1) In the event that the Election Committee is unable to carry out its duties due to certain conditions, then
The duties of the Election Committee are assisted and/or taken over by the Regency Election Committee.

- (2) The Election Committee is assisted by the Regency Election Committee in the event that the Election Committee is unable to carry out some of its duties.
- (3) The Election Committee is taken over by the Regency Election Committee in the event that it cannot carry out all its duties and the BPD does not form an Election Committee as intended in Article 15B.
- (4) Certain conditions as intended in paragraph (1) includes:
 - a. disturbance of security and order by taking into account police input; And
 - b. social disaster determined by the Regent.
- (5) In the event that the Regency Election Committee assists and/or takes over the duties of the Election Committee as intended in paragraph (1), this is determined by a Regent's Decree.
- 7. Article 29 letter g is deleted, so that Article 29 reads as follows:

Candidates for Village Head must meet the following requirements:

- a. citizen of the Republic of Indonesia;
- b. have faith in God Almighty;
- c. uphold and practice Pancasila, implement the 1945
 Constitution of the Republic of Indonesia, and defend and maintain the integrity of the Unitary State of the Republic of Indonesia and Bhinneka Tunggal Ika;
- d. minimum education completed junior high school or equivalent;
- e. at least 25 (twenty five) years of age at the time of registration;
- f. willing to be nominated as Village Head;
- g. deleted
- h. not currently serving a prison sentence;
- i. has never been sentenced to imprisonment based on a court decision that has permanent legal force for committing a criminal offense that is punishable by imprisonment for a minimum of 5 (five) years or more, except 5 (five) years after completing the prison sentence and announcing it honestly and openly to the public that the person concerned has been convicted and is not a repeat offender;

- j. not having their right to vote revoked in accordance with a Court decision which has permanent legal force;
- k. healthy; And
- I. never served as Village Head for 3 (three) terms of office.
- 8. The provisions of paragraph (3) of Article 34 are amended to read as follows:

- (1) In the event that there are more than 5 (five) prospective Village Head candidates who meet the requirements as intended in Article 29, additional selection is carried out using the criteria of work experience in government institutions, education level and age.
- (2) Apart from additional selection with the criteria as follows referred to in paragraph (1) additional selection is carried out through a written test.
- (3) Additional selection as intended in paragraph (1) and paragraph (2) is implemented by the Election Committee.
- (4) Procedures for additional selection of prospective Village Head candidates as intended in paragraph (1) and paragraph (2) are regulated by Regent Regulations.
- 9. The provisions of paragraph (1) and paragraph (3) of Article 45 are amended to read as follows:

Article 45

- (1) The number of TPS is determined based on regional areas based on Rukun Warga or hamlets with more than 1 (one) and odd numbers.
- (2) The TPS as referred to in paragraph (1), is determined to be located in a place that is easy to reach, including for people with disabilities, and guarantees that every voter can cast their vote directly, publicly, freely, confidentially, honestly and fairly.
- (3) The number, location, layout of TPS and number of voters at each TPS are determined by the Election Committee.
- 10. The provisions of Article 52 are amended to read as follows following:

Article 52

(1) The Village Head candidate who obtains the most votes from the number of valid votes is determined to be the elected Village Head candidate.

- (2) In the event that the Village head candidate who obtains the most votes is more than 1 (one) person, the candidate is elected determined based on the distribution of the highest number of valid votes in each TPS with a larger number of TPS.
- (3) Provisions for obtaining the most votes by more than 1 (one) person as intended in paragraph (2) are regulated by a Regent's Regulation.
- 11. Between paragraph (1) and paragraph (2) of Article 54, 1 (one) paragraph is inserted, namely paragraph (2a), so that Article 54 reads as follows:

- (1) The Village Head Election Committee submits a report on the results of the Village Head election to the BPD after the vote counting is complete, no later than 3 (three) days after the voting.
- (2) BPD, based on the report on the results of the Village Head election as intended in paragraph (1), submits the selected Village Head candidate based on the majority of votes to the Regent via the Camat with a copy to the Village Head, no later than 3 (three) days after receiving the committee report. (2a) In the event that the BPD
- does not submit a report on the results of the Village Head election as intended in paragraph (2), then the report on the results of the Village Head election is reported by the Camat to the Regent with a copy to the Village Head after obtaining a copy of the Village Head election results report from the Village Head Election Committee.
- (3) The Regent determines the ratification and appointment of the Village Head with a Regent's Decree, no later than 30 (thirty) days after receiving the report from the BPD or sub-district head as intended in paragraph (2) and paragraph (2a).
- 12. Between Article 54 and Article 55, 2 (two) articles are inserted, namely Article 54A and Article 54B so that they read as follows:

Article 54A

(1) An elected Village Head candidate who dies, is permanently absent or resigns for a justifiable reason before the inauguration, the elected candidate is declared disqualified and the Regent appoints a Civil Servant from the Regional Government as Acting Village Head.

(2) The acting Village Head as referred to in paragraph (1) carries out the duties and authority of the Village Head until the Village Head is appointed as a result of simultaneous direct election in accordance with the provisions of statutory regulations.

Article 54B

- (1) An elected Village Head candidate who is designated as a suspect and is threatened with imprisonment for a minimum of 5 (five) years prior to his inauguration, the selected candidate remains appointed as Village Head.
- (2) An elected Village Head candidate who is determined to be a suspect in a criminal act of corruption, terrorism, treason and/or a crime against state security prior to his inauguration, the selected candidate remains inaugurated as Village Head and at the first opportunity the Regent temporarily dismisses the person concerned from his position as Head. Village.
- (3) The elected Village Head candidate who is named as a defendant and is threatened with imprisonment for a minimum of 5 (five) years based on the case register at the court before the inauguration, the elected candidate remains is appointed as Village Head and at the first opportunity the Regent temporarily dismisses the person concerned from his position as Village Head.
- (4) The elected village head candidate who is declared a convict and is threatened with imprisonment for a minimum of 5 (five) years based on a court decision which has permanent legal force before the inauguration, the selected candidate remains appointed as Village Head and at the first opportunity the Regent dismisses the person concerned. from his position as Village Head and appointed Civil Servants from the Regional Government as

Acting Village Head.

- (5) The elected Village head candidate as intended in paragraph (1) to paragraph (4) who is not present at the time of the inauguration is deemed to have resigned unless there is a justifiable reason.
- (6) Implementation of the first opportunity provisions as intended in paragraph (2), paragraph (3) and paragraph (4), no later than 14 (fourteen) days from the date of inauguration.
- (7) The acting Village head as referred to in paragraph (4) carries out the duties and authority of the Village Head until the Village Head is appointed as a result of the interim Village head election through the Village deliberation.

13. The provisions of paragraph (3) of Article 59 are amended to read as follows:

Article 59

- (1) Civil servants who nominate themselves in the Village Head election must obtain written permission from the Civil Service Supervisory Officer.
- (2) In the case of Civil Servants as intended in paragraph (1) is elected and appointed as Village Head, the person concerned is temporarily released from his position while he is Village Head without losing his rights as a Civil Servant.
- (3) Civil servants who are elected and appointed as Village Heads as intended in paragraph (2) are entitled to receive Village Head allowances and other legitimate income sourced from the Village Revenue and Expenditure Budget.
- 14. Article 61 is deleted.
- 15. Between Article 61 and Article 62, 5 (five) articles are inserted, namely Articles 61A, 61B, 61C, 61D and 61E, so that they read as follows:

Article 61A

- (1) A Village Head who resigns and/or is dismissed with a remaining term of office of more than one year, the Regent appoints a civil servant from the Regional Government as the acting Village head until the Village Head is appointed at any time as a result of the Village deliberation.
- (2) The Village Deliberation as referred to in paragraph (1) shall be held no later than 6 (six) months after the Village Head is dismissed.
- (3) The term of office of the Village head determined through Village deliberation starts from the date of inauguration until the remaining term of office of the dismissed Village head expires.

Article 61B

- (1) BPD forms an inter-Village head election committee time.
- (2) The formation of an interim Village head election committee as intended in paragraph (1) is determined by the decision of the BPD leadership.
- (3) The interim Village head election committee consists of Village officials and community elements.

- (4) The number of the interim Village head election committee as referred to in paragraph (3) shall be adjusted to the workload and capacity of the Village revenue and expenditure budget.
- (5) The interim Village head election committee as intended in paragraph (4) is responsible to the leadership of the BPD.

Article 61C

- (1) The election committee as intended in Article 61B paragraph (3) carries out a selection and screening of prospective Village head candidates from time to time.
- (2) The screening of prospective Village head candidates to become Village head candidates is determined by at least 2 (two) people candidates and a maximum of 3 (three) candidates.
- (3) In the event that the number of candidates as intended in paragraph (2) who fulfill the requirements is more than 3 (three), the committee will carry out additional selection.
- (4) Additional selection as intended in paragraph (3) consists of:
 - a. have experience in government Village;
 - b. level of education; and/or b. otherrequirements determined by the Regent.
- (5) In the event that there are less than 2 (two) candidates who meet the requirements, the election committee extends the number of candidates Registration time is 7 (seven) days.
- (6) In the event that there are still fewer than 2 (two) candidates who meet the requirements after the extension of time as intended in paragraph (4), the BPD postpones the implementation of the Village deliberation for the election of the Village head until the time determined by the BPD.

Article 61D

- (1) Interim village head elections are carried out through stages:
 - a. preparation;
 - b. implementation; And
 - c. reporting.
- (2) The preparation stages as intended in paragraph (1) include:
 - a. the formation of an interim Village head election committee by the BPD no later than 15 (fifteen) days from the time the Village head is dismissed;

- b. submission of election costs at the expense of the Village Revenue and Expenditure Budget by the election committee to the acting Village head within a period of 30 (thirty) days from the time the committee was formed;
- c. granting approval for election costs by the acting Village head within a period of 30 (thirty) days from the time it is submitted by the election committee;
- d. announcement and registration of Village head candidates by the election committee within a period of 15 (fifteen) days; e. examination
- of the completeness of administrative requirements for prospective candidates by the election committee within a period of 7 (seven) days; And
- f. determination of candidates for interim Village head by the election committee of at least 2 (two) candidates and a maximum of 3 (three) candidates who are requested to be ratified by the Village deliberation to be determined as candidates who have the right to be elected at the Village deliberation.
- (3) The implementation stages as intended in paragraph (1) letter b include: a. The
 - implementation of the Village Deliberation is led by the Chairman of the BPD where the technical implementation of the election is carried out by the election committee;
 - b. ratification of Village head candidates who have the right to be elected by the Village meeting through deliberation to reach consensus or through voting;
 - c. carrying out the election of Village head candidates by the election committee and Village deliberation participants through a consensus deliberation mechanism or through voting that has been agreed upon by the Village deliberation;
 - d. reporting the results of the election of Village head candidates by the election committee to the Village

deliberation; and e. ratification of selected candidates by the Village delib

- (4) Village deliberation participants as referred to in paragraph (3) letter c involve elements of the community.
- (5) The community elements as intended in paragraph (4) come from:
 - a. religious leaders;
 - b. public figure;
 - c. education figure;
 - d. representatives of farmer groups;
 - e. representatives of craftsmen groups;

- f. representatives of women's groups;
- g. representatives of observer and protection groups child;
- h. representatives of poor community groups; or
- i. other elements of society in accordance with the sociocultural conditions of the local community.
- (6) The community elements as referred to in paragraph (5) letter i are represented by a maximum of 5 (five) people from each hamlet.
- (7) The number of Village deliberation participants as referred to in paragraph (4) and paragraph (5) is discussed and agreed upon with the BPD and the Village government by taking into account the number of residents who have the right to vote in the Village as determined by the BPD decision.
- (8) The reporting stages as intended in paragraph (1) letter c include:
 - a. reporting the results of the Village head election through the Village deliberation to the BPD within 7 (seven) days after the Village deliberation ratifies the elected Village head candidate;
 - b. reporting of the elected Village head candidate as a result of the Village deliberation by the BPD chairman to the Regent no later than 7 (seven) days after receiving the report from the
 - election committee; c. issuance of the regent/mayor's decision regarding ratification of the appointment of the elected Village head candidate no later than 30 (thirty) days from the receipt of the report from the BPD; And
 - d. the inauguration of the Village head by the Regent no later than 30 (thirty) days from the issuance of the decision ratifying the appointment of the elected Village head candidate in the order of the inauguration ceremony in accordance with the provisions of statutory regulations.
- (9) Stages of implementing the interim Village head election as intended in paragraph (2), paragraph (3), and paragraph (4) can be shortened by considering efficiency and effectiveness, the implementation of which is stipulated in the Regent's Regulation.

Article 61E

- (1) The BPD submits the report of the selected Village head candidate as a result of the Village deliberation to the Regent.
- (2) The Regent validates the elected Village head candidate as intended in paragraph (1) with a Regent's Decree.

- (3) The Regent is obliged to inaugurate the elected Village Head candidate in accordance with the provisions of the statutory regulations.
- 16. The provisions of Article 63 have 1 (one) paragraph added, namely paragraph (4) so that Article 63 reads as follows:

 Article 63
 - (1) The costs of selecting a Village Head are charged to the Regency Regional Revenue and Expenditure Budget.
 - (2) Village Head election costs as referred to in paragraph (1) are used to procure ballot papers, ballot boxes, other equipment, committee honorarium and inauguration costs.
 - (3) Assistance funds from the Village Revenue and Expenditure Budget for needs for voting.
 - (4) The interim election of Village heads through Village deliberations is charged to the Village Revenue and Expenditure Budget.
- 17. The provisions of paragraph (2) letters b and g are changed and between paragraph (3) and paragraph (4) of Article 71, 2 (two) paragraphs are inserted, namely paragraph (3a) and paragraph (3b), so that Article 71 reads as follows:

- (1) The Village Head resigns because:
 - a. die;
 - b. own request; or
 - c. dismissed.
- (2) The Village Head is dismissed as intended in paragraph (1) letter c because: a. end of term of

office; b. unable to carry out

- duties continuously or permanently absent continuously for 6 (six) months due to suffering from illness which results in both physical and mental, not functioning normally as proven by an authorized doctor's certificate and/or his/her whereabouts are unknown;
- c. no longer qualified as chief Village;
- d. violates prohibitions as Village head;

- e. a change in the status of a Village to a sub-district, a merger of 2 (two) or more Villages into 1 (one) new Village, or the abolition of a Village;
- f. not carrying out his obligations as head Village; and/or
- g. declared as a convict who is threatened with imprisonment for a minimum of 5 (five) years based on a court decision that has permanent legal force.
- (3) If the Village head resigns as intended in paragraph (1), the BPD leadership reports to the regent via the subdistrict head.
- (3a) The BPD leadership report to the regent as intended in paragraph (2) contains case material experienced by the Village head concerned.
- (3b) Based on the report from the BPD leadership as intended in paragraph (3a), the Regent conducts a study for the next process.
- (4) The dismissal of the Village head as intended in paragraph (3) is determined by a Regent's Decree.
- 18. The provisions of Article 82 are amended to read as follows following:

- (1) The current term of office of the Village Head remains in effect until the end of his term of office.
- (2) The term of office of the current Acting Village Head continues to carry out his duties until the elected Village Head is appointed as a result of direct election.
- (3) The election of the Village Head, which has not yet been completed, is carried out based on Sukoharjo Regency Regional Regulation Number 10 of 2015 concerning Village Heads as amended by Sukoharjo Regency Regional Regulation Number 8 of 2016 concerning Amendments to Sukoharjo Regency Regional Regulation Number 10 of 2016. 2015 concerning Village Heads and their implementing regulations.

Article II

This local regulation are applied at the date stated.

So that everyone is aware, this Regional Regulation is ordered to be promulgated by placing it in the Sukoharjo Regency Regional Gazette.

SECOND AMENDMENT TO THE REGIONAL REGULATIONS OF SUKOHARJO DISTRICT NUMBER 10 OF 2015 CONCERNING VILLAGE HEAD

I. GENERAL

That based on Minister of Home Affairs Regulation Number 65 of 2017 concerning Amendments to Minister of Home Affairs Regulation Number 112 of 2014 concerning Election of Village Heads and Minister of Home Affairs Regulation Number 66 of 2017 concerning Amendments to Minister of Home Affairs Regulation Number 82 of 2015 concerning Appointment and Dismissal of Heads Villages have provisions regarding the Election of Village Heads and the Appointment and Dismissal of Village Heads which are regulated in Sukoharjo Regency Regional Regulations Number 10 of 2015 concerning Village Heads as amended by Sukoharjo Regency Regional Regulations Number 8 of 2016 concerning Amendments to Sukoharjo Regency Regional Regulations Number 10 of 2015 regarding Village Heads needs to be deleted and changed, because it is not in accordance with Minister of Home Affairs Regulation Number 65 of 2017 concerning Amendments to Minister of Home Affairs Regulation Number 112 of 2014 concerning Election of Village Heads and Minister of Home Affairs Regulation Number 66 of 2017 concerning Amendments to Minister of Home Affairs Regulations State Number 82 of 2015 concerning the Appointment and Dismissal of Village Heads.

In connection with the above, it is necessary to stipulate the Sukoharjo Regency Regional Regulation concerning the Second Amendment to the Sukoharjo Regency Regional Regulation Number 10 of 2015 concerning Village Heads.

The substance that was changed relates to the Inter-Time Village Head Election, Elected Village Head Candidates who died, were permanently absent or resigned before the inauguration, Village Head Candidates who were designated as suspects, defendants and convicts, Civil Servants who were elected as Village Heads and Village Head provisions dismissed.
