REGENT SUKOHARJO,

Considering: a. that with the enactment of Law Number 28 of 2009 concerning
Regional Taxes and Regional Levies, the Regional Regulations
concerning the Provision of Part of the Proceeds of Regional
Taxes and Regional Levies to Villages need to be adjusted;

- b. that based on Law Number 6 of 2014 concerning Villages and the provisions of Article 97 paragraph (3)
 Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages as amended by Government Regulation Number 47 of 2015 concerning Amendments to Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages states the allocation of a portion of the proceeds from district taxes and levies to the Village is determined by a Regent's Regulation;
- c. that based on the considerations as intended in letters a and b, Sukoharjo Regency Regional Regulation Number 6 of 2003 concerning the Provision of Part of the Proceeds of Regional Taxes and Regional Retributions to Villages needs to be revoked; d. that based on the considerations as intended in

letters a, b and c, it is necessary to establish a Regional Regulation concerning Revocation

Sukoharjo Regency Regional Regulation Number 6 of 2003 concerning Providing Part of the Proceeds of Regional Taxes and Regional Retributions to Villages;

I. GENERAL

Whereas based on Law Number 6 of 2014 concerning Villages and the provisions of Article 97 paragraph (3) of Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages as amended by Government Regulation Number 47 of 2015 concerning Amendments to Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages states that the allocation of part of the proceeds from district regional taxes and levies to Villages is determined by Regent's Regulations and with the enactment of Law Number 28 of 2009 concerning Regional Taxes and Regional Levies then the Regional Regulations regarding Providing Part of the Proceeds from Regional Taxes and Regional Retributions to Villages need to be adjusted.

At this time Sukoharjo Regency Regional Regulation Number 6 of 2003 concerning Providing Part of the Proceeds of Regional Taxes and Regional Levies to Villages is no longer in accordance with higher laws and regulations so that Sukoharjo Regency Regional Regulation Number 6 of 2003 concerning Providing Part of the Proceeds of Regional Taxes and Retributions Areas for Villages need to be revoked.
