FORMATION OF VILLAGE LEGAL PRODUCTS

BY THE GRACE OF GOD ALMIGHTY

REGENT SUKOHARJO,

Considering: a. that the implementation of government in villages requires village legal products whose formation is carried out systemically and coordinated;

- b. that in preparing village legal products so that they are in accordance with legal principles and in accordance with applicable provisions and do not conflict with the public interest, it is necessary to provide technical guidelines for the formation of village legal products;
- c. that to implement the provisions in Government Regulation Number 43 of 2014 concerning Regulations for the Implementation of Law Number 6 of 2014 concerning Villages as amended by Government Regulation Number 47 of 2015 concerning Amendments to Government Regulation Number 43 of 2014 concerning Regulations for the Implementation of Law Number 6 of 2014 concerning Villages and Minister of Home Affairs Regulation Number 111 of 2014 concerning Technical Guidelines for Village Regulations, regulations regarding the formation of village legal products are required;
- d. that based on the considerations as intended in letter a, letter b and letter c need to specify Regional Regulations concerning the Establishment of Village Legal Products;

Bearing in mind: 1. Article 18 paragraph (6) of the 1945 Constitution of the Republic of Indonesia;

DECIDE:

To stipulate: REGIONAL REGULATIONS CONCERNING THE FORMATION OF VILLAGE LEGAL PRODUCTS.

PIG GENERAL REQUIREMENTS

article 1

In this Regional Regulation what is meant by: 1. Region is Sukoharjo Regency.

- 2. Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.
- 3. The Regent is the Regent of Sukoharjo.
- 4. The sub-district head is the leader and coordinator of government administration in the sub-district working area who, in implementation, obtains the delegationisotiagorement authority from the Regent to handle some regional autonomy affairs, and carry out general government tasks.
- 5. A village is a legal community unit that owns territorial boundaries that have the authority to regulate and manage government affairs, the interests of local communities based on community initiatives, rights of origin, and/or traditional rights that are recognized and respected in the government system of the Unitary State of the Republic of Indonesia.
- 6. Village Government is the administration of government affairs and the interests of local communities in the government system of the Unitary State of the Republic of Indonesia.
- 7. The Village Government is the Village Head assisted by the Village Apparatus as the organizing element of the Village Government.
- 8. Village Consultative Body, hereinafter abbreviated to BPD, is an institution that carries out government functions whose members are representatives of the village population based on regional representation and are determined democratically.
- Village regulations are regulations which include Village Regulations, Joint Village Head Regulations, Village Head Regulations and BPD Regulations.
- 10. Village Regulations are statutory regulations stipulated by the Village Head after being discussed and agreed upon with the BPD.
- 11. Joint Village Head Regulations are regulations that determined by two or more Village Heads and is regulatory in nature.
- 12. Village Head Regulations are established regulations by the Village Head and is regulatory in nature.
- 13. BPD regulations are regulations stipulated by the BPD and are regulatory in nature.
- 14. The Village Head's decision is a concrete, individual and final determination.

- 15. A BPD decision is a decision signed by the BPD chairman based on the results of BPD deliberations.
- 16. Evaluation is the study and assessment of draft Village Regulations to determine if they conflict with the public interest and/or higher laws and regulations.
- 17. Invitation is the placement of regulations in the village in the Village Gazette or Village News.
- 18. Clarification is the study and assessment of Village regulations to find out whether they conflict with the public interest, and/or higher laws and regulations.
- 19. Contrary to the public interest are policies that disrupt harmony between citizens community, disruption of access to public services, disruption of peace and public order, disruption of economic activities to improve community welfare and/or discrimination against ethnicity, religion and belief, race, inter-group and gender.
- 20. Village Revenue and Expenditure Budget, hereinafter referred to as Village APB, is the annual financial plan of the village government.
- 21. Village legal products are legal products in the form of regulations including Village Regulations, Village Head Regulations, Joint Village Head Regulations, BPD Regulations and in the form of decisions including Village Head Decrees and BPD Decrees.
- 22. Day is a working day.

CHAPTER II PRINCIPLES OF FORMATION

Section 2

In forming village legal products it must be based on The principles of forming good laws and regulations include:

- a. clarity of purpose;
- b. appropriate institutions or forming organs;
- c. suitability between type and material of cargo;
- d. can be implemented;
- e. usefulness and usefulness; f. clarity
- of formulation; and g.

openness.

CHAPTER III

TYPES AND CONTENT MATERIALS OF VILLAGE LEGAL PRODUCTS

Part One

Types of Village Legal Products

Article 3

- (1) Village legal products are:
 - a. arrange; And
 - b. set.
- (2) The types of Village legal products that are regulatory in nature as intended in paragraph (1) letter a consist of:
 - a. Village Regulations;
 - b. Joint Village Head Regulations;
 - c. Village Head Regulation; And
 - d. BPD regulations.
- (3) The types of Village legal products that are stipulating as intended in paragraph (1) letter b consist of:
 - a. Village Head's Decision; And
 - b. BPD decision.

Article 4

(1) Village Legal Products as intended in Article 3 prohibited in conflict with: a.

public interest; and/or

- b. more statutory provisions high level.
- (2) Village Legal Products which are regulatory in nature as intended in Article 3 paragraph (2), regulate matters which fall under the authority of the Village Government.

The second part Regulatory Content Material

- (1) The Village Regulations as intended in Article 3 paragraph (2) letter a contain material on the implementation of village authority and further elaboration of higher statutory regulations.
- (2) Joint Village Head Regulations as intended in Article 3 paragraph (2) letter b contain village cooperation material.

- (3) Village Head Regulations as intended in Article 3 paragraph (2) letter c contain material on the implementation of village regulations, joint regulations with village heads and follow-up to higher statutory regulations.
- (4) The BPD regulations as intended in Article 3 paragraph (2) letter d contain material on the implementation of the functions, duties and authority as well as the rights and obligations of the BPD.

CHAPTER IV

VILLAGE REGULATIONS

Part One Planning

Article

- 6 (1) Planning for drafting Village Regulations is determined by the Village Head and BPD in the Village Government Work Plan.
- (2) Community institutions can provide input to the Village Government and/or BPD for plans for drafting Village Regulations.

The second part Drafting

Paragraph 1 Preparation of Village Regulations by the Village Head

- (1) The preparation of draft Village Regulations is initiated by the Village Government.
- (2) The Draft Village Regulation that has been prepared must be consulted with the village community and can be consulted with the Subdistrict Head to obtain input.
- (3) The draft Village Regulations that are consulted as intended in paragraph (2) are prioritized to the community or community groups that are directly related to the substance of the regulatory material.
- (4) Input from the village community and sub-district head as intended in paragraph (2) is used by the Village Government to follow up the process of drafting Village Regulations.
- (5) Draft Village Regulations that have been consulted as intended in paragraph (3) is submitted by the Village Head to the BPD for mutual discussion and agreement.

Paragraph 2 Preparation of Village Regulations by BPD

Article

- 8 (1) BPD can prepare and propose draft Village Regulations.
- (2) Draft Village Regulations as intended in paragraph (1) except for draft Village Regulations concerning Village Medium Term Development Plans, draft Village Regulations concerning Village Government Work Plans, draft Village Regulations concerning Village APB, draft Village Regulations concerning Changes to Village APB and on Village Regulations concerning Draft Reports Accountability for the Realization of Implementation of Village APB.
- (3) The draft Village Regulation as intended in paragraph (1) can be proposed by BPD members to the BPD leadership to be determined as a draft Village Regulation proposed by the BPD.

Part Three Discussion

Article 9

- (1) BPD invites the Village Head to discuss and approve the draft Village Regulation.
- (2) In the event that there is a draft Village Regulation initiated by the Village Government and a BPD proposal regarding the same matter to be discussed at the same discussion time, then the draft Village Regulation proposed by the BPD takes precedence while the Draft Village Regulation proposed by the Village Head is used as material for comparison.

Article 10

- (1) Draft Village Regulations that have not been discussed can be withdrawn by the proposer.
- (2) Draft Village Regulations that have been discussed cannot be withdrawn except by mutual agreement between the Village Government and the BPD.

Part Four

Determination

Article

11 (1) The Draft Village Regulation that has been mutually agreed upon is submitted by the BPD leadership to the Village Head to be adopted as a Village Regulation no later than 7 (seven) days from the date of agreement.

(2) The draft Village Regulation as intended in paragraph (1) must be stipulated by the Village head by affixing his signature no later than 15 (fifteen) days from the receipt of the draft Village Regulation from the BPD leadership.

Part Five Invitation

Article

- 12 (1) Draft Village Regulations which have been signed are submitted to the Village Secretary for promulgation.
- (2) In the event that the Village Head does not sign the Draft Village Regulation as intended in paragraph (1), the Draft Village Regulation must be promulgated.

Article

- 13 (1) The Village Secretary promulgates Village Regulations in the Village Gazette.
- (2) Village Regulations are declared to come into force and have binding legal force from the time they are promulgated.

Part Six Dissemination

Article

- 14 (1) Dissemination is carried out by the Village Government and BPD from the time of determining the plan for drafting Village Regulations, drafting Village Regulations, discussing Draft Village Regulations, until promulgating Village Regulations.
- (2) The dissemination as intended in paragraph (1) is carried out to provide information and/or obtain input from the public and stakeholders.

CHAPTER V

EVALUATION AND CLARIFICATION OF VILLAGE REGULATIONS

Part One Evaluation

Article

15 (1) Draft Village Regulations regarding Village APB, changes to Village APB, levies, spatial planning and organization of Village Government which have been discussed and agreed upon by the Village Head and BPD, shall be submitted by the Village Head to the Regent through the Subdistrict Head no later than 3 (three) days from when it was agreed to be evaluated.

(2) Results of evaluation of draft Village Regulations as follows referred to in paragraph (1) shall be submitted by the Regent no later than 20 (twenty) days from the Regent's receipt of the draft Village Regulation.

Article

- 16 (1) In the event that the Regent does not provide the evaluation results within the 20 (twenty) day time limit, the Village Regulation applies automatically.
- (2) In the event that the Regent has provided the evaluation results as intended in Article 15 paragraph (2) Head
 The village is obliged to fix it.

Article

- 17 (1) The Village Head shall amend the draft Village Regulation as intended in Article 16 paragraph (2) no later than 20 (twenty) days after receiving the evaluation results.
- (2) The Village Head may invite the BPD to improve the draft Village Regulations as intended in paragraph (1).
- (3) The results of corrections and follow-up are conveyed by the Village Head to the Regent via the sub-district head.

Article

18 In the event that the Village Head does not follow up on the evaluation results as intended in Article 17 paragraph (1), and still stipulates it as a Village Regulation, the Regent cancels the Village Regulation with a Regent's Decree.

Article

- 19 (1) The Regent can form an Evaluation Team for Draft Village Regulations.
- (2) The team as intended in paragraph (1) is determined by a Regent's Decree.

The second part Clarification

- 20 (1) Village regulations that have been promulgated as intended in Article 13 are submitted by the Village Head to the Regent no later than 7 (seven) days after promulgation for clarification.
- (2) The Regent will clarify Village Regulations by forming a clarification team no later than 30 (thirty) days from receipt.

Article 21

- (1) The results of the clarification as intended in Article 20 paragraph (1) may be in the form of:
 - a. clarification results that are in accordance with the public interest, and/or the provisions of higher laws and regulations;
 Δnd
 - b. clarification results that conflict with the public interest and/or the provisions of higher laws and regulations.
- (2) In the event that the results of the clarification as intended in paragraph (1) of the Village Regulations do not conflict with the public interest, and/or the provisions of higher laws and regulations, the Regent issues a letter of clarification results containing the appropriate clarification results.
- (3) In the event that the results of the clarification as intended in paragraph (1) conflict with the public interest, and/or the provisions of higher laws and regulations, the Regent cancels the Village Regulation with a Regent's Decree.

CHAPTER VI

JOINT REGULATIONS WITH THE VILLAGE HEAD

Part One

Article

- 22 (1) Planning for drafting a Joint Village Head Regulation is determined jointly by two Village Heads or more in the context of inter-Village cooperation.
- (2) The planning for drafting the Joint Village Head Regulation as intended in paragraph (1) is determined after receiving recommendations from the village deliberation.

The second part Drafting

Article

23 The draft Village Head Joint Regulation is carried out by the initiating Village Head.

- 24 (1) The Draft Village Head Joint Regulation that has been prepared must be consulted with the respective village community and can be consulted with the respective Subdistrict Head to obtain input.
- (2) Input from the village community and sub-district head as intended in paragraph (1) is used by the Village Head to follow up on the process of drafting a joint Village Head Regulation.

Part Three Discussion, Determination and Invitation

Article

25 Discussion of the draft Joint Village Head Regulation is carried out by 2 (two) or more Village Heads.

Article

- 26 (1) The Village Head who carries out inter-village cooperation shall stipulate a Joint Village Head Regulation Draft by affixing his signature no later than 7 (seven) days from the agreed date.
- (2) Draft Village Head Joint Regulations which have been signed as intended in paragraph (1) are promulgated in the Village News by the Village Secretary of each village.
- (3) The Joint Village Head Regulation as referred to in paragraph (1) comes into force and has binding legal force from the date it is promulgated in the Village News in each Village.

Part Four Dissemination

Article

27 Joint Village Head Regulations shall be disseminated to each village community.

CHAPTER VII

VILLAGE HEAD REGULATIONS

Article

- 28 (1) The draft Village Head Regulation is prepared by the Village Head.
- (2) The content of the Village Head Regulation includes material implementation of Village Regulations and higher laws and regulations.

Article

29 Village Head Regulations are promulgated in the Village News by the Village Secretary.

CHAPTER VIII

BPD REGULATIONS

- 30 (1) The draft BPD Regulations are prepared by the BPD Leadership.
- (2) The content of the BPD Regulations includes material on the implementation of functions, duties and authority as well as the rights and obligations of the BPD.

Article 31

BPD regulations are promulgated in the Village News by the Village Secretary.

CHAPTER IX

DECISION OF THE VILLAGE HEAD

Article 32

The Village Head can stipulate a Village Head Decree for the implementation of village regulations, higher laws and regulations and in the context of implementing village authority that is in the nature of determination.

CHAPTER X

BPD DECISION

Article 33

- (1) The BPD decision is in the form of a determination to determine the results of the BPD deliberations in order to carry out the duties and functions of the BPD.
- (2) The BPD decision as intended in paragraph (1) contains material resulting from the BPD deliberations.

CHAPTER XI

DRAWING TECHNIQUES

Article 34

- (1) Provisions regarding techniques for preparing village legal products in accordance with the provisions of the Law concerning the Formation of Legislative Regulations.
- (2) Further technical provisions regarding procedures for preparing village legal products are regulated in the Regulations Regent.

Article 35

Provisions regarding the form of village legal products are listed in the Appendix which is an inseparable part of this Regional Regulation.

CHAPTER XII

FINANCING

Article 36

Funding for the formation of village legal products is charged at the Village APB.

CHAPTER XIII

TRANSITIONAL PROVISIONS

Article 37

When this regional regulation comes into effect, all Implementing regulations relating to the formation of village legal products are declared to remain valid as long as they have not been replaced and do not conflict with the provisions of this regional regulation.

CHAPTER XIV

CLOSING

Article 38

At the time this Regional Regulation came into force, Sukoharjo Regency Regional Regulation Number 12 of 2007 concerning Guidelines for Formation and Mechanisms for Preparing Village Regulations (Sukoharjo Regency Regional Gazette 2007 Number 8, Additional Regional Gazette of Sukoharjo Regency Number 139), is revoked and declared invalid.

Article 39

This local regulation are applied at the date stated.

FORMATION OF VILLAGE LEGAL PRODUCTS

I. GENERAL

Based on Law Number 6 of 2014 concerning Villages, Villages are villages and traditional villages or referred to by other names, hereinafter referred to as Villages, are legal community units that have territorial boundaries and are authorized to regulate and manage government affairs and the interests of local communities based on initiative. community, origin rights, and/or traditional rights recognized and respected in the government system of the Unitary State of the Republic of Indonesia. Viewed from a public law perspective, the village has the authority to regulate and manage the interests of the local community and this has implications for the village's authority to determine village legal products.

The Village Government needs law as an instrument to carry out government in the Village. Law in the sense of policy instruments is in the form of legal products, both regulatory and stipulation in nature. To support the realization of the formation of village legal products in a systemic and coordinated manner, guidelines for the formation of village legal products are needed.

Village legal products that are regulatory in nature are Village Regulations, Joint Village Head Regulations, Village Head Regulations and BPD Regulations. Meanwhile, Village legal products that are stipulations are Village Head Decrees and BPD Decrees. Village Regulations are stipulated by the Village Head after being discussed and agreed upon with the BPD as a legal and policy framework for implementing Village Government and Village Development.

The stipulation of Village Regulations is an elaboration of the various authorities possessed by the Village referring to the provisions of higher laws and regulations. As a legal product, Village Regulations must not conflict with higher regulations and must not harm the public interest, namely:

- a. disruption of harmony between community members;
- b. disruption of access to public services;
- c. disruption of peace and public order;
- d. disruption of economic activities to improve the welfare of Village communities;

 And
- e. discrimination against ethnicity, religion and belief, race, between class, and gender.

Village regulations are processed democratically and participatively, that is, the drafting process includes the participation of the Village community. The Village Community has the right to propose or provide input to the Village Head and BPD in the process of drafting Village Regulations.

Joint Village Head Regulations are regulations stipulated by two or more Village Heads and are regulatory in nature. Joint Village Head Regulations are needed as a legal basis for inter-Village cooperation. Meanwhile, Village Head Regulations are regulators stipulated by the Village Head and are regulatory in nature. The content of Village Head Regulations includes material on the implementation of Village Regulations and higher statutory regulations.

The Village Head can stipulate a Village Head Decree for the implementation of village regulations, higher laws and regulations and in the context of implementing village authority that is in the nature of determination. The Village Head's decision is a concrete, individual and final determination.

BPD decisions take the form of determinations to determine the results of BPD deliberations in order to carry out BPD duties and functions.

The BPD decision contains material resulting from the BPD deliberations.

a What is meant by "principle of clarity of purpose" is that every formation of a village legal product must have a clear purpose to be achieved.

Letter b

What is meant by "appropriate institutional principles or forming organs" is that every type of village legal product must be made by an institution/ official who forms authorized legal regulations. These laws and regulations can be canceled or null and void by law, if they are made by institutions/ officials who are not authorized.

Letter c

What is meant by "principle of suitability between content type and material" is that in the formation of village legal products, one must really pay attention to the appropriate content material for the type of statutory regulations.

Letter d

What is meant by "principle of implementation" is that every village legal product created must take into account the effectiveness of these laws and regulations in society, both philosophically, juridically and sociologically.

Letter e

What is meant by "principle of efficacy and usefulness" is that every legal product must be created because it is truly needed and useful in regulating the life of society, nation and state.

Letter f

What is meant by "principle of clarity of formulation" is that every village legal product must meet the technical requirements for the preparation of statutory regulations, systematics and choice of words or terminology, as well as the legal language being clear and easy to understand, so as not to give rise to various kinds of interpretations in its implementation.

Letter g

What is meant by "principle of openness" is that the process of forming village legal products starting from planning, preparation, drafting and discussion is transparent and open. In this way, all levels of society have the widest possible opportunity to provide input in the process of making village legal products.
