REGENT SUKOHARJO,

- Considering:**
- a. that with the enactment of Law Number 23 of 2014 concerning Regional Government as amended several times, most recently by Law Number 9 of 2015 concerning the Second Amendment to Law Number 23 of 2014 concerning Regional Government, energy and mineral resources have become the authority of the Government Central and Provincial Government;**
 - b. that in order to follow up on the Decree of the Governor of Central Java Number: 180/108 of 2016 concerning the Cancellation of the Regional Regulation of Sukoharjo Regency dictum FIRST number 5, then the Regional Regulation of Sukoharjo Regency Number 18 of 2011 concerning Mining of Non-Metal Minerals and Rocks needs to be revoked;**
 - c. that based on the considerations as intended in letters a and b, it is necessary to stipulate a Regional Regulation concerning the Revocation of Sukoharjo Regency Regional Regulation Number 18 of 2011 concerning Non-Metal Mineral and Rock Mining;**

**REVOCACTION OF SUKOHARJO DISTRICT REGIONAL REGULATION NUMBER
18 OF 2011 CONCERNING NON-METAL MINERAL MINING
AND ROCKS**

I. GENERAL.

Sukoharjo Regency Regional Regulation Number 18 of 2011 concerning Non-Metal Mineral and Rock Mining, is no longer appropriate and contradicts Attachment to Roman I letter CC number 2 of Law Number 23 of 2014 concerning Regional Government as amended several times, most recently by Law Number 9 of 2015 concerning the Second Amendment to Law Number 23 of 2014 concerning Regional Government.

Inconsistency with Law Number 23 of 2014 concerning Regional Government as amended several times, most recently with Law Number 9 of 2015 concerning the Second Amendment to Law Number 23 of 2014 concerning Regional Government which regulates that Regency/City Regional Governments do not have the authority affairs in the energy and mineral resources sector.

Based on the considerations above, the Regional Government of Sukoharjo Regency is following up on Law Number 23 of 2014 concerning Regional Government as amended several times, most recently with Law Number 9 of 2015 concerning the Second Amendment to Law Number 23 of 2014 concerning Regional Government which regulates Mining of Non-Metal Minerals and Rocks, so that Sukoharjo Regency Regional Regulation Number 18 of 2011 concerning Mining of Non-Metal Minerals and Rocks, is revoked and declared invalid.
