GENERAL REQUIREMENTS**

**article 1**

**In this Regional Regulation what is meant by:**

- 1. Region is Sukoharjo Regency.**
- 2. Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.**
- 3. The Regent is the Regent of Sukoharjo.**
- 4. Sub-district is the work area of the sub-district head as an apparatus Regency Area.**
- 5. A village is a legal community unit that owns territorial boundaries that have the authority to regulate and manage government affairs, the interests of local communities based on community initiatives, rights of origin, and/or traditional rights that are recognized and respected in the government system of the Unitary State of the Republic of Indonesia.**

**I. GENERAL**

**Law Number 13 of 1950 concerning the Establishment of District Areas within the Province of Central Java stipulates that districts are autonomous regions in Central Java Province. Sukoharjo Regency is one of the regencies in Central Java Province.**

**Sukoharjo Regency administratively consists of 12 (twelve) sub-districts, 17 (seventeen) sub-districts and 150 (one hundred and fifty) villages spread across 11 (eleven) sub-districts.**

**Based on the provisions of Article 116 paragraph (2) of Law Number 6 of 2014 concerning Villages and the provisions of Article 29 paragraph (3) of Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages as amended by Government Regulation Number 47 2015 concerning Amendments to Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages, the villages that currently exist in Sukoharjo Regency need to be stipulated in Regional Regulations.**
