**REGENT SUKOHARJO,**

- Considering:**
- a. that based on the provisions of Article 39 of Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages as amended by Government Regulation Number 47 of 2015 concerning Amendments to Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 2014 concerning Villages, stated that the determination of Village authority is regulated by Ministerial Regulations that administer government affairs in the field of domestic government;**
  - b. that based on the provisions of Article 21 and Article 22 of the Minister of Home Affairs Regulation Number 44 of 2016 concerning Village Authorities, it is mandated that regulations regarding Village Authorities be regulated by Regent Regulations;**
  - c. that based on the considerations as intended in letters a and b, Sukoharjo Regency Regional Regulation Number 11 of 2015 concerning Village Authority needs to be revoked;**
  - d. that based on the considerations as intended in letters a, b and c, it is necessary to stipulate a Regional Regulation concerning the Revocation of Sukoharjo Regency Regional Regulation Number 11 of 2015 concerning Village Authority;**

**I. GENERAL.**

Sukoharjo Regency Regional Regulation Number 11 of 2015 concerning Village Authority is prepared based on the Regulation of the Minister of Villages, Development of Disadvantaged Regions and Transmigration Number 1 of 2015 concerning Guidelines for Authority Based on Origin Rights and Village-Scale Local Authority, is no longer appropriate and contrary to statutory regulations , namely: a. Government Regulation Number 43 of 2014 concerning

Implementing Regulations of Law Number 6 of 2014 concerning Villages as amended by Government Regulation Number 47 of 2015 concerning Amendments to Government Regulation Number 43 of 2014 concerning Implementing Regulations of Law Number 6 of 2014 concerning Villages, Article 39 states that the Determination of Village Authority is regulated by a Ministerial Regulation which administers government affairs in the field of domestic government; And

b. Minister of Home Affairs Regulation Number 44 of 2016 concerning Village Authorities in Article 21 and Article 22 regulates that the list of Village authorities based on rights of origin and local village-scale authority is determined by the Regent with a Regent's Regulation.

The non-conformity referred to includes, among other things, several regulations regarding:

1. Determination of village authority is regulated by ministerial regulations that administer government affairs in the field of domestic government; And
2. Regulations regarding village authority which are currently regulated by Regional Regulations, based on the provisions of statutory regulations are mandated to be regulated in Regent Regulations.

Based on the considerations mentioned above, in order for the Regional Government to follow up on the provisions governing village authority in accordance with statutory regulations, Sukoharjo Regency Regional Regulation Number 11 of 2015 concerning Village Authority must be revoked and declared invalid.
