DECIDE:

To enact: REGIONAL REGULATIONS CONCERNING THE FINANCIAL AND ADMINISTRATIVE RIGHTS OF LEADERS AND MEMBERS OF THE REGIONAL REPRESENTATIVE COUNCIL.

PIG GENERAL REQUIREMENTS

article 1

In this Regional Regulation what is meant by:

- 1. The region is Sukoharjo Regency.
- 2. Regional Government is the Regent as an element of regional government administrators who leads the implementation of government affairs which fall under the authority of the autonomous region.
- 3. The Regent is the Regent of Sukoharjo.
- 4. The Regional People's Representative Council, hereinafter abbreviated as DPRD, is a regional people's representative institution whose position is as an element of regional government administration.
- 5. DPRD leadership is a regional official who holds the positions of Chair and Deputy Chair of the Sukoharjo Regency DPRD in accordance with the provisions of statutory regulations.
- 6. DPRD members are regional officials who hold the position of Member of the Sukoharjo Regency DPRD in accordance with the provisions of statutory regulations.
- 7. The DPRD Secretariat is a supporting element in implementing the functions, duties and authority of the DPRD as intended in Law Number 23 of 2014 concerning Regional Government as amended several times, most recently by Law Number 9 of 2015 concerning the Second Amendment to Law Number 23 of 2015. 2014 concerning Regional Government.
- 8. The DPRD Secretary is a Regional Apparatus Official leads the DPRD Secretariat.
- 9. Expert Group or Expert Team is a group of people who have the ability in certain scientific disciplines to assist the DPRD's duties and authority.
- 10. A Fraction Expert is someone who has the ability in a particular scientific discipline to assist in carrying out the faction's duties.
- 11. A State House is a building owned by the Regional Government and functions as a residence or residence and as a means of family development and to support the implementation of official duties.

CHAPTER II

INCOME OF DPRD LEADERS AND MEMBERS

Part One Income of DPRD Leaders and Members

Section 2

- (1) The income of DPRD Leaders and Members consists of income whose tax is charged to:
 - a. APBD, including:
 - 1. representation

money; 2. family

allowance; 3. rice

allowance; 4. package money;

- 5. position allowance;
- 6. fittings allowance; And
- 7. allowance for other fittings.
- b. The leaders and members of the DPRD concerned include:
 - 1. intensive communication allowance; And
 - 2. recess allowance.
- (2) The imposition of income tax on DPRD Leaders and Members as intended in paragraph (1) letters a and b is carried out in accordance with the provisions of statutory regulations.

- (1) Representation money as intended in Article 2 paragraph (1) letter a number 1 is given every month to the Leadership and Members of the DPRD.
- (2) The DPRD Chairman's Representation Fee is equivalent to the basic salary Regent.
- (3) Representation money for the Deputy Chairman of the DPRD is 80% (eighty percent) of the representation money for the Chairman of the DPRD.
- (4) Representation money for DPRD members is 75% (seventy five percent) of the representation money for the DPRD chairman.

- (1) Family allowances and rice allowances as intended in Article 2 paragraph (1) letter a number 2 and number 3 are given every month to the Leadership and Members of the DPRD.
- (2) Family allowances and rice allowances for DPRD Leaders and Members are the same as family allowances and rice allowances for state civil servants in accordance with the provisions of statutory regulations.

Article 5

The package money as intended in Article 2 paragraph (1) letter a number 4 is given every month to the Leaders and DPRD members 10% (ten percent) of the relevant Representation Money.

Article 6

The position allowance as intended in Article 2 paragraph (1) letter a number 5 is given every month to DPRD Leaders and Members in the amount of 145% (one hundred and forty five percent) of the relevant representation money.

Article 7

- (1) Equipment allowances and other equipment allowances as intended in Article 2 paragraph (1) letter a number 6 and number 7 are given every month to the Leadership and Members of the DPRD who sit in the Deliberative Body, Commission, Budget Body, Regional Regulation Formation Body, Honorary Board, or other equipment.
- (2) Equipment allowances and other equipment allowances as intended in paragraph (1) are provided with the following conditions:
 - a. chairman, 7.5% (seven point five percent);
 - b. deputy chairman, 5% (five percent);
 - c. secretary, by 4% (four percent); And
 - d. members, 3% (three percent);

from the allowance for the position of Chairman of the DPRD.

(3) Allowance for other equipment as intended in paragraph (1) and paragraph (2) is given as long as the other equipment is formed and carrying out its duties.

- (4) In the event that other equipment carries out the tasks as intended in paragraph (3) for less than 1 (one) month, 1 (one) month is taken into account.
- (5) Carrying out the tasks as intended in paragraph (3) begins when determining other equipment and ending with providing a report on the results of the implementation of the tasks.

- (1) The Intensive Communication Allowance as intended in Article 2 paragraph (1) letter b number 1 is given every month to improve performance to DPRD Leaders and Members.
- (2) The recess allowance as referred to in Article 2 paragraph (1) letter b number 2 is given every time a recess is held to the Leadership and Members of the DPRD.
- (3) Intensive communication allowances and recess allowances are given in accordance with the Regional financial capacity.
- (4) Regional financial capacity as referred to in paragraph (3) is determined based on the results of calculations of the amount of regional general income minus expenditure for state civil servant employees and grouped into 3 (three) groups, namely:

a. tall; b.
currently; And
c. low.

(5) Further provisions regarding the grouping of Regional financial capabilities in the current/relevant budget year as intended in paragraph (4) are implemented in accordance with the provisions of statutory regulations.

- (1) In the case of high Regional financial capacity as intended in Article 8 paragraph (4) letter a, Intensive Communication Allowance and recess allowance for DPRD leaders and members are given a maximum of 7 (seven) times the DPRD Chair's Representation Money.
- (2) In the event that the Regional financial capacity is moderate as intended in Article 8 paragraph (4) letter b, Intensive Communication Allowance and recess allowance for DPRD leaders and members are given a maximum of 5 (five) times the DPRD Chair's Representation Money.
- (3) In the event that the Regional financial capacity is low as intended in Article 8 paragraph (4) letter c, Intensive Communication Allowance and recess allowance for DPRD Leaders and Members are given a maximum of 3 (three) times the DPRD Chair's Representation Money.

The second part Welfare Benefits for DPRD Leaders and Members

Article 10

- (1) The welfare benefits of DPRD Leaders and Members consist of:
 - a. health insurance;
 - b. accident insurance;
 - c. life insurance; And
 - d. official clothing and attributes.
- (2) Apart from the welfare benefits as intended in paragraph (1), the DPRD leadership is provided with welfare benefits in the form of: a. State House

and its equipment; b. official official vehicle; and c. household shopping.

- (3) Apart from the welfare benefits as intended in paragraph (1), DPRD members are provided with welfare benefits in the form of:
 - a. State House and its equipment; And
 - b. transportation allowance.

- (1) Health insurance as intended in Article 10 paragraph (1) letter a is provided in the form of contributions to the Health Social Security Administering Body in accordance with the provisions of statutory regulations.
- (2) Health insurance as referred to in paragraph (1) also includes wife/husband and children in accordance with the provisions of statutory regulations.
- (3) In addition to health insurance as intended in paragraph (1), DPRD Leaders and Members are provided with a health examination which aims to determine health status outside the scope of health services provided by the Health Social Security Administering Body.
- (4) The health examination as intended in paragraph (3) is carried out 1 (one) time in 1 (one) year and is carried out within the country and does not include wives/husbands and children.

Work accident insurance and death insurance as intended in Article 10 paragraph (1) letter b and letter c are provided in the form of contributions to the Employment Social Security Administering Body in accordance with the provisions of statutory regulations.

Article 13

- (1) Official clothing and attributes of DPRD Leaders and Members as intended in Article 10 paragraph (1) letter d consist of:
 - a. 2 (two) pairs of daily civilian clothing are provided in 1 (one) year;
 - b. 1 (one) pair of official civilian clothing is provided in 1 (one) year;
 - c. complete civilian clothing provided in 2 (two) pairs within 5 (five) years;
 - d. 1 (one) pair of long-sleeved daily service clothing is provided in 1 (one) year; And
 - e. Clothes with regional characteristics are provided 1 (one) pair in 1 (one) year.
- (2) Official clothing and attributes as intended in paragraph (1) are provided by considering the principles of efficiency, effectiveness and propriety.
- (3) Provisions regarding unit price standards for official clothing and attributes as intended in paragraph (1) are regulated by Regent's Regulations.

- (1) The state house and its equipment as well as office official vehicles as intended in Article 10 paragraph (2) letters a and b are provided to the DPRD leadership in accordance with standards based on the provisions of statutory regulations.
- (2) State houses and their equipment as intended in Article 10 paragraph (3) letter a can be provided to DPRD Members according to standards based on the provisions of statutory regulations.
- (3) The use of the State House and its equipment as well as official official vehicles as intended in paragraph (1) and the use of the State House and its equipment as intended in paragraph (2) is carried out in accordance with the provisions of statutory regulations.

- (4) Maintenance of the State House and its equipment as well as office official vehicles as intended in paragraph (1) and maintenance of the State House and its equipment as intended in paragraph (2) is borne by the APBD.
- (5) In the event that the leadership of the DPRD resigns or ends their term of service, the state house and its equipment as well as official vehicles must be returned in good condition to the Regional Government no later than 1 (one) month from the date of cessation or end of the term of service.
- (6) In the event that a DPRD Member who is provided with a state house and equipment stops or ends his term of service, the state house and its equipment must be returned in good condition to the Regional Government no later than 1 (one) month from the date of termination or end of the service period.
- (7) Further provisions regarding the procedures for returning state houses and their equipment as well as office official vehicles are implemented in accordance with the provisions of statutory regulations.

- (1) The State House and its equipment as well as official official vehicles provided as intended in Article 14 cannot be rented, used, transferred, and/or have their legal status changed.
- (2) The structure and shape of the State House building provided as intended in paragraph (1) cannot be changed.

- (1) In the event that the Regional Government has not been able to provide a state house and official vehicle for the DPRD Leader as intended in Article 14, the person concerned is given a housing allowance and a transportation allowance.
- (2) In the event that the Regional Government has not been able to provide state housing for DPRD Members as intended in Article 14, the person concerned may be given a housing allowance.
- (3) Housing allowances and transportation allowances for DPRD leaders as referred to in paragraph (1) are given in the form of money and paid every month starting from the date of taking the oath/promise.

- (4) Housing allowance as intended in paragraph (2) and transportation allowance for DPRD Members as intended in Article 10 paragraph (3) letter b are given in the form of money and paid every month starting from the date of taking the oath/promise.
- (5) Husbands and/or wives who hold positions as Leaders and/or DPRD Members in the same DPRD are only given one housing allowance.
- (6) Leaders and DPRD members whose husband or wife serves as regional head/deputy regional head in the same region are not given a housing allowance.
- (7) Leaders and/or DPRD members who are temporarily dismissed are not given housing allowances and transportation allowances.

The State House and its equipment as well as official official vehicles as intended in Article 14 as well as housing allowances and transportation allowances as intended in Article 16 cannot be given to the Leadership and Members of the DPRD simultaneously.

- (1) The amount of housing allowance as intended in Article 16 must take into account the principles of decency, reasonableness, rationality, applicable local price standards, and state building and house land area standards in accordance with the provisions of statutory regulations.
- (2) The amount of transportation allowance as intended in Article 16 must take into account the principles of decency, reasonableness, rationality, applicable local price standards in accordance with the provisions of statutory regulations.
- (3) The amount of housing allowance paid must be in accordance with the standard house rental unit price that applies to state housing standards for DPRD Leaders and Members, excluding furniture, electricity, water, gas and telephone expenses.
- (4) The amount of the transportation allowance paid must be in accordance with the vehicle rental unit price standards that apply to office service vehicle standards for DPRD Leaders and Members, excluding maintenance costs and operational costs for office service vehicles.

- (5) The amount of the housing allowance and transportation allowance for DPRD Leaders and Members may not exceed the amount of the housing allowance and transportation allowance for the Leaders and Members of the DPRD of Central Java Province.
- (6) Further provisions regarding the amount of housing allowance and transportation allowance are regulated in a Regent's Regulation.

- (1) Household expenditure as intended in Article 10 paragraph (2) letter c is provided to support the implementation of the functions, duties and authority of the DPRD leadership.
- (2) Household expenditure as intended in paragraph (1) is used to meet minimum household needs by considering the Regional financial capacity.
- (3) The minimum household needs of DPRD Leaders as referred to in paragraph (2) are budgeted for in the programs and activities of the DPRD Secretariat.
- (4) Provisions regarding minimum household needs standards as referred to in paragraph (3) are regulated by a Regent's Regulation.
- (5) In the event that the DPRD leadership does not use the state house facilities and equipment, household expenditure as intended in Article 10 paragraph (2) letter c is not provided.

Part Three Service Fees for Leaders and DPRD Members

- (1) Leaders or DPRD members who die or end their term of service are given service fees.
- (2) The amount of service fees as referred to in paragraph (1) is adjusted to the period of service of the DPRD Leaders and Members, with the following provisions:
 - a. service period of less than or up to 1 (one) year, service fee of 1 (one) month's representation fee is given;
 - b. service period of up to 2 (two) years, given a service fee of 2 (two) months of representation fee;
 - c. service period of up to 3 (three) years, given a service fee of 3 (three) months' representation fee;

- d. service period of up to 4 (four) years, given service fees of 4 (four) months representation fee; And
- e. service period of up to 5 (five) years, given service fees of 5 (five) months or a maximum of 6 (six) months of representation fees.
- (3) In the event that the Leader or Member of the DPRD dies, the service fee as referred to in paragraph (2) is given to his heirs.
- (4) Payment of service fees is made after the person concerned has been honorably discharged in accordance with the provisions of the laws and regulations.
- (5) In the event that the Leaders and Members of the DPRD are dishonorably dismissed, they will not be given service fees.

CHAPTER III

SPENDING TO SUPPORT DPRD ACTIVITIES

Article 21

(1) Expenditures supporting DPRD activities are provided to support the smooth functioning, duties and authority of DPRD in the form of: a.

program, which consists of: 1.

holding meetings;

- 2. work visit;
- 3. reviewing, examining and preparing regional regulations;
- 4. increasing the capacity and professionalism of human resources within the DPRD;
- 5. coordination and consultation of government activities and society; And
- 6. other programs in accordance with the functions, duties and authority of the DPRD;
- b. DPRD Leadership operational funds;
- c. formation of an expert group or expert team for DPRD equipment; d.

provision of faction experts; and e.

faction secretariat shopping.

(2) Expenditures to support activities as intended in paragraph (1) are prepared based on work plans determined in accordance with the provisions of statutory regulations.

The program as intended in Article 21 paragraph (1) letter a is described into several activities in accordance with the provisions of statutory regulations.

Article 23

- (1) DPRD Leadership operational funds as intended in Article 21 paragraph (1) letter b are given every month to the DPRD Chair and DPRD Deputy Chair to support operational activities related to representation, services and other needs to facilitate the implementation of the DPRD Chair and Deputy Chair's duties. day-to-day chairman of the DPRD.
- (2) Operational funds as in paragraph (1) are provided in accordance with the Regional financial capacity as intended in Article 8 paragraph (4).
- (3) Operational fund budgeting as referred to in paragraph (1) and paragraph (2) is prepared collectively by DPRD Secretary with the following provisions:
 - a. Chairman of the DPRD, in terms of ability groups Regional finance:
 - high, a maximum of 6 (six) times;
 moderate, a maximum of 4 (four) times;
 low, a maximum of 2 (two) times;

from the representation money from the Chairman of the DPRD;

- b. Deputy Chairman of the DPRD, in terms of ability groups Regional finance:
 - 1. high, a maximum of 4 (four) times;
 - 2. medium, a maximum of 2.5 (two point five) times;
 - 3. low, a maximum of 1.5 (one point five) times;

from the representation money for the Deputy Chair of the DPRD.

- (4) Provision of operational funds as intended in paragraph (3) is carried out every month with the following provisions:
 - a. 80% (eighty percent) is given at once for all costs or is called *a lump sum*; And
 - b. 20% (twenty percent) is given to other operational funding support.
- (5) In the event that any remaining operational funds after the implementation of the provisions for granting as intended in paragraph (4) are not used until the end of the budget year, the remaining funds must be deposited into the regional general treasury account no later than December 31 of the relevant budget year.

(6) DPRD Leadership operational funds are not used for personal, group and/or class needs, and their use must take into account the principles of benefit, effectiveness, efficiency and accountability.

Article 24

- (1) The expert group or team of experts on DPRD equipment as referred to in Article 21 paragraph (1) letter c is a certain number of experts or experts who have abilities in scientific disciplines that are in accordance with the needs of implementing the DPRD's functions, duties and authority as reflected in the tool. DPRD equipment is in accordance with DPRD needs based on the suggestions of members, faction leaders and DPRD Equipment Leaders.
- (2) The expert group or Expert Team for DPRD equipment as referred to in paragraph (1) is a maximum of 3 (three) people for each DPRD Equipment.
- (3) The Expert Group or Expert Team for DPRD equipment is appointed and dismissed with the decision of the DPRD Secretary in accordance with the needs as intended in paragraph (1) and in accordance with the provisions as intended in paragraph (2).
- (4) Compensation payments for Expert Groups or Expert Teams for DPRD equipment are based on attendance in accordance with DPRD needs or certain DPRD activities and can be done at a price per person day or person month.
- (5) Further provisions regarding the amount of compensation for the Expert Group or Expert Team for DPRD equipment are regulated in a Regent's Regulation taking into account expertise standards in accordance with the provisions of statutory regulations.
- (6) Procurement of an Expert Group or Expert Team for DPRD equipment as intended in paragraph (1) is carried out in accordance with the provisions of statutory regulations.

- (1) Fraction Expert Staff as referred to in Article 21 paragraph (1) letter d are Expert Staff provided by 1 (one) person for each faction and have abilities in certain scientific disciplines that support the faction's duties and are compensated by taking into account skill standards, principles efficiency, and in accordance with Regional financial capabilities.
- (2) The faction experts as referred to in paragraph (1) are determined by the DPRD Secretary's Decree.

- (3) Further provisions regarding the amount of compensation for faction experts are regulated by Regent's Regulations taking into account expertise standards in accordance with statutory provisions.
- (4) Procurement of faction experts as intended in paragraph (1) is carried out in accordance with the provisions of statutory regulations.

- (1) Fraction secretariat expenditure as intended in Article 21 paragraph (1) letter e is financed from the DPRD secretariat budget in accordance with DPRD needs and in accordance with the Regional financial capacity.
- (2) Fraction secretariat expenditure consists of providing facilities and budget.
- (3) Provision of facilities includes work space at the DPRD Secretariat and office equipment in accordance with statutory provisions and does not include mobility facilities.
- (4) Budget provision includes meeting the needs for shopping for office stationery and food and drink for faction meetings held within the DPRD Secretariat office by paying attention to the principles of efficiency, effectiveness and propriety.

CHAPTER IV

FINANCIAL AND ADMINISTRATIVE RIGHTS MANAGEMENT LEADERS AND MEMBERS OF DPRD

- (1) Income, welfare allowances, service fees for DPRD Leaders and Members, as well as expenditure to support DPRD activities constitute the DPRD expenditure budget which is formulated into the Work Plan and Regional Apparatus Budget of the DPRD Secretariat and described into types of expenditure in accordance with the provisions of statutory regulations..
- (2) Management of the DPRD expenditure budget as referred to in paragraph (1) is carried out in accordance with the provisions of statutory regulations.
- (3) The DPRD expenditure budget as referred to in paragraph (1) is an inseparable part of the APBD.

CHAPTER V MISCELLANEOUS PROVISIONS

Article 28

(1) DPRD leaders or members who are temporarily dismissed by authorized officials in accordance with the provisions of statutory regulations are still given financial and administrative rights in the form of: a. representation money; b.

package money; c.
family allowance;
d. rice allowance; e.
health insurance; and
f. life insurance. in accordance
with the provisions of
statutory regulations.

(2) In the event that the DPRD Leadership is temporarily absent for more than 30 (thirty) days and is appointed as acting DPRD Leadership by an authorized official in accordance with the provisions of statutory regulations, the DPRD Leadership acting is given the same financial and administrative rights as the DPRD Leadership The definitive replacement will be effective from the 1st (one) of the following month.

CHAPTER VI

CLOSING

Article 29

At the time this Regional Regulation came into force, Sukoharjo Regency Regional Regulation Number 9 of 2004 concerning the Protocol and Financial Position of the Leaders and Members of the Sukoharjo Regency DPRD (Sukoharjo Regency Regional Gazette of 2004 Number 53, Supplement to Sukoharjo Regency Regional Gazette Number 121) as amended several times most recently with the Sukoharjo Regency Regional Regulation Number 17 of 2007 concerning the Third Amendment to the Sukoharjo Regency Regional Regulation Number 9 of 2004 concerning the Protocol and Financial Position of the Leaders and Members of the Sukoharjo Regency DPRD (Sukoharjo Regency Regional Gazette of 2006 Number 19, Supplement to the Sukoharjo Regency Regional Gazette Number 150), as long as it regulates the financial and administrative rights of DPRD Leaders and Members, it is revoked and declared invalid.

The Regent's Regulation as the implementation of this Regional Regulation must be stipulated no later than 2 (two) months after the promulgation of this Regional Regulation.

FINANCIAL AND ADMINISTRATIVE RIGHTS OF LEADERS AND BOARD MEMBERS REGIONAL PEOPLE'S REPRESENTATIVES

I. GENERAL

Based on Law Number 23 of 2014 concerning Regional Government as amended several times, most recently with Law Number 9 of 2015 concerning Amendments to Law Number 23 of 2014 concerning Regional Government, the DPRD has the position of administering Regional Government together with the Regional Head. Both are equal partners who have different functions. The DPRD has 3 (three) functions, namely: the function of forming Regional Regulations, the budget function and the supervisory function.

Meanwhile, the Regional Head carries out the function of implementing Regional Regulations and Regional policies.

Furthermore, in its position as an organizing element of Regional Government, the DPRD has the rights, obligations, duties, authority and functions of the DPRD. Among the rights possessed by DPRD Leaders and Members as intended in Article 160 of Law Number 23 of 2014 concerning Regional Government as amended several times, most recently by Law Number 9 of 2015 concerning Amendments to Law Number 23 of 2014 concerning Government Regions are financial and administrative rights.

In connection with the implementation of Government Regulations Number 18 of 2017 concerning the Financial and Administrative Rights of the Leaders and Members of the Regional People's Representative Council, then Sukoharjo Regency Regional Regulation Number 9 of 2004 concerning the Protocol and Financial Position of the Leaders and Members of the Sukoharjo Regency DPRD as amended several times, most recently by Sukoharjo Regency Regional Regulation Number 17 2007 concerning the Third Amendment to Sukoharjo Regency Regional Regulation Number 9 of 2004 concerning the Protocol and Financial Position of the Leaders and Members of the Sukoharjo Regency DPRD needs to be adjusted.

Regulations regarding the financial and administrative rights of DPRD Leaders and Members aim to increase the role and responsibility of the DPRD institution to develop democratic life, guarantee the representation of the people and the Region in carrying out the functions, duties and authority of the institution, as well as develop a checks and balance mechanism between the DPRD institution and the Head Regions, as well as improving the quality, productivity and performance of institutional members in order to realize justice and welfare of the people.

This Regional Regulation is expected to become the legal basis for fulfilling the financial and administrative rights of DPRD Leaders and Members.
