#### IN THE NAME OF GOD, THE ALMIGHTY

# HEAD OF MALANGAN VILLAGE,

- a. Making notes on the performance of the Village Head;
- b. Requesting clarification or information;
- c. Stating opinions;
- d. Providing input for the preparation of Village deliberation materials.

#### Article 4

This Village Regulation shall come into effect on the date it is enacted. In order for everyone to be informed, it is ordered to promulgate this Village Regulation by publishing it in the Malangan Village Gazette.
