# SIDOREJO VILLAGE REGULATION NUMBER 5 OF 2024

### **CONCERNING**

# VILLAGE REVENUE AND EXPENDITURE BUDGET BUDGET YEAR 2025

## IN THE NAME OF GOD, THE ALMIGHTY

### HEAD OF SIDOREJO VILLAGE,

## Considering:

- a. That the Village Revenue and Expenditure Budget, as a form of village financial management, is implemented transparently and responsibly for the greatest prosperity of the village community;
- b. That the Village Revenue and Expenditure Budget for the Fiscal Year 2025 is compiled according to the needs of village governance, based on the principles of togetherness, efficiency, fairness, sustainability, environmental awareness, and independence, in order to create a strong foundation for the implementation of governance and development towards a just, prosperous, and thriving society;
- c. That based on the considerations as referred to in points a and b, it is necessary to establish a Village Regulation on the Village Revenue and Expenditure Budget for the Fiscal Year 2025;

### **Article 1**

The Village Revenue and Expenditure Budget for the Fiscal Year 2025 with the following details:

## **Article 2**

Further details regarding the Village Revenue and Expenditure Budget as referred to in Article 1 are outlined in the Annex, which is an integral part of this Village Regulation.

### Article 3

The Annex as referred to in Article 2 contains:

- a. Village Revenue and Expenditure Budget (APB Desa);
- b. List of capital participation, if available;
- c. List of reserve funds, if available; and
- d. List of activities that were not carried out in the previous fiscal year, if any.

## **Article 4**

The Head of the Village shall establish the Head of Village Regulation on the Village Revenue and Expenditure Budget Breakdown as the operational basis for implementing the Village Revenue and Expenditure Budget (APB Desa).

### Article 5

- (1) The Village Government may carry out activities for disaster management, emergency situations, and urgent matters.
- (2) Activities as referred to in paragraph (1) must meet the following criteria:
- a. Not part of the normal activities of the Village Government and cannot be predicted in advance;
- b. Not expected to occur repeatedly;
- c. Outside the control and influence of the Village Government;
- d. Have a significant impact on the budget for recovery caused by extraordinary events and/or social issues; and
- e. Local in scale to the Village.

### Article 6

In the event of:

- a. Increases and/or decreases in Village revenue in the current year;
- b. Situations that require shifting between expenditure items; and/or
- c. Activities that were not carried out in the previous year and result in the Surplus/Deficit

(SiLPA) to be carried out in the current year;

The Head of the Village may initiate changes to the Village Revenue and Expenditure Budget by revising the Head of Village Regulation on the Breakdown of the Village Revenue and Expenditure Budget and notifying the Village Consultative Body (BPD).

### Article 7

This Village Regulation shall come into effect on the date of its promulgation.

In order to make it known to the public, the promulgation of this Village Regulation shall be ordered by placing it in the Sidorejo Village Gazette.
