## CHANGES TO REGENT REGULATION NUMBER 84 OF 2019 CONCERNING ASSISTANT COORDINATION DUTIES REGIONAL SECRETARY OF SUKOHARJO DISTRICT

# BY THE GRACE OF GOD ALMIGHTY,

## REGENT SUKOHARJO,

Considering: a. that in order to achieve good governance, as well as a synergistic and harmonious relationship between the Assistant Regional Secretary and the Regional Apparatus who are coordinating in the field of carrying out their duties, and the Assistant Regional Secretary with the Sections within the scope of the Regional Secretariat who are hierarchically coordinating in carrying out technical tasks, as well as coordinating with other vertical agencies, it is necessary to organize their divisions according to their respective duties and functions;

- b. that in order to realize effective and efficient government governance in order to improve government performance and public services, it is necessary to divide the duties of the Assistant Regional Secretary;
- c. that with the enactment of Regional Regulation Number 12 of 2016 concerning the Formation and Composition of Regional Apparatus as amended by Regional Regulation Number 7 of 2022 concerning Amendments to Regional Regulation Number 12 of 2016 concerning the Formation and Composition of Regional Apparatus, there are changes in the nomenclature

Regional Apparatus, then Regent Regulation Number 84 2019 regarding the Coordination Duties of the Assistant Regional Secretary of Sukoharjo Regency needs to be changed;

d. that based on the considerations as intended in letters a, b, and c, it is necessary to stipulate a Regent's Regulation concerning Amendments to Regent's Regulation Number 84 of 2019 concerning the Division of Assistant Secretary Coordination Duties

Sukoharjo Regency Area;

- Minister of Home Affairs Regulation Number 56 of 2019 concerning Guidelines for Nomenclature and Work Units of Provincial and Regency/City Regional Secretariats (State Gazette of the Republic of Indonesia of 2019 Number 970);

### DECIDE:

## To stipulate: REGENT'S REGULATION CONCERNING AMENDMENTS TO REGENT'S REGULATION NUMBER 84 OF 2019 CONCERNING THE DELIVERY OF COORDINATION DUTIES OF THE SUKOHARJO REGIONAL ASSISTANT SECRETARY.

## Article I

Several provisions in the Sukoharjo Regent's Regulations Number 84 of 2019 concerning Division of Duties Coordination of Assistant District Regional Secretary Sukoharjo (Sukoharjo Regency Regional News Year 2019 Number 85), amended as follows:

1. The provisions of Article 1 are amended to read as follows following:

#### PIG

#### GENERAL REQUIREMENTS

#### article 1

- 1. The region is Sukoharjo Regency.
- 2. Regional Government is the Regent as the organizing element of the Regional Government which leads the implementation of government affairs which are the authority of the autonomous Region.
- 3. The Regent is the Regent of Sukoharjo.
- 4. The Deputy Regent is the Deputy Regent of Sukoharjo.
- 5. The Regional People's Representative Council, hereinafter abbreviated as DPRD, is the Regional People's Representative Council of Sukoharjo Regency.
- 6. Regional Apparatus is a supporting element for the Regent and DPRD in carrying out government affairs which fall under the authority of the Region.
- 7. Regional Secretariat is the Regional Secretariat Sukoharjo Regency.

- The Secretariat of the Regional People's Representative Council, hereinafter referred to as the DPRD Secretariat, is the Secretariat of the Regional People's Representative Council Sukoharjo Regency.
- 10. deleted.
- 11. Regional Inspectorate is the Regional Inspectorate of Sukoharjo Regency.
- 12. Regional Service is the Sukoharjo Regency Regional Service.
- 13. Regional Agency is the Regional Agency of Sukoharjo Regency.
- 14. Sub-district is a sub-district in the Sukoharjo Regency area.
- 15. Regional General Hospital Ir. Soekarno is the Ir Regional General Hospital. Soekarno, Sukoharjo Regency.
- 2. The provisions of paragraph (1) of Article 2 are amended to read as follows:

Section 2

- (1) Assistant for Government and People's Welfare is an assistant element of the Regional Secretary who is under and responsible to the Regional Secretary.
- (2) Assistant for Government and People's Welfare led by Assistant.
- 3. Provisions in the Attachment to Regent Regulation Number 84 of 2019 concerning the Division of Coordination Duties of the Assistant Regional Secretary of Sukoharjo Regency are amended so that it becomes as stated in the Attachment which is an inseparable part of this Regent's Regulation.

Article II

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.
