CHANGES TO SUKOHARJO REGENCY REGULATION NUMBER 55 OF 2018 CONCERNING GUIDELINES FOR INSTALLING CAMPAIGN PROPS AND USE OF PUBLIC FACILITIES DURING THE CAMPAIGN PERIOD GENERAL ELECTION AND ELECTION OF GOVERNOR AND DEPUTY GOVERNOR AND REGENT AND DEPUTY REGENT

BY THE GRACE OF GOD ALMIGHTY,

REGENT SUKOHARJO,

Considering: a. that in order to provide space for campaign activities, it is necessary to determine the location of public facilities for the implementation of the campaign during the general election campaign and the election of governor and deputy governor and regent and deputy regent;

- b. that based on the considerations as intended in letter a, Sukoharjo Regent Regulation Number 55 of 2018 concerning Guidelines for the Installation of Campaign Props and Use of Public Facilities during the Campaign Period for the General Election and Election of Governor and Deputy Governor and Regent and Deputy Regent needs to be amended;
- c. that based on the considerations as intended in letters a and b, it is necessary to stipulate a Regent's Regulation concerning Amendments to the Sukoharjo Regent's Regulation Number 55 of 2018 concerning Guidelines for the Installation of Campaign Props and Use of Public Facilities during the General Election Campaign Period and the Election of Governor and Deputy Governor and Regent and Vice-regent;

Bearing in mind: 1. Law Number 13 of 1950 concerning the Establishment of Regency Areas within the Province of Central Java;

- 3. Law Number 12 of 2011 concerning the Formation of Legislation (State Gazette of the Republic of Indonesia of 2011 Number 82, Supplement to the State Gazette of the Republic of Indonesia Number 5234);
- 4. Law Number 23 of 2014 concerning Regional Government (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to State Gazette of the Republic of Indonesia Number 5587) as amended several times, most recently by Law Number 9 of 2015 concerning the Second Amendment to Law Number 23 of 2014 concerning Regional Government (State Gazette of the Republic of Indonesia of 2015 Number 58, Supplement to the State Gazette of the Republic of Indonesia Number 5679);

Law Number 1 of 2015 concerning the Determination of Government Regulations in Lieu of Law Number 1 of 2014 concerning the Election of Governors, Regents and Mayors into Law (State Gazette of the Republic of Indonesia of 2015 Number 23, Supplement to the State Gazette of the Republic of Indonesia Number 5588) as amended several times, most recently by Law Number 10 of 2016 concerning the Second Amendment to Law Number 1 of 2015 concerning the Determination of Government Regulations in Lieu of Law Number 1 of 2014 concerning the Election of Governors, Regents and Mayors into Law (Sheet Republic of Indonesia Year 2016 Number 130, Supplement to the State Gazette of the Republic of Indonesia Number 5998);
- Law Number 7 of 2017 concerning General Elections (State Gazette of the Republic of Indonesia of 2017 Number 182, Supplement to the State Gazette of the Republic of Indonesia Number 6109);
- Presidential Regulation Number 87 of 2014 concerning Implementing Regulations of Law Number 12 of 2011 concerning the Formation of Legislative Regulations (State Gazette of the Republic of Indonesia of 2014 Number 199);
- Republic of Indonesia General Election Commission Regulation Number 4 of 2017 concerning Election Campaigns for Governors and Deputy Governors, Regents and Deputy Regents, and/or Mayors and Deputy Mayors (State Gazette of the Republic of Indonesia of 2017 Number 827);

Regulation of the General Election Commission of the Republic of Indonesia Number 23 of 2018 concerning General Election Campaigns (State Gazette of the Republic of Indonesia of 2018 Number 973) as amended by Regulation of the General Election Commission of the Republic of Indonesia Number 28 of 2018 concerning Amendments to the Regulation of the General Election Commission of the Republic of Indonesia Number 23 of 2018 concerning General Election Campaigns (State Gazette of the Republic of Indonesia of 2018 Number 1174);

 Sukoharjo Regent Regulation Number 55 of 2018 concerning Guidelines for Installing Campaign Props and the use of public facilities during the general election campaign and election of governor and deputy governor and regent and deputy regent (Regional Gazette of Sukoharjo Regency of 2018 Number 55);

DECIDE :

To stipulate: REGENT'S REGULATION CONCERNING AMENDMENTS TO SUKOHARJO REGENT'S REGULATION NUMBER 55 OF 2018 CONCERNING GUIDELINES FOR THE INSTALLATION OF CAMPAIGN PROPS AND USE OF PUBLIC FACILITIES DURING THE GENERAL ELECTION CAMPAIGN AND THE ELECTION OF THE GOVERNOR AND DEPUTY GOVERNOR AND THE REGENT AND DEPUTY REGENT.

Article I

Several provisions in the Sukoharjo Regent's Regulation Number 55 of 2018 concerning Guidelines for Installing Campaign Props and Using Public Facilities during the General Election Campaign Period and the Election of Governor and Deputy Governor and Regent and Deputy Regent. (Sukoharjo Regency Regional Gazette 2018 Number 55) was amended to read as follows:

1. The title of CHAPTER V is changed to read as follows:

CHAPTER V

INSTALLATION TIME AND USE OF PUBLIC FACILITIES

2. The provisions of paragraph (1) of article 11 are amended and 1 (one) paragraph is added, so that it reads as follows:

Article 11

- (1) The period for installing campaign props/using public facilities as intended in article 2 is used during the campaign period until entering the quiet period according to the schedule as regulated by the Regency KPU.
- (2) The period for installing campaign props as intended in paragraph (1) at the campaign venue/location starts at 00.00 WIB on the Election campaign day schedule determined by the Regency KPU
- (3) The period for using public facilities as intended in paragraph (1) at the campaign venue/location starts at 09.00 WIB and ends no later than 18.00 WIB on the campaign day schedule determined by the Regency KPU

3. The provisions of paragraph (1) of article 12 are amended to read as follows following:

Article 12

- (1) The campaign organizer as intended in Article 2 is responsible for the cleanliness, order, beauty and security of the campaign props installed and the use of public facilities.
- (2) The implementation of the campaign as referred to in paragraph (1) and the third party/advertising bureau that installs campaign props have the obligation to:
 - a. maintain neatness, order, beauty, cleanliness and safety;
 - b. adhere to the specified installation time;
 - c. repair and replace if anything is damaged; And
 - d. lower/remove/remove/put in order/ dismantle campaign props according to the election campaign schedule.
- 4. Between CHAPTER VI and CHAPTER VII, 1 (one) CHAPTER is inserted, namely CHAPTER VI A, so that it reads as follows:

CHAPTER VI A GENERAL FACILITIES FOR CAMPAIGN

Article 12 A

- (1) Public facilities that can be used for organizing campaigns are in the form of fields.
- (2) Public facilities as intended in paragraph (1) are listed in the Attachment which is an inseparable part of this Regent's Regulation.
- 5. The provisions of Article 13 are amended to read as follows following:

Article 13

 Installation of props and use of public facilities as intended in Article 2 which is not in accordance with the provisions of this Regent's Regulation is a form of violation.

- (2) Violations as intended in paragraph (1) will be subject to sanctions.
- (3) Sanctions as intended in paragraph (2) are in the form of:
 - a. Decrease/release/dissolution Tool Demonstrate Election Campaign or Election Campaign by Satpol PP who has coordinated with the Regency Bawaslu together with related agencies;
 - b. Revocation of advertising permits belonging to third parties/advertising agencies; and/or
 - c. Termination of the campaign by the Sukoharjo Regency Bawaslu in coordination with the Sukoharjo Satpol PP

Article II

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.
