AMENDMENT TO SUKOHARJO REGENCY REGULATION NUMBER 44 OF 2016 CONCERNING TRADITIONAL/GROKERAGE STORE ARRANGEMENT IN SUKOHARJO DISTRICT

REGENT SUKOHARJO.

- Considering: a. that in order to provide justice for traditional shop/grocery business actors so that running their business can be affordable in terms of capital, then
 - need to change the amount of working capital in the requirements for establishing a traditional/grocery shop;
 - b. that based on the balance as intended in letter a, Sukoharjo Regent Regulation Number 44 of 2016 concerning Arrangement of Traditional/ Grocery Shops in Sukoharjo Regency needs to be amended;
 - c. that based on the considerations as intended in letters a and b, it is necessary to stipulate a Regent's Regulation concerning Amendments to Sukoharjo Regent's Regulation Number 44 of 2016 concerning Arrangement of Traditional/Grocery Shops in Sukoharjo Regency;

DECIDE:

To stipulate: REGENT'S REGULATION CONCERNING AMENDMENTS TO SUKOHARJO REGENT'S REGULATION NUMBER 44 OF 2018

CONCERNING THE ARRANGEMENT OF TRADITIONAL/GROKERAGE SHOPS IN SUKOHARJO DISTRICT.

Article I

Provisions of Article 4 paragraph (2) in the Sukoharjo Regent Regulation Number 44 of 2016 concerning Store Arrangement Traditional/Grocery in Sukoharjo Regency (Regional News Sukoharjo Regency of 2016 Number 44) was amended to read as follows:

Article 4

- (1) The maximum floor area for traditional/grocery shops is 100m² (one hundred square meters), including if there is a place for warehouse/ stock storage of traded goods.
- (2) Have working capital of a maximum of IDR 100,000,000.00 (one hundred million rupiah), excluding land and buildings.
- (3) The goods sold are domestically produced and are the basic daily needs of the community.
- (4) Traditional/grocery shops are not shops with a *franchise/franchise* system or franchise partners.
- (5) Sales are carried out by providing direct services by the seller to the buyer/consumer.

Article II

This Regent's Regulation comes into force on the date of promulgation.

So that everyone knows, order the promulgation of this Regent's Regulation with its placement and the Regional News of Sukoharjo Regency.
