SECOND AMENDMENT TO REGENT REGULATION NUMBER 34 OF 2021 CONCERNING DELEGATION OF BUSINESS LICENSING AUTHORITY, NON-BUSINESS LICENSING AND NON-PERMISSION TO HEAD OF CAPITAL INVESTMENT AND SERVICES OFFICE INTEGRATED ONE DOOR

BY THE GRACE OF GOD ALMIGHTY

REGENT SUKOHARJO,

Considering: a. that in order to realize fast, effective and efficient licensing governance in order to improve public services,

it is necessary to delegate authority for business licensing, non-business licensing and non-licensing to the Head of the One-Stop Integrated Services and Investment Service;

- b. that in order to improve the quality of services to the community, especially in the field of business licensing, non-business licensing and nonlicensing services as well as to encourage economic growth through increasing investment, it is necessary to have a fast, efficient and integrated business licensing, non-business licensing and non-licensing service system;
- c. that with the stipulation of Minister of Agriculture Regulation Number 3 of 2019 concerning Veterinary Medical Services, the provisions relating to the issuance of permits for Independent Veterinary Practice Licenses and Veterinary Paramedic Service Places are in Regent Regulation Number 34 of 2021 concerning Delegation of Authority for Business Licensing, Non-Business Licensing and Non-Permitting To the Head of the One Stop Investment and Integrated Services Service as amended by Regent's Regulation Number 8 of 2022 concerning Amendments to Regent's Regulation Number 34 of 2021 concerning Delegation of Authority for Business Licensing, Non-Business Licensing and Non-Licensing To the Head of the One Stop Investment and Integrated Services Service Doors, need to be changed;

- d. that based on the considerations as intended in letters a, b and c, it is necessary to stipulate a Regent's Regulation concerning the Second Amendment to Regent's Regulation Number 34 of 2021 concerning Delegation of Authority for Business Licensing, Non-Business Licensing and Non-Permitting to the Head of the Regency Investment and One-Stop Integrated Services Service Sukoharjo.

DECIDE:

To stipulate: REGENT REGULATION CONCERNING THE SECOND AMENDMENT TO REGENT REGULATION NUMBER 34 OF 2021 CONCERNING DELEGATION OF AUTHORITY FOR BUSINESS LICENSING, NON-BUSINESS LICENSING AND NON-BUSINESS LICENSING TO THE HEAD OF THE DEPARTMENT OF CAPITAL INVESTMENT AND ONE-DOOR INTEGRATED SERVICES.

Article I

Provisions of Appendix II in Regent's Regulation Number 34 of 2021 concerning Delegation of Authority for Business Licensing, Non-Business Licensing and Non-Permitting to the Head of the One Stop Integrated Service and Investment Service (Sukoharjo Regency Regional Gazette of 2021 Number 35) as amended by Regent's Regulation Number 8 of 2021 2022 concerning Amendments to Regent's Regulation Number 34 of 2022 concerning Delegation of Authority for Business Licensing, Non-Business Licensing and Non-Permitting to the Head of the Sukoharjo Regency One Stop Investment and Integrated Services Service (Sukoharjo Regency Regional Gazette 2022 Number 8) is amended so that it becomes as stated in Attachment II which is an inseparable part of this Regent's Regulation.

Article II

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.
