**FOURTH AMENDMENT TO SUKOHARJO REGENCY REGULATION NUMBER 7
2020 CONCERNING PROCEDURES FOR DISTRIBUTION OF VILLAGE FUNDS**

BY THE GRACE OF GOD ALMIGHTY

REGENT SUKOHARJO,

Considering:

- a. that with the enactment of Minister of Finance Regulation Number 156/PMK.07/2020 concerning the Third Amendment to Minister of Finance Regulation Number 205/PMK.07/2019 concerning Village Financial Management, there are several changes to the procedures for distributing Village Funds so that Sukoharjo Regent Regulation Number 7 of 2020 regarding Procedures for Distribution of Village Funds as amended several times, most recently by Sukoharjo Regent Regulation Number 53 of 2020 concerning Third Amendment to Sukoharjo Regent Regulation Number 7 of 2020 concerning Procedures for Distribution of Village Funds needs to be amended;
- b. that based on the considerations as intended in letter a, it is necessary to stipulate a Regent's Regulation concerning the Fourth Amendment to Sukoharjo Regent's Regulation Number 7 of 2020 concerning Procedures for Distribution of Village Funds;

DECIDE :

To stipulate: REGENT'S REGULATION CONCERNING THE FOURTH AMENDMENT TO SUKOHARJO REGENT'S REGULATION NUMBER 7 OF 2020 CONCERNING PROCEDURES FOR DISTRIBUTION OF VILLAGE FUNDS.

Article I

Several provisions in Sukoharjo Regent Regulation Number 7 of 2020 concerning Village Fund Management Procedures (Berita Sukoharjo Regency Region 2020 Number 7) which has been amended several times by the Regulation of the Regent of Sukoharjo:

- a. Number 25 of 2020 concerning Procedures for Distribution of Village Funds Amendment to Regulation of the Regent of Sukoharjo Number 7 of 2020 concerning Procedures for Distribution of Village Funds (Regional Gazette of Sukoharjo Regency of 2020 Number 25);

- b. Number 30 of 2020 concerning the Second Amendment to Sukoharjo Regent Regulation Number 7 of 2020 concerning Procedures for Distribution of Village Funds (Sukoharjo Regency Regional Gazette of 2020 Number 30);**
 - c. Number 53 of 2020 concerning the Third Amendment to Sukoharjo Regent Regulation Number 7 of 2020 concerning Procedures for Distribution of Village Funds (Sukoharjo Regency Regional Gazette of 2020 Number 53);**
- changed as follows:**

- 1. The provisions of paragraph (5) and paragraph (6) of Article 6A are amended, and between paragraph (6) and paragraph (7) 1 (one) paragraph is inserted, namely paragraph (6a), so it reads as follows:**

Article 6A

- (1) The social safety net in the Village as intended in Article 4 paragraph (1a) letter b, is in the form of Village BLT to poor or disadvantaged families in the Village as beneficiary families.**
- (1a) Village Funds are prioritized for Village BLT as intended in paragraph (1).**
- (2) The Village Government is obliged to budget and implement Village BLT activities as referred to in paragraph (1).**
- (3) Prospective family recipients of village BLT benefits as referred to in paragraph (1) at least meet the following criteria: a. poor or underprivileged families domiciled in the village concerned; And**
 - b. does not include recipients of the Family Hope Program (PKH), Basic Food Cards and Pre-Employment Cards.**
- (4) Data collection on prospective Village BLT recipient families as referred to in paragraph (3) letter b takes into account the Integrated Social Welfare Data (DTKS) from the Ministry of Social Affairs.**
- (5) The amount of BLT as intended in paragraph (1) is determined at:**
 - a. IDR 600,000.00 (six hundred thousand rupiah) for the first month to the third month per beneficiary family.**
 - b. IDR 300,000.00 (three hundred thousand rupiah) for the fourth to ninth months per beneficiary family.**

- (4) In the event that the letter of explanation as intended in paragraph (3) letter a and the letter of recommendation as intended in paragraph (3) letter b are submitted after the Village Funds for the current budget year have been completely distributed, the termination of distribution as intended in paragraph (3) begins to be implemented on distribution of Phase I Village Funds for the next fiscal year.**
- (5) In the event that a village head is involved in a legal problem related to the misuse of Village Funds as referred to in paragraph (1) letter a, the Regency Government is responsible for monitoring the development of the legal process for misuse of Village Funds.**

3. The provisions of Article 12 are amended to read as follows following:

Article 12

- (1) The Ministry of Finance can redistribute Village Funds whose distribution is stopped as intended in Article 11 paragraph (3), after receiving:**
- a. revocation of the suspect's legal status, restoration of the suspect's legal status, and/or a court decision that has permanent legal force delivered by the relevant Regency Government as a result of monitoring as intended in Article 11 paragraph (5); or**
 - b. recommendations for re-distribution of Village Funds from relevant ministries/institutions.**
- (2) Redistribution of Village Funds as intended in paragraph (1), with the following provisions:**
- a. documents as intended in paragraph (1) letter a for stopping the distribution of Village Funds because the village head misused Village Funds as intended in Article 11 paragraph (1) letter a; or b. recommendation for the redistribution of Village Funds as intended**
 - in paragraph (1) letter b to stop the distribution of Village Funds because the Village is experiencing administrative problems and/or unclear legal status as intended in Article 11 paragraph (1) letter b.**

Article II

This Regent's Regulation comes into force on the date of promulgation.

So that everyone knows, this Regulation is ordered to be placed in the Regional Gazette of Sukoharjo Regent
