REGIONAL REGULATION OF SUKOHARJO REGENCY NUMBER 6 OF 2015

ON

THE FOURTH AMENDMENT TO THE REGIONAL REGULATION OF SUKOHARJO REGENCY NUMBER 4 OF 2008 ON THE ORGANIZATION AND WORKING PROCEDURES OF REGIONAL TECHNICAL INSTITUTIONS, SATUAN POLISI PAMONG PRAJA, AND THE INTEGRATED LICENSING SERVICE OFFICE OF SUKOHARJO REGENCY

BY THE GRACE OF GOD ALMIGHTY THE REGENT OF SUKOHARJO,

- Considering: a. That based on the provisions of Article 6 and Article 20 of the Ministry of Home Affairs Regulation Number 40 of 2011 concerning the Guidelines for the Organization and Working Procedures of the Civil Service Police Unit (Satpol PP), the Regional Regulation of Sukoharjo Regency Number 4 of 2008 concerning the Organization Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency, as amended several times, most recently by the Regional Regulation of Sukoharjo Regency Number 8 of 2014 concerning the Third Amendment to the Regional Regulation of Sukoharjo Regency Number 4 of 2008 concerning the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency, needs to be amended:
 - b. That based on the considerations as referred to in letter a, it is necessary to establish a Regional Regulation concerning the Fourth Amendment to the Regional Regulation of Sukoharjo Regency Number 4 of 2008 concerning the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency;

Article I

The Regional Regulation of Sukoharjo Regency Number 4 of 2008 concerning the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency (Regional Gazette of Sukoharjo Regency 2008 Number 4, Supplement to the Regional Gazette of Sukoharjo Regency Number 158), which has been amended several times by the following Regional Regulations:

- a. Number 2 of 2010 concerning the Amendment to the Regional Regulation of Sukoharjo Regency Number 4 of 2008 on the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency (Regional Gazette of Sukoharjo Regency 2010 Number 2, Supplement to the Regional Gazette of Sukoharjo Regency Number 173);
- b. Number 11 of 2011 concerning the Second Amendment to the Regional Regulation of Sukoharjo Regency Number 4 of 2008 on the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo

c. Number 8 of 2014 concerning the Third Amendment to the Regional Regulation of Sukoharjo Regency Number 4 of 2008 on the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency (Regional Gazette of Sukoharjo Regency 2014 Number 8, Supplement to the Regional Gazette of Sukoharjo Regency Number 215);

is amended as follows:

The provisions of paragraph (1) and paragraph (5) of Article 39 are amended to read as follows:

Article 39

- (1) The organizational structure of the Civil Service Police Unit consists of:
- a. Head;
- b. Secretariat, consisting of:

Program Subdivision;

Finance Subdivision; and

General Affairs and Human Resources Subdivision.

c. Regional Law Enforcement Division, consisting of:

Legal Development, Supervision, and Counseling Section; and

Investigation and Inquiry Section.

d. Public Order and Community Security Division, consisting of:

Operations and Control Section; and

Cooperation Section.

e. Human Resources Division, consisting of:

Basic Training Section; and

Functional Technical Section.

f. Community Protection Division, consisting of:

Community Protection Unit Section; and

Community Potential Development Section.

- g. Functional position group.
- (2) A Civil Service Police Unit Implementation Unit is formed in each district.
- (3) The Civil Service Police Unit Implementation Unit in the district as referred to in paragraph (2) is led by a Unit Head.
- (4) The Unit Head as referred to in paragraph (3) is exofficio held by the Head of the Public Order and Security Section at the district level.
- (5) The organizational chart of the Civil Service Police Unit as referred to in paragraph (1) and paragraph (2) is included in the Annex, which is an integral part of this Regional Regulation.
- 2. The provisions of Article 52A are amended to read as follows:

Article 52A

When this Regional Regulation comes into effect, structural officials in the Civil Service Police Unit shall continue to carry out their duties and responsibilities until new structural officials are appointed based on this Regional Regulation.

Article II

This Regional Regulation shall come into effect on the date of its promulgation.

In order for everyone to be informed, the promulgation of this Regional Regulation is ordered by placing it in the Regional Gazette of Sukoharjo Regency.

REGIONAL REGULATION OF SUKOHARJO REGENCY NUMBER 6 OF 2015 CONCERNING

THE FOURTH AMENDMENT TO THE REGIONAL REGULATION OF SUKOHARJO REGENCY NUMBER 4 OF 2008 ON THE ORGANIZATION AND WORKING PROCEDURES OF REGIONAL TECHNICAL INSTITUTIONS, CIVIL SERVICE POLICE UNIT, AND THE INTEGRATED LICENSING SERVICE OFFICE OF SUKOHARJO REGENCY

I. GENERAL

The Civil Service Police Unit of Sukoharjo Regency has been designated as a Type A Civil Service Police Unit based on the Regional Regulation of Sukoharjo Regency Number 11 of 2011 concerning the Second Amendment to the Regional Regulation of Sukoharjo Regency Number 4 of 2008 on the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency. With the implementation of the Ministry of Home Affairs Regulation Number 40 of 2011 concerning the Guidelines for the Organization and Working Procedures of the Civil Service Police Unit, which states that the organizational structure of a Type A Civil Service Police Unit consists of a Head, 1 (one) Secretariat with 3 (three) Subdivisions, 4 (four) Divisions each consisting of 2 (two) Sections, and a group of functional positions, it is necessary to amend the Regional Regulation of Sukoharjo Regency Number 4 of 2008 on the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency, as last amended by the Regional Regulation of Sukoharjo Regency Number 8 of 2014 concerning the Third Amendment to the Regional Regulation of Sukoharjo Regency Number 4 of 2008 on the Organization and Working Procedures of Regional Technical Institutions, Civil Service Police Unit, and the Integrated Licensing Service Office of Sukoharjo Regency.
