## AMENDMENTS TO THE WORK PLAN OF REGIONAL APPARATUS FOR 2024

# BY THE GRACE OF GOD ALMIGHTY REGENT OF SUKOHARJO.

# Considering:

- a. That in order to realize equitable and just community welfare, a work plan is needed to ensure sustainable and public interestoriented development;
- b. That in response to the evolving social dynamics and the everchanging needs of the community, it is necessary to amend the work plan of regional apparatus to improve public services and create responsive and inclusive governance;
- c. That pursuant to Article 273 paragraph (4) of Law Number 23 of 2014 on Regional Government as last amended by Law Number 6 of 2023 concerning the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation into Law, amendments to the Work Plan of Regional Apparatus are stipulated by the Regional Head after the amendment to the Regional Government Work Plan has been determined;
- d. That based on the evaluation of the implementation of the Sukoharjo Regency Regional Apparatus Work Plan for 2024 until the second quarter, there are discrepancies with the current conditions, necessitating adjustments to the activities and subactivities in the Sukoharjo Regency Regional Apparatus Work Plan for 2024;
- e. That based on the considerations as referred to in points a, b, c, and d, it is necessary to stipulate a Regent Regulation concerning the Amendment to the Work Plan of Regional Apparatus for 2024.

# Remembering:

- 1. Article 18 paragraph (6) of the 1945 Constitution of the Republic of Indonesia;
- 2. Law Number 13 of 1950 concerning the Formation of Districts in the Central Java Province as amended by Law Number 9 of 1965 concerning the Formation of the Batang Level II Region by Amending Law No. 13 of 1950 on the Formation of Districts in the Central Java Province;
- 3. Law Number 23 of 2014 on Regional Government as last amended by Law Number 6 of 2023 concerning the Stipulation of

Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation into Law.

#### **DECIDES:**

#### To Etablish:

REGULATION OF THE REGENT CONCERNING AMENDMENTS TO THE WORK PLAN OF REGIONAL APPARATUS FOR 2024.

#### Article I

In this Regent Regulation, the following terms shall be defined as:

- 1. Region refers to Sukoharjo Regency.
- 2. Regional Government refers to the Regent as an element of the Regional Government implementing governance within the scope of the autonomous region.
- 3. Regent refers to the Regent of Sukoharjo.
- 4. Regional Apparatus refers to the supporting elements of the Regent and the Regional People's Representative Council in conducting government affairs under the authority of the Region.
- 5. The Regional Annual Development Plan, hereinafter referred to as the Regional Government Work Plan (RKPD), is a planning document for the Region for a one-year period.
- 6. The Strategic Plan of Regional Apparatus, hereinafter referred to as the Regional Apparatus Strategic Plan, is the planning document of a Regional Apparatus for a five-year period.
- 7. The Regional Apparatus Work Plan, hereinafter referred to as the Renja Regional Apparatus, is the planning document of a Regional Apparatus for a one-year period.

## Article 2

Amendments to the Renja Regional Apparatus shall be prepared in accordance with the Regional Apparatus Strategic Plan and the amended RKPD.

# Article 3

The amendments to the Renja Regional Apparatus as referred to in Article 2 shall contain programs, activities, locations, and target groups, including performance indicators and funding in accordance with the duties and functions of each Regional Apparatus.

# Article II

SYSTEMATICS AND FUNCTIONS OF RENJA REGIONAL APPARATUS

## Article 4

The amendments to the Renja Regional Apparatus as referred to in Article 2 shall be structured with the following systematics:

- a. Chapter I: Introduction;
- b. Chapter II: Evaluation of the Renja up to the Second Quarter of the Relevant Year;
- c. Chapter III: Work Plan and Funding of Regional Apparatus; and
- d. Chapter IV: Closing.

#### Article III

# CONTROL AND EVALUATION OF RENJA REGIONAL APPARATUS

#### Article 5

- 1. The Head of the Regional Apparatus shall conduct control and evaluation of the implementation of the amendments to the Renja Regional Apparatus.
- 2. The Head of the Regional Apparatus shall report the results of the control and evaluation of the amendments to the Renja Regional Apparatus to the Regent through the Head of the Regional Planning, Research, and Innovation Agency.

#### Article IV

# REGIONAL APPARATUS RESPONSIBLE FOR PREPARATION

#### Article 6

- (1) The amendments to the Renja Regional Apparatus as referred to in Article 2 shall be prepared by the following Regional Apparatus:
- a. Regional Secretariat;
- b. Secretariat of the Regional People's Representative Council;
- c. Regional Inspectorate;
- d. Department of Education and Culture;
- e. Department of Health;
- f. Department of Public Works and Spatial Planning;
- g. Department of Housing and Settlement Areas;
- h. Civil Service Police Unit;
- i. Department of Social Affairs;
- j. Department of Population Control, Family Planning, Women's Empowerment, and Child Protection;
- k. Department of Food;
- 1. Department of Environment;
- m. Department of Population and Civil Registration;
- n. Department of Community Empowerment and Villages;
- o. Department of Transportation;
- p. Department of Communication and Informatics;

- q. Department of Investment and Integrated One-Stop Services;
- r. Department of Youth, Sports, and Tourism;
- s. Department of Library and Archives;
- t. Department of Agriculture and Fisheries;
- u. Department of Cooperatives, Small and Medium Enterprises, and Trade;
- v. Department of Industry and Labor;
- w. Regional Planning, Research, and Innovation Agency;
- x. Regional Finance, Revenue, and Asset Management Agency;
- y. Agency for Personnel and Human Resources Development;
- z. Regional Disaster Management Agency; aa. Agency for National Unity and Politics; bb. Weru Subdistrict; cc. Bulu Subdistrict; dd. Tawangsari Subdistrict; ee. Sukoharjo Subdistrict; ff. Nguter Subdistrict; gg. Bendosari Subdistrict; hh. Polokarto Subdistrict; ii. Mojolaban Subdistrict; jj. Grogol Subdistrict; kk. Baki Subdistrict; ll. Gatak Subdistrict; and mm. Kartasura Subdistrict.
- (2) The amendments to the Renja Regional Apparatus as referred to in paragraph (1) points a to mm are outlined in the Attachment, which is an integral part of this Regent Regulation.
