REGENT SUKOHARJO,

- Considering:**
- a. that the levy rates for recreation and sports places are stipulated in Sukoharjo Regency Regional Regulation Number 13 of 2011 concerning Regional Levy as amended by Sukoharjo Regency Regional Regulation Number 12 of 2017 concerning Amendments to Sukoharjo Regency Regional Regulation Number 13 of 2011 concerning Regional Levy. not in accordance with the economic development of the community so changes need to be made;**
 - b. that based on the provisions of Article 92 of Sukoharjo Regency Regional Regulation Number 13 of 2011 concerning Regional Retributions as amended by Sukoharjo Regency Regional Regulation Number 12 of 2017 concerning Amendments to Sukoharjo Regency Regional Regulations Number 13 of 2011 concerning Regional Levies, changes to levy rates are determined by Regent's Regulations;**
 - c. that based on the considerations as intended letters a and b, it is necessary to stipulate a Regent's Regulation concerning Changes in Levy Rates for Recreation and Sports Places in Sukoharjo Regency;**
