BY THE GRACE OF GOD ALMIGHTY

REGENT SUKOHARJO,

Considering: that in order to implement the provisions of Article 24, Article 31 and Article 41 paragraph (3) of the Regional Regulations of Sukoharjo Regency Number 5 of 2020 concerning Management and Empowerment Street vendors need to stipulate a Regent's Regulation on Guidelines for Implementing Regency Regional Regulations Sukoharjo Number 5 of 2020 concerning Structuring and Empowerment of Street Vendors;

Bearing in mind: 1. DECIDE:

To stipulate: REGENT'S REGULATION CONCERNING INSTRUCTIONS FOR THE IMPLEMENTATION OF SUKOHARJO DISTRICT REGIONAL REGULATION NUMBER 5 OF 2020 CONCERNING THE ORGANIZATION AND EMPOWERMENT OF STREET VENDORS.

PIG

GENERAL REQUIREMENTS

article 1

In this Regent's Regulation what is meant by:

1. The region is Sukoharjo Regency.
2. Regional Government is the Regent as an element of regional government administrators who leads the implementation of government affairs which are the authority of the autonomous region.
3. The Regent is the Regent of Sukoharjo.
4. Department of Trade, Small and Medium Enterprise Cooperatives, hereinafter abbreviated as Department, is the Department of Trade, Small and Medium Enterprise Cooperatives of Sukoharjo Regency.
5. The Civil Service Police Unit, hereinafter abbreviated to Satpol PP, is the Sukoharjo Regency Civil Service Police Unit.
6. Street vendors, hereinafter abbreviated as PKL, are business actors who carry out trading business using movable or immovable business facilities, using infrastructure belonging to the Regional Government or private sector, social facilities, public facilities, land and buildings belonging to the government and/or the private sector which are temporary/not permanent.
7. Empowerment of street vendors is an effort carried out by the government, regional government, business world and society synergistically in the form of growing the business climate and business development of street vendors so that they are able to grow and develop both the quality and quantity of their business.
8. A PKL location is a place to run a PKL business located on land and/or buildings owned by the Regional Government and/or private sector.
9. A target location is a location that has been designated for street vendors as regulated by the Regional Government, either permanently or temporarily.
10. The location of the street vendor is not suitable for its intended purpose
The location is not intended as a place for street vendors to do business.

11. Permanent PKL locations are permanent locations designated as business premises

Street vendors.

12. Temporary PKL locations are locations where PKL businesses are scheduled and temporary.

13. Business Registration Certificate, hereinafter abbreviated as TDU, is a letter issued by an appointed official as proof of registration of a PKL business as well as a control tool for empowering and developing PKL businesses in locations determined by the Regional Government.

Section 2

The scope of this Regent's Regulation includes:

- a. procedures for submitting applications, issuance, extension and revocation and invalidation of TDU;
- b. procedures for empowering street vendors; And
- c. procedures for imposing administrative sanctions.

CHAPTER II

PROCEDURES FOR SUBMITTING APPLICATIONS, PUBLISHING, EXTENSION, REVOCATION AND INVALIDITY TDU

Part One General

Article 3

- (1) Every PKL occupying a location is required to have a TDU.
- (2) PKLs who violate the provisions as intended in paragraph (1) are subject to administrative sanctions in the form of:
 - a. written warning; and/or
 - b. demolition.
- (3) The administration of administrative sanctions in the form of written warnings as intended in paragraph (2) letter a is carried out by the Service.
- (4) The imposition of administrative sanctions in the form of written warnings as intended in paragraph (2) letter a, consists of:
 - a. First Warning Letter, with a period of 7 (seven) calendar days;
 - b. if the first Warning Letter as intended in letter a is not heeded, a second Warning Letter will be given, with a period of 3 (three) calendar days;
And
 - c. If the second warning letter as intended in letter b is not heeded, a third warning letter will be given, with a period of 1 (one) calendar day.

- (5) The imposition of administrative sanctions in the form of demolition as intended in paragraph (2) letter b is carried out by Satpol PP.
- (6) The imposition of administrative sanctions in the form of demolition as intended in paragraph (2) letter b can be carried out without being preceded by a written warning in the event of being caught red-handed committing a violation of:
 - a. organize and/or carry out all forms gambling;
 - b. store and/or sell alcoholic beverages;
 - c. commit negligence so that the place of activity/business is used to consume alcoholic beverages;
 - d. committing immoral acts and/or activities that lead to immoral acts;
 - e. abandoning and/or leaving empty the location of the business premises without continuous activity for 1 (one) month; and/or
 - f. misused for criminal acts.
- (7) Results of demolition as intended in paragraph (6) falls under the authority of Satpol PP.

The second part
Submission of TDU Application

Article 4

- (1) The procedure for submitting a TDU application is as follows:
 - a. The applicant submits an application to the Regent cq Head of Service by filling out the form in writing in the format as stated in Appendix I which is an inseparable part of this Regent's Regulation, attached with:
 - 1) Photocopy of Resident Identity Card (KTP);
 - 2) Photocopy of Family Card;
 - 3) Statement letter; And
 - 4) 2 (two) recent color photographs 4 x 6 cm sheet with a red background.
 - b. The applicant makes a Statement Letter in the format as stated in Attachment II which is an inseparable part of this Regent's Regulation.

Part Three
TDU Publishing

Article 5

- (1) TDU as intended in Article 3 paragraph (1) is issued by the Service.
- (2) The Service as intended in paragraph (1) verifies the application files.
- (3) If the verification results as intended in paragraph (2) meet the requirements as intended in Article 4 paragraph (1), a TDU will be issued.
- (4) If the verification results as intended in paragraph (2) do not meet the requirements, the files will be returned to be completed.
- (5) TDU as intended in paragraph (1) with the format as stated in Attachment III which is an inseparable part of this Regent's Regulation.

Part Four
TDU extension

Article 6

- (1) TDU as in Article 3 paragraph (1) can be extended based on the results of business development evaluation.
- (2) Extension of TDU as intended in paragraph (1)
submitted by street vendors.
- (3) PKL as intended in paragraph (2) submits a request for a TDU extension to the Department by attaching the old TDU.
- (4) Application for TDU extension as intended in paragraph (1) shall be made no later than 3 (three) months before the TDU validity period ends.
- (5) Application for TDU extension as intended in paragraph (3) in the format as stated in Attachment IV which is an inseparable part of this Regent's Regulation.

Part Five
Revocation and Invalidity of TDU

Paragraph I
Revocation of TDU

Article 7

- (1) TDU can be revoked if:
 - a. TDU holders violate the provisions contained in the Statement Letter as intended in Article 3 paragraph (2) letter b;
 - b. the relevant business location is no longer designated as a PKL business location;

- c. TDU holders violate statutory provisions invitation;
 - d. not carry out street vending business any more; and/or
 - e. TDU transferred.
- (2) No revocation of TDU as intended in paragraph (1). given compensation.
- (3) TDU revocation letter as intended in paragraph (1) issued by the Head of Service.

Paragraph II
TDU does not apply

Article 8

- (1) TDU does not apply in the case of:
- a. TDU holder dies;
 - b. not extending TDU;
 - c. upon written request from the TDU holder; and/or
 - d. TDU holder moves business location.
- (2) In the event that the TDU holder dies as intended in paragraph (1) letter a, the husband, wife, and/or children of the TDU holder may submit a TDU application to use the business premises at the location concerned by fulfilling the procedures for submitting a TDU application as stated in referred to in Article 4 paragraph (1).

CHAPTER III RIGHTS AND OBLIGATIONS OF PKL

Part One

Street Vendor Rights

Article 9

Street vendors are entitled to:

- a. street vendor business registration services;
- b. opportunity to carry out business activities at a designated location;
- c. information and outreach or notifications related to business activities in the location concerned;
- d. regulation, structuring, coaching, supervision and assistance in business development; And
- e. assistance in obtaining capital loans with bank partners.

The second part
Street Vendor Obligations

Article 10

- (1) PKL is obliged to:
- a. comply with statutory provisions;
 - b. comply with business activity times determined by the Regent;
 - c. maintaining beauty, order, security, cleanliness and environmental health of business premises;
 - d. placing and arranging merchandise and/or services as well as merchandise equipment in an orderly and orderly manner;
 - e. maintain traffic order and public interests;
 - f. hand over the business premises or business location without demanding compensation in any form, if the business location is not occupied for 1 (one) month or at any time the location is required by the local government;
 - g. occupy a place or business location that has been determined by the regional government according to the TDU owned by the street vendor;
 - h. create a business place with a disassembly system or one that is easy to move to a scheduled location;
 - i. dismantle the business premises according to the specified time; And
 - j. provide a place to wash food utensils with running water for food vendors.
- (2) PKLs who violate the provisions as intended in paragraph (1) are subject to administrative sanctions in the form of:
- a. written warning;
 - b. freezing/revoking TDU; and/or
 - c. demolition.
- (3) The administration of administrative sanctions in the form of written warnings as intended in paragraph (2) letter a is carried out by the Service.
- (4) The imposition of administrative sanctions in the form of written warnings as intended in paragraph (2) letter a, consists of:
- a. First Warning Letter, with a period of 7 (seven) calendar day;
 - b. if the first Warning Letter as intended in letter a is not heeded, a second Warning Letter will be given, with a period of 3 (three) calendar days; And

- c. If the second warning letter as intended in letter b is not heeded, a third warning letter will be given, with a period of 1 (one) calendar day.
- (5) The imposition of administrative sanctions in the form of freezing/ revocation of TDU as intended in paragraph (2) letter b is carried out by the Service.
- (6) The imposition of administrative sanctions in the form of demolition as intended in paragraph (2) letter c is carried out by Satpol PP.
- (7) The imposition of administrative sanctions in the form of demolition as referred to in paragraph (2) letter c can be implemented without being preceded by a written warning in the event of being caught red-handed committing a violation of:
 - a. organize and/or carry out all forms gambling;
 - b. store and/or sell alcoholic beverages;
 - c. commit negligence so that the place of activity/business is used to consume alcoholic beverages;
 - d. commit immoral acts and/or activities that leads to immoral acts;
 - e. abandoning and/or leaving empty the location of the business premises without continuous activity for 1 (one) month; and/or
 - f. misused for criminal acts.
- (8) Results of demolition as intended in paragraph (6) falls under the authority of Satpol PP.

CHAPTER IV PROHIBITION

Article 11

(1) Street vendors are prohibited from:

- a. carry out business activities in public spaces that are not designated as PKL locations;
- b. renovate, add and change the functions and facilities in the premises or locations of PKL businesses that have been determined and/or determined by the Regent;
- c. occupying land or location of street vendors for site activities stay;
- d. change location and/or place or transfer TDU PKL without their knowledge and permission of the Regent;
- e. abandon and/or leave the location empty a place of business without continuous activity for 1 (one) month;

- f. replacing business fields that are not in accordance with the TDU;
 - g. carrying out business activities by damaging and/or changing the shape of sidewalks, public facilities and/or surrounding buildings;
 - h. using the road for business premises, except designated for scheduled PKL locations and controlled;
 - i. trade in places where parking is prohibited, temporary stop, or sidewalk for street vendors business activities using vehicles;
 - j. buying and selling or renting out street vendors' business premises to other traders;
 - k. erect permanent or semi-permanent buildings in
location of the street vendor's business premises;
 - l. placing and/or leaving facilities, infrastructure and/or merchandise at the location of the business premises after doing business;
 - m. carrying out business activities selling/slaughtering raw or processed meat originating from non-food animals for consumption purposes;
And
 - n. trade illegal goods.
- (2) PKLs who violate the provisions as intended in paragraph (1) are subject to administrative sanctions in the form of:
- a. written warning;
 - b. freezing/revoking TDU; and/or
 - c. demolition.
- (3) The administration of administrative sanctions in the form of written warnings as intended in paragraph (2) letter a is carried out by the Service.
- (4) The imposition of administrative sanctions in the form of written warnings as intended in paragraph (2) letter a, consists of:
- a. First Warning Letter, with a period of 7 (seven) calendar day;
 - b. if the first Warning Letter as intended in letter a is not heeded, a second Warning Letter will be given, with a period of 3 (three) calendar days;
And
 - c. If the second warning letter as intended in letter b is not heeded, a third warning letter will be given, with a period of 1 (one) calendar day.
- (5) The imposition of administrative sanctions in the form of freezing/ revocation of TDU as intended in paragraph (2) letter b is carried out by the Service.
- (6) The imposition of administrative sanctions in the form of demolition as intended in paragraph (2) letter c is carried out by Satpol PP.

- (7) The imposition of administrative sanctions in the form of demolition as referred to in paragraph (2) letter c can be implemented without being preceded by a written warning in the event of being caught red-handed committing a violation of:
- g. organize and/or carry out all forms gambling;
 - h. store and/or sell alcoholic beverages;
 - i. commit negligence so that the place of activity/business is used to consume alcoholic beverages;
 - j. commit immoral acts and/or activities that leads to immoral acts;
 - k. abandoning and/or leaving empty the location of the business premises without continuous activity for 1 (one) month; and/or
 - l. misused for criminal acts.
- (8) Results of demolition as intended in paragraph (6) falls under the authority of Satpol PP.

CHAPTER V

PROCEDURES FOR EMPOWERING PKL

Part One
General

Article 12

- (1) The Department carries out the empowerment of PKL in the Region.
- (2) Empowerment of PKL as intended in paragraph (1) includes:
- a. funding aspects;
 - b. aspects of facilities and infrastructure;
 - c. business information aspects;
 - d. partnership aspect;
 - e. aspects of business opportunities;
 - f. trade promotion aspects; And
 - g. aspects of institutional support.
- (3) Street vendors can play a role as well as in a way active in empowerment as intended in paragraph (1).

Article 13

- The funding aspect as intended in Article 12 paragraph (2) letter a is carried out by:
- a. expanding funding sources and facilitating street vendors to be able to access banking credit and non-bank financial institutions;
 - b. increasing the number of financing institutions and expanding their networks so that they can be accessed by street vendors;

- c. provide convenience in obtaining funding quickly, accurately, cheaply and without discrimination in services in accordance with the provisions of laws and regulations; And
- d. assist street vendors to obtain financing and other financial services/ products provided by banks and non-bank financial institutions, both using conventional systems and sharia systems with guarantees provided by the Government.

Article 14

Aspects of facilities and infrastructure as referred to in Article 12 paragraph (2) letter b is carried out by:

- a. provide public infrastructure that can encourage and developing the growth of street vendors; And
- b. provide relief on certain infrastructure rates for street vendors.

Article 15

Aspects of business information as intended in Article 12 paragraph (2) letter c is carried out by:

- a. establishing and facilitating the use of data banks and business information networks;
- b. provide and disseminate information regarding markets, sources of financing, commodities, guarantees, design and technology, and quality; And
- c. guarantee transparency and equal access for all street vendors to all business information.

Article 16

Partnership aspect as intended in Article 12 paragraph (2) letter d is carried out by:

- a. realizing partnerships between street vendors;
- b. realizing partnerships between street vendors and the business world other;
- c. encourage relationships
mutually beneficial in the implementation of inter-business transactions
street vendors;
- d. encourage relationships
mutually beneficial in the implementation of business transactions between
street vendors and other business world;
- e. develop cooperation to improve position
bargaining for street vendors;

- f. encourage the formation of a market structure that ensures the growth of healthy business competition and protects consumers; And
- g. prevent market domination and business concentration by certain individuals or groups which is detrimental to street vendors.

Article 17

- (1) Aspects of business opportunities as referred to in Article 12 paragraph (2) letter e is carried out by:
 - a. determine the allocation of business premises which includes providing locations in markets, shop spaces, industrial center locations, people's agricultural locations, people's mining locations, reasonable locations for street vendors, and other locations;
 - b. determine the allocation of business time for street vendors in retail trade subsector; And
 - c. protect certain strategic businesses for street vendors;
- (2) The implementation of the provisions as intended in paragraph (1) is supervised and controlled by the Regent.

Article 18

- (1) The trade promotion aspect as intended in Article 12 paragraph (2) letter f, is carried out by:
 - a. increasing promotion of street vendor products; And
 - b. expanding funding sources for product promotion
- (2) The implementation of the provisions as intended in paragraph (1) is supervised and controlled by the Regent.

Article 19

The institutional support aspect as intended in Article 12 paragraph (2) letter g is aimed at developing and improving the function of incubators, business development service institutions, bank partner financial consultants, and other similar professional institutions as supporting institutions for PKL development.

CHAPTER VII

CLOSING

Article 20

This Regent's Regulation comes into force on the date of promulgation.


