REGENT SUKOHARJO,

Considering: a. that to implement the provisions of Article 26 paragraph (2) Law Number 25 of 2004 concerning the National Development Planning System and Article 264 paragraph (2) of Law Number 23 of 2014 concerning Regional Government as amended several times, most recently by Law Number 6 of 2023 concerning the Determination of Government Regulations in Lieu of Laws. Law Number 2 of 2022 concerning Job Creation becomes law, it is necessary to stipulate a Regent's Regulation concerning the Sukoharjo Regency Regional Government Work Plan for 2024;

To stipulate: REGENT'S REGULATION CONCERNING THE WORK PLAN OF THE SUKOHARJO DISTRICT REGIONAL GOVERNMENT FOR 2024.

PIG

GENERAL REQUIREMENTS

article 1

In this Regent's Regulation what is meant by:

1. The region is Sukoharjo Regency.

2. Regional Government is the Regent as the organizing element of Regional Government which leads the implementation of government affairs which are the authority of the autonomous region.
3. The Regent is the Regent of Sukoharjo.
4. Regional Apparatus is the supporting element of the Regent and the Regional People's Representative Council in the implementation of Government Affairs which fall under the authority of the Region.
5. Regional Government Work Plan, hereinafter abbreviated to RKPD, is a Regional development planning document for a period of 1 (one) budget year.

## CHAPTER II

### RKPD

#### Section 2

The 2024 RKPD is a regional development planning document for the period of 1 (one) fiscal year which begins on January 1, 2024 and ends on December 31, 2024.

#### Article 3

The 2024 RKPD as intended in Article 2 is a guideline in:

- a. preparation of the Income and Expenditure Budget Plan Region for Fiscal Year 2024;
- b. preparation of Annual Regional Work Plans 2024 Budget, and
- c. discussion of General Budget Policy (KUA) and Temporary Budget Priorities and Ceilings (PPAS) with the Regional People's Representative Council.

#### Article 4

The 2024 RKPD as intended in Article 2 is prepared systematically as follows:

- a. Pig : Introduction;
- b. chapter II : General Description of Regional Conditions;
- c. chapter III : Regional Economic and Financial Framework;
- d. Chapter IV : Development Goals and Priorities Area;
- e. Chapter V : Regional Work Plan and Funding;
- f. Chapter VI : Government Administration Performance Area; And
- g. Chapter VII : Closing

Article 5

The RKPD document as intended in Article 2 is listed in the Appendix which is an inseparable part of this Regent's Regulation.

CHAPTER III

CLOSING

Article 6

This Regent's Regulation comes into force on the date of promulgation.

So that everyone is aware, this Regent's Regulation is ordered to be promulgated by placing it in the Regional Gazette of Sukoharjo Regency.
