REGENT OF SUKOHARJO CENTRAL JAVA PROVINCE REGULATION OF THE REGENT OF SUKOHARJO NUMBER 26 OF 2024 ON

THE WORK PLAN OF REGIONAL GOVERNMENT UNITS FOR 2025

BY THE GRACE OF THE ALMIGHTY GOD THE REGENT OF SUKOHARJO,

Considering

- a. that in order to realize good governance practices oriented toward public welfare, a directed and sustainable work plan is necessary as a manifestation of the principles of social justice and balanced development;
- b. that to address the increasingly complex and dynamic needs of society and to ensure equitable distribution of development outcomes across all social strata, a work plan for regional government units is needed, which is responsive to the aspirations and social conditions of the people of Sukoharjo Regency;
- c. that in the context of implementing Law Number 23 of 2014 concerning Regional Government, as amended several times, most recently by Law Number 6 of 2023 on the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 concerning Job Creation into Law, the Regent's Regulation Number 21 of 2024 concerning the Regional Government Work Plan of Sukoharjo Regency for 2025 has been enacted;
- d. that pursuant to the provisions of Article 273 paragraph (4) of Law Number 23 of 2014 concerning Regional Government, as amended several times, most recently by Law Number 6 of 2023 on the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 concerning Job Creation into Law, the Work Plan of Regional Government Units is established by the Regional Head after the Regional Government Work Plan is enacted;
- e. that based on the considerations mentioned in points a, b, c, and d, it is necessary to stipulate a Regent Regulation on the Work Plan of Regional Government Units of Sukoharjo Regency for 2025;

Remembering: 1. Article 18 paragraph (6) of the Constitution of the Republic of Indonesia of 1945;

- 2. Law Number 13 of 1950 concerning the Establishment of Regencies within the Province of Central Java, as amended by Law Number 9 of 1965 concerning the Establishment of Batang Regency by amending Law Number 13 of 1950 on the Establishment of Regencies within the Province of Central Java (State Gazette of 1965 Number 52, Supplement to the State Gazette Number 2757);
- 3. Law Number 23 of 2014 concerning Regional Government (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587), as amended several times, most recently by Law Number 6 of 2023 on the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 concerning Job Creation into Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);

DECIDES:

To Etablish: REGULATION OF THE REGENT CONCERNING THE WORK PLAN OF REGIONAL GOVERNMENT UNITS FOR 2025.

CHAPTER I

GENERAL PROVISIONS

Article 1

In this Regent Regulation, the following terms shall have the meanings assigned below:

- 1. Region refers to Sukoharjo Regency.
- 2. Regional Government refers to the Regent as an element of the administration of regional governance who leads the implementation of governmental affairs that fall under the jurisdiction of the autonomous region.
- 3. Regent refers to the Regent of Sukoharjo.
- 4. Regional Government Unit refers to supporting elements of the Regent and the Regional People's Representative Council in administering governmental affairs that fall under the jurisdiction of the region.
- 5. The Regional Annual Development Plan, hereinafter referred to as the Regional Government Work Plan, abbreviated as RKPD, refers to the regional planning document for a one-year period.
- 6. The Strategic Plan of Regional Government Units, hereinafter referred to as the Strategic Plan of Regional Government Units, refers to the planning document of Regional Government Units for a five-year period.

7. The Work Plan of Regional Government Units, hereinafter referred to as the Work Plan of Regional Government Units, refers to the planning document of Regional Government Units for a one-year period.

Article 2

(1) The Work Plan of Regional Government Units shall be prepared with reference to the Strategic Plan of Regional Government Units and the Regional Government Work Plan. The Work Plan of Regional Government Units as referred to in paragraph (1) shall include programs, activities, locations, and target groups accompanied by performance indicators and funding in accordance with the duties and functions of each Regional Government Unit.

CHAPTER II

SYSTEMATICS AND FUNCTION OF THE WORK PLAN OF REGIONAL GOVERNMENT UNITS

Article 3

The Work Plan of Regional Government Units as referred to in Article 2 shall be prepared with the following systematics:

a. Chapter I : Introduction;

b. Chapter II : Results of the Evaluation of the Work

Plan of Regional Government Units from

the Previous Year;

c. Chapter III : Objectives and Targets of Regional

Government Units;

d. Chapter IV: Work Plan and Funding of Regional

Government Units; and

e. Chapter V: Closing.

Article 4

The Work Plan of Regional Government Units as referred to in Article 2 shall serve as a guideline for Regional Government Units in preparing their work and budget plans.

CHAPTER III

CONTROL AND EVALUATION OF THE WORK PLAN OF REGIONAL GOVERNMENT UNITS

Article 5

- (1) The Head of Regional Government Units shall conduct control and evaluation of the implementation of the Work Plan of Regional Government Units.
- (2) The Head of Regional Government Units shall report the results of the control and evaluation of the Work Plan of Regional Government Units to the Regent through the Head of the Regional Planning, Research, and Innovation Agency.

CHAPTER IV

PREPARING REGIONAL GOVERNMENT UNITS

Article 6

- (1) The Work Plan of Regional Government Units as referred to in Article 2 shall be prepared by the following Regional Government Units:
 - a. Regional Secretariat;
 - b. Secretariat of the Regional People's Representative Council;
 - c. Regional Inspectorate;
 - d. Department of Education and Culture;
 - e. Department of Health;
 - f. Department of Public Works and Spatial Planning;
 - g. Department of Housing and Settlement Areas;
 - h. Civil Service Police Unit;
 - i. Department of Social Affairs;
 - j. Department of Population Control, Family Planning, and Women's Empowerment and Child Protection;
 - k. Department of Food;
 - l. Department of Environmental Affairs;
 - m. Department of Population and Civil Registry;
 - n. Department of Community Empowerment and Villages;
 - o. Department of Transportation;
 - p. Department of Communication and Information Technology;
 - q. Department of Investment and Integrated One-Stop Services;
 - r. Department of Youth, Sports, and Tourism;
 - s. Department of Libraries and Archives;
 - t. Department of Agriculture and Fisheries;
 - u. Department of Cooperatives, Small and Medium Enterprises, and Trade;
 - v. Department of Industry and Workforce;
 - w. Regional Planning, Research, and Innovation Agency;
 - x. Agency for Financial, Revenue, and Asset Management;
 - y. Agency for Personnel and Human Resources Development;
 - z. Regional Disaster Management Agency;
 - aa. Agency for National Unity and Politics;
 - bb. Weru Subdistrict;
 - cc. Bulu Subdistrict;
 - dd. Tawangsari Subdistrict;
 - ee. Sukoharjo Subdistrict;
 - ff. Nguter Subdistrict;
 - gg. Bendosari Subdistrict;
 - hh. Polokarto Subdistrict;
 - ii. Mojolaban Subdistrict;
 - jj. Grogol Subdistrict;
 - kk. Baki Subdistrict;
 - ll. Gatak Subdistrict; and
 - mm. Kartasura Subdistrict.

The Work Plan of Regional Government Units as referred to in paragraph (1) letters a through mm is listed in the Attachment, which is an inseparable part of this Regent Regulation.

CHAPTER V

FINAL PROVISIONS

Article 7

This Regent Regulation shall come into effect on the date of its promulgation.

In order for everyone to be informed, the promulgation of this Regent Regulation is ordered by placing it in the Regional News of Sukoharjo Regency.
