### SUKOHARJO REGENT,

#### Considering

: that in order to implement the provisions of Article 12 of the Sukoharjo Regency Regulation No 1 of 2021 concerning Accountability for the Implementation of Regional Revenue and Expenditure Budgets for Fiscal Year 2020 it is necessary to stipulate a Regent Regulation concerning the Elaboration of Accountability for the Implementation of Regional Revenue and Expenditure Budgets for Fiscal Year 2020;
