SUKOHARJO REGENT

- Weigh : a. that in order to improve discipline, work motivation and the identity and authority of the State Civil Apparatus, guidelines are needed on the official attire of the state civil apparatus within the Sukoharjo Regency Government ;
- b. that for the sake of effectiveness and efficiency in the use of the official attire of the State Civil Apparatus, the Regulation of the Regent of Sukoharjo Number 6 1 of 20 20 concerning the official attire of the State Civil Apparatus in the Sukoharjo Regency Government needs to be amended;
- c. that based on the considerations as referred to in letters a and b, it is necessary to stipulate a Regent Regulation concerning Amendments to Sukoharjo Regent Regulation Number 61 of 2020 concerning State Civil Apparatus Service Clothing within the Sukoharjo Regency Government;

GENERAL REQUIREMENTS

Article I

Article I

The Regulation of the Regent of Sukoharjo Number 61 of 2020 concerning the Attire of the State Civil Apparatus in the Sukoharjo Regency Government (Sukoharjo District Gazette of 2020 Number 61) is amended as follows:

1. The provisions of Article 26 are amended to read as follows:

Article 26

- (1) The use of PDH for the public as referred to in Article 21 letter a is as follows:

Monday : PDH Khaki using Mutz ; \_

Tuesday : PDH Khaki using Mutz ;

Wednesday : PDH white shirt with trousers for men / skirt for women black ; \_

Thursday : PDH batik/weaving/striped with trousers for men / skirts for women black ;

—

Friday : 1st week and 2nd week :

Clothes Sport used at 07.00 WIB until 09.00 WIB continued PDH Batik Sukoharjo Makmur 1 with trousers for men / skirt for women black ( not *jeans* ).

Friday : 3rd week, 4th week and 5th week :

Clothes Sport used at 07.00 WIB until 09.00 WIB continued PDH Batik Sukoharjo Makmur 2 with trousers for men / skirt for women black ( not *jeans* ).

- (2) For ASN who do not use certain official clothes on regional apparatus which are enforced for 6 (six) working days, on Saturday they use batik/weaving/striped PDH.
- (3) The clothes of the Indonesian Civil Servant Corps, are used at every national holiday ceremony, the 17th of every month, Korpri's birthday, meetings and meetings organized by the Indonesian Civil Servant Corps as well as the specified events/activities.
- (4) Scout clothes are used for civil servants other than teachers every 14th and specifically for teacher civil servants every Friday and every 14th .

- (5) PDH batik/weaving/striped is used by civil servants in the local government environment on National Batik Day every October 2nd.
- (6) The Indonesian Teachers Association (PGRI) clothes are worn for teachers on the 25th of every year.
- (7) Special PDH and Beskap Shirt/Kebaya (Praja Kejawen) are used to attend certain events according to the provisions in the invitation.
- (8) The motifs of Batik Sukoharjo Makmur 1 and Batik Sukoharjo Makmur 2 as referred to in paragraph (1) are listed in Appendix I which is an integral part of this Regent Regulation.

2. The provisions of paragraph (3) of Article 27 are amended to read as follows:

#### Article 27

The use of official attire for employees who have certain tasks as referred to in Article 21 letter b are as follows:

#### (3) One-Stop Integrated Service and Investment Service

- a. Monday : Men's PDH long-sleeved shirt , light brown , black tie, dark brown trousers; and  
PDH woman in brown color .
- b. Tuesday : Men's PDH long -sleeved red shirt , black tie black trousers; and  
PDH women in red
- c. Wednesday : Men's PDH green long sleeve shirt , black tie , black trousers; and  
Women wear *blazers* with collars and short-sleeved batik shirts as interiors
- d. Thursday : PDH batik/weaving/striped and/ or regional specialties with black skirts/slacks.
- e. Friday the 1st week, and the 2nd week :  
Clothes Sport used at 07.00 WIB until 09.00 WIB continued PDH Batik Sukoharjo Makmur 1 with trousers for men / skirt for women black ( not jeans).
- f. Friday 3rd week , 4th week and 5th week :  
Clothes Sport used at 07.00 WIB until 09.00 WIB continued PDH Batik Sukoharjo Prosperous 2 with a black skirt /trousers (not jeans).

3. The provisions of paragraph (5) and paragraph (6) of Article 29 are amended, so that they read as follows:

## Article 29

- (1) PDH PPPK is used by Work Units in the Local Government Environment.
- (2) PDH as referred to in paragraph (1), consists of:
  - a. PDH white shirt, black pants/skirt; and
  - b. PDH batik/weaving/striped or traditional clothing.
- (3) PDH white shirt and black pants/skirt as referred to in paragraph (2) letter a is used by the PPPK from Monday to Wednesday.
- (4) PDH batik/weaving/striped as referred to in paragraph (2) letter b is used by Regional Government PPPK on Thursday.
- (5) PDH Batik Sukoharjo Makmur 1 is used by the District Government PPPK on Friday the 1st week, and the 2nd week.
- (6) PDH Batik Sukoharjo Makmur 2 is used by the district government's PPPK on Friday the 3rd week, 4th week and 5th week.
- (7) Provisions regarding the use of PDH batik/weaving/striped for Regional Apparatus on Saturday as referred to in Article 25 paragraph (2) apply mutatis mutandis to the use of PDH for PPPK.

## Article II

This Regent Regulation comes into force on the date of promulgation.

In order for everyone to know, ordering the promulgation of this Regent Regulation by placing it in the Sukoharjo Regency Regional Gazette.
