AMENDMENT TO REGULATION OF THE REGENCY OF SUKOHARJO NUMBER 69
OF 2020 CONCERNING STANDARD UNIT PRICES OF SUKOHARJO DISTRICT
FINANCIAL YEAR 2021

BY THE GRACE OF GOD ALMIGHTY
SUKOHARJO REGENT ,

- Weigh : a. that in order to implement the provisions of Article 51 paragraph (5) of Government Regulation Number 12 of 2019 concerning Regional Financial Management , it is necessary to stipulate the Sukoharjo Regency Unit Price Standards;
- b. that by establishing Minister of Home Affairs Regulation Number 77 Year 20 20 about Technical Guidelines for Regional Financial Management, the Regulation of the Sukoharjo Regent Number 69 of 2020 concerning the Standard Price of the Sukoharjo Regency Unit Price for the 2021 Fiscal Year needs to be amended ;
- c. that based on the considerations as referred to in letters a and b, it is necessary to stipulate a Regent Regulation concerning Amendments to Sukoharjo Regent Regulation Number 69 of 2020 concerning Standard Unit Prices for Sukoharjo Regency Fiscal Year 202 1 ;

DECIDING:

Set : REGULATION OF THE REGENT CONCERNING AMENDMENT TO REGULATION OF THE REGENCY OF SUKOHARJO NUMBER 69 OF 2020 CONCERNING STANDARD UNIT PRICES OF SUKOHARJO REGENCY FOR FINANCIAL YEAR 2021.

Article I

Several provisions in the Regulation of the Regent of Sukoharjo Number 69 of 2020 concerning the Standard Unit Price of the Regency of Sukoharjo for the 2021 Fiscal Year (Sukoharjo Regency Regional Gazette of 2020 Number 69) are amended as follows:

1. The provisions of Article 4 are amended, so that it reads as follows:

Article 4

Honorarium expenditure as referred to in Article 3 letter a, is listed in Appendix I which is an integral part of this Regent's Regulation.

2. Provision Article 5 changed so that it reads as follows:

Article 5

Expenditure as referred to in Article 3 letter b, is listed in Attachment I I which is an integral part of this Regent's Regulation.

3. Provision Article 6 changed so that it reads as follows:

Article 6

expenditures as referred to in Article 3 letter c, are listed in Attachment I II which is an integral part of this Regent's Regulation.

4. Provision Article 7 changed so that it reads as follows:

Article 7

Expenditure as referred to in Article 3 letter d, is listed in Attachment IV which is an integral part of this Regent's Regulation.

5. Provision Article 8 changed so that it reads as follows:

Article 8

Domestic Service Travel Expenditures as referred to in Article 3 letter e, are listed in Appendix V which is an integral part of this Regent's Regulation.

6. Provision Article 9 changed , so that it reads as follows:

Article 9

Expenditure as referred to in Article 3 letter f, is listed in Appendix VI which is an integral part of this Regent's Regulation.

Article II

This Regent Regulation comes into force on the date it is promulgated.
