REGULATION NUMBER 2 OF 2018 CONCERNING SUKOHARJO DISTRICT  
INDUSTRIAL DEVELOPMENT PLAN 2018 - 2038

BY THE GRACE OF GOD ALMIGHTY

SUKOHARJO REGENT,

- Considering:
- a. that in order to increase the prosperity and welfare of the people in Sukoharjo Regency, regional industrial development is needed;
  - b. that in the context of optimizing the regional industrial development as referred to in letter a, cooperation with stakeholders, guidance and supervision is carried out through synchronization of the Regency Industrial Development Plan in accordance with the goals, targets and priorities of industrial development, as well as reporting on the implementation of the Regency Industrial Development Plan;
  - c. that based on the considerations as referred to in letters a and b, it is necessary to stipulate a Regent Regulation concerning Instructions for the Implementation of Sukoharjo Regency Regulation Number 2 of 2018 concerning the 2018-2038 Sukoharjo Regency Industrial Development Plan ;

## DECIDE :

GENERAL REQUIREMENTS

## article 1

In this Regent Regulation, what is meant by:

1. The area is Sukoharjo Regency.
2. Regional Government is the Regent as an element of the Regional Government organizer who leads the implementation of government affairs which are the authority of the autonomous region.
3. The Regent is the Regent of Sukoharjo.
4. Service is Department of Industry and Manpower Sukoharjo Regency.
5. Industry is all forms of economic activity that processes raw materials and/or utilizes industrial resources so as to produce goods that have added value or higher benefits, including industrial services.
6. RPIK , is the Sukoharjo Regency industrial planning and development document for 20 (twenty) years starting from 2018 to 2038.

## Section 2

Regent Regulation is as a guideline for implementing cooperation, coaching, monitoring and reporting on the implementation of the 2018-2038 RPIK .

## Article 3

Regent Regulation is to:

- a. develop the Industry through partnerships ; \_
- b. strengthen the industry ;
- c. improve the quality of human resources in the industrial sector;
- d. improve product quality ;
- e. to know the development of the industry on a regular basis ;  
and

- f. determine policies in the field of Industry .

CHAPTER II  
SCOPE

Article 4

The scope of this Regent Regulation includes:

- a. cooperation;
- b. guidance and supervision; and
- c. p reporting.

CHAPTER III  
COOPERATION

Article 5

- (1) The Regional Government is responsible for the implementation of the cooperation in the Industrial development program in the Region as referred to in Article 4 letter a.
- (2) In carrying out the cooperation with the Industrial development program as referred to in paragraph (1), the Regional Government may cooperate with stakeholders.
- (3) The stakeholders as referred to in paragraph (2) include:
  - a. regional apparatus;
  - b. businessman;
  - c. industrial actors;
  - d. college ;
  - e. banking;
  - f. other districts/cities; and/or
  - g. domestic and foreign institutions.
- (4) The forms of cooperation as referred to in paragraph ( 1 ) include:
  - a. partnership;
  - b. cooperation agreement ;
  - c. comparative study ;
  - d. internship ;
  - e. accompaniment; and/or
  - f. *Memorandum of Understanding* / Memorandum of Understanding.

CHAPTER IV  
GUIDANCE AND SUPERVISION

Article 6

- (1) The Regent conducts guidance and supervision of the implementation of the RPIK.
- (2) Guidance and supervision are carried out in the context of consistent implementation of the RPI K in accordance with the objectives, targets and priorities of regional industrial development while still aligning with the Central Java Province Industrial Development Master Plan and the National Industrial Development Master Plan.
- (3) The purpose of the guidance and supervision as referred to in paragraph (1) is to improve the quality of human resources and the quality of products produced in the Industrial sector .
- (4) The target of guidance and supervision as referred to in paragraph (1) includes small and medium-sized Industries.

#### Article 7

- (1) The Regent in carrying out the guidance and supervision as referred to in Article 6 paragraph (1) delegates to the Head of the Service.
- (2) The Head of the Service in carrying out the guidance and supervision as referred to in paragraph (1) shall form a Team which is determined by the Decree of the Regent.
- (3) The team as referred to in paragraph (2) consists of regional apparatus and/or related agencies as needed.

#### Article 8

- (1) The guidance as referred to in Article 6 paragraph (1) includes:
  - a. human resource improvement;
  - b. increase in capital;
  - c. increased marketing capabilities;
  - d. strengthening of facilities and infrastructure; and
  - e. strengthening cooperation.
- (2) The supervision as referred to in Article 6 paragraph (1) includes:
  - a. industrial licensing ;
  - b. industrial raw materials ;
  - c. industrial standardization ;
  - d. production process;
  - e. production result; and
  - f. reporting on the delivery of industrial information.

#### CHAPTER V REPORTING

#### Article 9

- (1) The Regent prepares and submits a report to the Governor of Central Java 1 (one) time a year on the implementation of the RPIK.

- (2) The report on the implementation of RPI K as referred to in paragraph (1) shall at least contain:
- a. production growth of the processing industry;
  - b. the number of workers in the small, medium and large industrial sector;
  - c. Industrial sector ;
  - d. achievement of the results of the implementation of Industrial development programs; and
  - e. problems and solutions in the industrial sector.

CHAPTER VI  
CLOSING

Article 10

This Regent Regulation comes into force on the date of promulgation.

In order for everyone to know, ordering the promulgation of this Regent Regulation by placing it in the Sukoharjo Regency Regional Gazette.
